RACE 1 : ROSSIGNS & MULTI PRINT / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE - 1100 metres

FORTISSIO (T. Zanker) - a post-race veterinary examination revealed no visible abnormalities.

I'M OUT (A. Doyle) – inclined to lay out under pressure in the straight.

READY AGAIN (D. Caboche) – approaching the 800 metres eased momentarily when tightened between RONDAFERRO, which was inclined to hang out and BIT SPENSIVE.

QUICK BISCUIT (M. Poon) - jumped away awkwardly

RONDAFERRO (L. Stojakovic) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 2 : D & G TYRES / SABOIS 2UP MAIDEN PLATE - 1396 metres

COMMAND THE SUN (B. Griffiths) – inclined to lay in under pressure in the straight.

THE REMOVALIST (D. Tootell) - rider reported, in his opinion, the gelding may of resented racing inside of other runners. A post-race veterinary examination revealed no visible abnormalities.

PIERREMONT MAGIC (A. Doyle) - slow to begin losing several lengths. Trainer advised a warning placed on the mare.

RACE 3: IAN'S CHICKEN HUT BENCHMARK 72 HANDICAP - 1498 metres

DEVON (T. Zanker) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

FRAAR MANDY (L. Stojakovic) – rider reported the mare raced flat in today's event. Trainer advised FRAAR MANDY would now be spelled.

PENNY FOR A POUND (M. Poon) – inclined to hang out under pressure in the straight. In the vicinity of the 150 metres rider accidentally dropped his whip. Rider pleaded guilty to a charge under AR137(a) carelessness in dropping his whip and was fined \$50.

CHAMBRAY (B. Griffiths) – inclined to lay out under pressure in the straight.

RACE 4: FIRST NATIONAL REAL ESTATE BENCHMARK 54 HANDICAP - 1498 metres

KOSMOS TERCEDES (Jemma Frew) - jumped away awkwardly, contacted the side of its barrier stall, knuckled and as a result Jemma Frew became unbalanced for a number of strides.

MR SHOWDOWN (K. Brooks) - slow to begin.

KING'S DELIGHT (B. Griffiths) – shifted out approaching the 1200 metres.

LIMBO QUEEN (D. Tootell) – in the vicinity of the 1200 metres shifted in onto ARWA, which was obliged to be checked. Rider severely reprimanded. A post-race veterinary examination revealed a small superficial wound to the near hind fetlock. First aid administered.

ARWA (L. Stojakovic) - in the vicinity of the 1200 metres was obliged to be checked as LIMBO QUEEN shifted in tightening that mare onto KING'S DELIGHT, which rolled out marginally. Laid in under pressure in the straight.

YOU AND ME (E. Finnegan) - slow to begin.

Following this event Jemma Frew was examined by the First Care Medical Personnel and ruled unfit to fulfil her remaining engagements. Jemma Frew was advised a medical clearance required before riding in trackwork, jump outs, races or trials.

RACE 5: WESTSIDE VEGIE PATCH BENCHMARK 60 HANDICAP - 1867 metres

HEREFORD (J. Toeroek) – rider reprimanded under AR145 for weighing in, in excess of half a kilogram.

BELONG THERESE (B. Griffiths) - a post-race veterinary examination revealed no visible abnormalities.

RACE 6: MOTEL POINSETTIA BENCHMARK 72 HANDICAP - 1100 metres

GEORDIE'S SECOND (D. Caboche) – reared on jumping away. A post-race veterinary examination revealed no visible abnormalities.

KUNGSLEDEN (Z. Spain) – laid out under pressure in the straight.

RACE 7: PORT AUGUSTA REFRIGERATION RATING 0-58 HANDICAP - 1200 metres

COSMIC KHELEYF (J. Toeroek) – lost its position at the start as BELLA TAHLEE shifted out and MAGNUM PE I shifted in. A post-race veterinary examination revealed no visible abnormalities.

ALL IS WELL (A. Doyle) - jumped away awkwardly and shifted out.

BELLA TAHLEE (K. Brooks) – bumped at the start and taken out by ALL IS WELL.

CONTEGO (T. Zanker) – as the start was effected it was determined that the gelding was held by a barrier attendant and was denied a fair start. Acting under AR134A, Stewards declared CONTEGO a non-starter.

SPINNING CROWN (D. Tootell) – inclined to hang out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

MAGNUM PE I (D. Caboche) - jumped away awkwardly and shifted in.

Correct weight for this event was delayed to allow Stewards to view the footage of the start in relation to CONTEGO.
