RACE 1 : SPORTSBET / SABOIS F&M MAIDEN PLATE - 1100 metres

SOU SOUNI PRINCESS (M. Neilson) - a post-race veterinary examination revealed the mare to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

TOUCH (J. Potter) – from in the vicinity of the 400 metres until approaching the 200 metres became held up for clear ground when racing behind ON DUTY and GRAND MARTINI.

GRAND MARTINI (D. Caboche) – inside the 800 metres raced keenly. Became awkwardly placed on the heels of ON DUTY. Shifted out when being restrained onto TRIPLE SPEC.

ON DUTY (D. Tourneur) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

TRIPLE SPEC (S. Cahill) – inside the 800 metres was obliged to be checked and lost its position when awkwardly placed on the heels of WILLANDER MISS as GRAND MARTINI, which was racing keenly.

RACE 2 : EMMETT'S (SA) / MAIDEN PLATE – 1700 metres

BANGARANG (M. Poon) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

SWEET DESIGN (J. Cartwright) – required Farrier attention prior to exiting the mounting yard. Underwent a pre-race veterinary examination and passed fit to race.

AALI MIA (J. Bowditch) - a post-race veterinary examination revealed no visible abnormalities.

LANKAN SUMMER (J. Kah) – bumped at the entrance to the straight.

CASSY'S ACE (J. Potter) – shifted out and bumped LANKAN SUMMER at the entrance to the straight.

OCTOBER DAWN (E. Finnegan) - jumped away awkwardly

RACE 3 : COOPER'S CARLSBERG LIGHT / SABOIS TWO-YEAR-OLD MAIDEN PLATE
– 1100 metres

The start of this event was delayed approximately one minute.

BENFICA SUN (T. Pannell) – in the vicinity of the 200 metres was obliged to be steadied and alter course as **ARROW LANE** shifted out. Raced greenly in the straight. A post-race veterinary examination revealed the gelding to be shin sore in both forelegs. Trainer advised a Veterinary Certificate of Fitness required prior to trial or race.

DASTAAN (J. Toeroek) – rider reported the gelding was inclined to race greenly throughout the event.

FOREIGN FIGHTER (Z. Spain) - rider reported the gelding was inclined to race greenly throughout the event.

GUN GURU (C. Lindop) - a post-race veterinary examination revealed a lower than expected heart rate.

TIME OUT (C. Jones) – raced keenly in the early and middle stages of the event.

TYPHON BREEZE (D. Tourneur) – difficult to load. Trainer advised a warning had been placed on the colt.

WANTED BY ALL (D. Caboche) – rider reported the gelding raced greenly in the straight.

ARROW LANE (J. Bowditch) – was inclined to lay out under pressure in the straight. In the vicinity of the 200 metres shifted out onto **BENFICA SUN**. Rider severely reprimanded.

RACE 4 : ADELAIDE GALVANISING BENCHMARK 56 HANDICAP - 1100 metres

The start of this event was delayed approximately five minutes.

OVERSTREET (E. Finnegan) – slow to begin.

SNAKE FARLEY (A. Doyle) - jumped away awkwardly. Held up for clear running from in the vicinity of the 600 metres until in the vicinity of the 350 metres when racing to the inside of **ACT OF FAITH**.

COMBAT DANCER (D. Caboche) - a post-race veterinary examination revealed atrial fibrillation. Trainer advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

DAMAGE CONTROL (B. Griffiths) – had difficulty obtaining clear ground from rounding the home turn until the finish line.

NICCOROSSA (J. Cartwright) - a post-race veterinary examination revealed no visible abnormalities.

SPALDING COVE (M. Poon) – held up for clear running from the entrance to the straight until approaching the 100 meters when racing behind **HARREBS TIME** and to the inside of **CHANDLERY**.

CHANDLERY (Z. Spain) – lost its off hind plate en route to the barriers. When attempted to be re-shod the gelding became unruly. Acting on veterinary advice and confirmation from the Trainer, **CHANDLERY** was permitted to race without the off hind shoe.

ACT OF FAITH (J. Mamat) – rider reported the mare felt short in its action in front during the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 5 : HOLIATT DAANT / SABOIS FILLIES & MARES BENCHMARK 64 HANDICAP
- 1500 metres

TUNISIA TRAVELLER (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

RACE 6 : SCHWEPPE CLASS ONE HANDICAP - 1200 metres

SACRED MONARCH (J. Frew) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer advised a Veterinary Certificate of Fitness required prior to trial or race.

TASSIE (J. Bowditch) - slow to begin.

VIEWPOINT ESTATE (L. Stojakovic) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

RACE 7 : SAGLE CONSTRUCTIONS / SABOIS PLUS MAIDEN / CLASS ONE PLATE **- 2100 metres**

POWER GLEN (M. Poon) – bumped at the start. Contacted inside the 100 metres by OPTIMIZE. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300.

ALL ROADS (C. Lindop) - raced keenly in the early stages of the event.

DAPPER ROSSA (J. Cartwright) – contacted at the start. Taken out and bumped POWER GLEN.

MIGHTY MAHER (T. Pannell) – from in the vicinity of the 600 metres until the entrance to the straight had difficulty in obtaining clear running. Inside the 100 metres was inclined to lay out under pressure onto OPTIMIZE.

DASHEBO (D. Tourneur) – inclined to lay in under pressure in the straight.

GO CAROL GO (C. Jones) - jumped away awkwardly, shifted out contacting DAPPER ROSSA.

OPTIMIZE (P. Gatt) – dipped in the vicinity of the 1800 metres for no apparent reason. Taken out inside the 100 metres and contacted POWER GLEN.

WICKED PROMES (J. Kah) - underwent a pre-race veterinary examination and passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

RACE 8 : GOLDIN FARMS / SABOIS+ BAROSSA CUP - 2100 metres

GALATIN (Z. Spain) - underwent a pre-race veterinary examination and passed fit to race. Bumped at the start.

HADDA COUPLE (D. Caboche) – inclined to lay out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

STREAMING BY (GB) (P. Gatt) - slow to begin.

SPANISH HALO (NZ) (S. Cahill) – held up for clear running from approaching the 400 metres until the 200 metres when racing behind WICKED TYCOON.

SWEDISH BITTERS (J. Kah) - jumped away awkwardly.

ARTFUL DIVA (D. Tootell) - slow to begin.

CONQUER THE MOMENT (E. Finnegan) - jumped away awkwardly, shifted in and bumped GALLATIN. As a consequence rider became unbalanced for several strides.

KIRCHNER (A. Doyle) – inclined to hang out throughout the event. A post-race veterinary examination revealed a lower than expected heart rate.

RACE 9 : WOLF BLASS PAVILLION BENCHMARK 56 HANDICAP- 1500 metres

LUCKY ON BLACK (M. Neilson) - a post-race veterinary examination revealed no visible abnormalities.

RACE 9 : WOLF BLASS PAVILLION BENCHMARK 56 HANDICAP- 1500 metres (Cont'd)

MAPPINGA PRINCE - a late scratching on veterinary advice at 3.43 pm owing to a laceration to the wither. Trainer advised a Veterinary Certificate of Fitness required prior to trial or race.

THE HARD WAY (D. Tootell) – inclined to hang in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

HEURIGER (Z. Spain) – rider reported the gelding did not feel comfortable in its action throughout the event and for this reason elected not to ride his mount out in his normal manner from in the vicinity of the 600 metres. A post-race veterinary examination revealed the gelding to be lame in both forelegs. Trainer advised a Veterinary Certificate of Fitness required prior to trial or race.

RACE 10 : BAROSSA FUNERALS BENCHMARK 56 HANDICAP - 1700 metres

KING CADEL (J. Mamat) – inclined to lay out under pressure in the straight.

SILVER EAGLE (L. Stojakovic) - Trainer reprimanded under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards. A post-race veterinary examination revealed no visible abnormalities.

POLLYWAGON (E. Finnegan) - a post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer advised a Veterinary Certificate of Fitness required prior to trial or race.

STRYKING GOLD (P. Gatt) - approaching the 300 metres bumped A LOTTA ROSIE. A post-race veterinary examination revealed no visible abnormalities.

A LOTTA ROSIE (D. Tourneur) - slow to begin. Approaching the 300 metres bumped STRYKING GOLD.

FRANK HEAVENS (Jemma Frew) – in the vicinity of the 700 metres rider accidentally dropped her whip. Rider reprimanded under AR137(a) for carelessness in dropping of whip.

BLAKELEY (M. Poon) - a post-race veterinary examination revealed no visible abnormalities. Trainer advised the gelding would now be retired.
