STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Hawker Racecourse
by the Hawker Racing Club on Saturday, 21 May 2016

RACE 1 : HAWKER / SABOIS MAIDEN PLATE - 1100 metres

ZINETTA (J. Mamat) – rider reported his mount was inclined to hang out rounding the home turn.

RACE 2 : K S RASHEED MEMORIAL BENCHMARK 60 HANDICAP - 1100 metres

SCENIC MINT (T. Zanker) – inclined to lay in near the 200 metres and had to be steadied.

TILLY GIRL (K. Brooks) - a post-race veterinary examination revealed the mare to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

MAGNUM PE I (D. Tootell) – reluctant to race in the early stages. A post-race veterinary examination revealed no visible abnormalities.

RACE 3 : HAWKER BENCHMARK 60 HANDICAP – 1100 metres

The start of this event was delayed approximately fifteen minutes owing to a patron requiring attention from the First Care Medical Personnel.

EXTREME SHOT (B. Griffiths) – struck the running rail in the vicinity of the 600 metres.

RACE 4 : ARKABA / SABOIS TWO-YEARS-OLD & OVER MAIDEN PLATE – 1400 metres

JUST RESTING (A. Doyle) – inclined to lay out in the vicinity of the 400 metres.

THE ENGINEER (B. Griffiths) – lost contact with the field in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities. Warning issued.

GRAND MARTINI (J. Mamat) – rider pleaded guilty to a charge under AR137A(5)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

RACE 5 : NORTHPOINT TOYOTA HAWKER CUP – 1750 metres

LITTLE AUDREY (K. Brooks) - a post-race veterinary examination revealed no visible abnormalities.

BELONG THERESE (T. O'Donnell) – was obliged to be steadied when leaving the straight on the first occasion and got in, away from another runner and struck the running rail. In the vicinity of the 600 metres struck the running rail. A post-race veterinary examination revealed the mare to have abrasions to its bumpers with no other visible abnormalities. Trainer, Ms S. Stott advised the mare would now be retired none the less was advised if BELONG THERESE returned to racing it would be required to prove competitive in an Official Barrier Trial prior to accepting for a future race.

RACE 6 : XXXX GOLD WONOKA BENCHMARK 60 HANDICAP – 1400 metres

SCHOONER WON (A. Doyle) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

COMMAND THE SUN (B. Griffiths) - inclined to lay in under pressure in the straight.

BENJIDDAH (Jemma Frew) – raced keenly in the early stages of the event.

THE HARD WAY (D. Tootell) – began awkwardly.

VIEWPOINT ESTATE (L. Stojakovic) – inconvenienced shortly after the start and obliged to be steadied.
