STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Gawler Racecourse
by the Gawler & Barossa Jockey Club on Wednesday, 25 May 2016

TRACK: Soft 5 (Downgraded to Soft 7 @ 11.40 am)
(Downgraded to a Heavy 8 @ 2.45 pm retrospective to Race 4)
(Downgraded to a Heavy 9 @ 3.19 pm retrospective to Race 5)
(Downgraded to a Heavy 10 @ 4.16 pm retrospective to Race 7)

WEATHER: Showery

RAIL: Out 4 metres Entire Sectional 605 metres.

RACE 1 : KINGSFORD HOTEL / SABOIS DISTANCE MAIDEN PLATE - 2122 metres

CASSY'S ACE (J. Potter) – raced keenly in the early stages of the event. A post-race veterinary examination revealed a strained injury to the near fore flexor tendon. First aid administered.

LANKAN SUMMER (J. Kah) – a post-race veterinary examination revealed the filly suffered a bi-lateral bleeding attack in both nostrils. Trainer advised LANKAN SUMMER was suspended from racing for a period of 3 months in accordance with AR53A.

LIGHTSCAPADE (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

RACE 2 : SCHWEPPE MIXERS / SABOIS FILLIES & MARES MAIDEN PLATE – 1111 metres

BITTER TWIST (J. Kah) – contacted a perimeter fence on a number of occasions prior to exiting the mounting yard. Underwent a pre-race veterinary examination on arrival at the barriers and passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

THE CASTLE KAT (R. Hurdle) – inclined to lay out under pressure in the straight.

TOUCH (J. Potter) – lost its position at the start as OCTOBER DAWN jumped away awkwardly and shifted out.

GASOLINE ALLEY (NZ) (D. Tourneur) – a post-race veterinary examination revealed no visible abnormalities.

OCTOBER DAWN (D. Tootell) - jumped away awkwardly and shifted out onto TOUCH.

REYIA (A. Doyle) - jumped away awkwardly and shifted in onto BITTER TWIST.

RACE 3 : WOLF BLASS PAVILION OPENING 8 JUNE / SABOIS TWO-YEAR-OLD MAIDEN PLATE
– 1111 metres

EXALTED TRAVELLER (J. Cartwright) - jumped away awkwardly, shifted in and bumped WAGING WAR.

SWIPE ME RIGHT (D. Caboche) – raced keenly in the early and middle stages of the event. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

WAGING WAR (T. Pannell) - jumped away awkwardly, shifted out and bumped EXALTED TRAVELLER. Difficulty in obtaining clear ground from the entrance to the straight until approaching the 100 metres.

RACE 3 : WOLF BLASS PAVILION OPENING 8 JUNE / SABOIS TWO-YEAR-OLD MAIDEN PLATE
- 1111 metres (Cont'd)

WASABI BOB (C. Lindop) – inside the 100 metres steadied momentarily as ZALMONA rolled in.

ZALMONA (D. Tourneur) – raced keenly in the early and middle stages of the event. Inside the 100 metres rolled in onto WASABI BOB.

TAHNEE TIARA (M. Neilson) - a post-race veterinary examination revealed no visible abnormalities.

RACE 4 : SPORTSBET CASH CARD MAIDEN PLATE - 1211 metres

BOLD ZAC (J. Toeroek) – raced in restricted room for a number of strides shortly after the start between SASUN, which shifted out and DOUBLE BE.

CLEVER TOMMY (S. Cahill) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300.

LUCKY DE LAGO (J. Frew) - slow to begin.

SASUN (D. Tourneur) - jumped away awkwardly and shifted out.

BE DARING (J. Cartwright) – raced keenly in the early and middle stages of the event. Inclined to hang out rounding the home turn.

Following the running of this race the track was downgraded to a Heavy 8 at 2.45 pm retrospective to Race 4.

RACE 5 : WOLF BLASS GOLD CLASS TWO HANDICAP - 1111 metres

PENDLEBURY (J. Holder) – marginally slow to begin.

SNIPETRON (P. Gatt) – in the vicinity of the 800 metres shifted in when insufficiently clear of HOT GOSSIP, which clipped the heels of SNIPETRON. Rider pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 1 June and to conclude at midnight on Saturday, 11 June 2016: a period of four (4) meetings. A post-race veterinary examination revealed no visible abnormalities.

SOCIAL LANE – a late scratching at 1.45 pm due to the track downgrade.

HARREBS TIME (R. Hurdle) – jumped away awkwardly and shifted out. In the vicinity of the 800 metres rolled in onto CHANDLERY. Rider reminded of his obligations when shifting ground in future.

FLYIN' FOR ME (D. Tourneur) - underwent a pre-race veterinary examination after becoming fractious in its barrier stall after being loaded and passed fit to race.

CHANDLERY (Z. Spain) – inconvenienced at the start as HARREBS TIME jumped away awkwardly and shifted out. In the vicinity of the 800 metres became awkwardly placed on the heels of HARREBS TIME, which rolled in.

HOT GOSSIP (J. Bowditch) - in the vicinity of the 800 metres clipped the heels of SNIPETRON when tightened onto CHANDLERY as SNIPETRON shifted in when insufficiently clear. A post-race veterinary examination revealed a minor laceration to bulb of heel on the off fore hoof.

Following the running of this race the track was downgraded to a Heavy 9 at 3.19 pm retrospective to Race 5.

RACE 6 : GOLDIN FARMS BENCHMARK 64 HANDICAP - 2122 metres

MR LAMBORGHINI (A. Doyle) - underwent a pre-race veterinary examination and passed fit to race. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

MIGHTY MAHER (T. Pannell) - jumped away awkwardly and was slow to begin.

NISHIAZABU (Jemma Frew) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was suspended from riding in races for a period to commence at midnight on Saturday, 28 May and to conclude at midnight on Saturday, 4 June 2016: a period of three (3) meetings.

MAN SHE'S FAST (J. Kah) – lost it off hind plate during the event. Trainer advised the filly would now be spelled.

RACE 7 : COOPERS CLEAR BENCHMARK 60 HANDICAP - 1511 metres

ALLEZ TARA (J. Mamat) – jumped away awkwardly. Inclined to lay out under pressure in the straight. In the vicinity of the 100 metres contacted DANOULI.

KARADOC KID – a late scratching at 3.20 pm due to the track downgrade.

PERPETUAL BLISS - a late scratching at 1.55 pm due to the track downgrade.

DANOULI (J. Holder) – in the vicinity of the 100 metres contacted ALLEZ TARA.

KIPROTICH (T. O'Donnell) - slow to begin.

Correct weight for this event was delayed to allow J. Holder (DANOULI) placed second and Mr J. Hickmott, the Trainer to view the vision in the straight. After doing so J. Holder lodged an objection against J. Mamat (ALLEZ TARA) being declared the winner, alleging interference from in the vicinity of the 200 metres. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* the objection.

Following the running of this race the track was downgraded to a Heavy 10 at 4.16 pm retrospective to Race 7.

RACE 8 : SANDERS FODDER BENCHMARK 60 HANDICAP - 1211 metres

The start of this event was delayed approximately two minutes.

JUST RANGER (A. Doyle) - a post-race veterinary examination revealed cardiac arrhythmia. Trainer advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

CESTOS (S. Cahill) - Trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards. A post-race veterinary examination revealed no visible abnormalities.

RED DAZZLE (P. Gatt) – inside the 600 metres shifted in and away from YODINI and bumped SCARLET LETTER.

BYTHESTARS (R. Hurdle) – lost its off hind plate in the mounting yard. Presented at the barrier to be reshod and became unruly. Acting on veterinary advice and confirmation from the Trainer, Stewards permitted BYTHESTARS to race without the off hind plate.

SCARLET LETTER (D. Caboche) – inside the 600 metres became awkward for a number of strides when RED DAZZLE shifted in and bumped the mare, thereafter weakened from the event. Rider reported the mare did not feel comfortable in its action when placed under pressure. A post-race veterinary examination revealed no visible abnormalities. Trainer advised a warning had been placed on SCARLET LETTER in relation to it being uncompetitive.
