# RACE 1: MERCEDES-BENZ ADELAIDE HANDICAP - 1000 metres

ARTFUL JACK (R. Hurdle) - slow to begin.

EVERASREADY (Z. Spain) - a post-race veterinary examination revealed no visible abnormalities.

**JET EXPRESS** (T. Pannell) - slow to begin. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**JUST A BIGGER DASH** (S. Cahill) - improved onto the heels of RAZOR BURN in the vicinity of the 50 metres and had to alter course.

SHOWPERO (J. Holder) - jumped away awkwardly.

#### RACE 2: AUSTRALIAN MADE HANDICAP - 1300 metres

**ABU DHABI** (J. Bowditch) – raced keenly in the early and middle stages of the event.

**BEAU RIVAGE** (J. Toeroek) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

**SCHISM** (T. Pannell) – rolled in slightly inside the 200 metres and had to be steadied off the heels of ALBERDINI, which rolled out slightly.

**ALBERDINI** (C. Lindop) – lost its near hind plate during the event.

**MAGNUS KNIGHT** (W. Kerford) – raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**ROYAL GUARD** (D. Tourneur) – held up from the vicinity of the 600 metres until near the 300 metres.

**DAREBEN HALARO** (R. Hurdle) – was a late scratching at 9.22 am on Veterinary advice due to swelling on the near fore fetlock.

#### RACE 3: L'OFFICIEL AUSTRALIA BENCHMARK 82 HANDICAP - 1950 metres

**TAP THAT (JPN)** (M. Neilson) – lost its off hind plate during the event.

#### RACE 3: L'OFFICIEL AUSTRALIA BENCHMARK 82 HANDICAP - 1950 metres (cont'd)

**MISS WYNETTE** (A. Doyle) – raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

SPANISH HALO (NZ) (J. Holder) - slow to begin.

**YOUL DASH FOR CASH** (A. Darmanin) - held up from the vicinity of the 500 metres until near the 200 metres. A post-race veterinary examination revealed a lower than expected heart rate.

**BURNRO** (D. Tourneur) – became awkward on the heels of MISS WYNETTE in the vicinity of the 500 metres and was obliged to alter course to that mare's outside to obtain clear ground.

**ROOBOY** (Z. Spain) - a post-race veterinary examination revealed no visible abnormalities.

**KING CADEL** (J. Toeroek) – held up from the vicinity of the 500 metres until inside the 400 metres.

#### RACE 4: THOMAS FARMS KITCHEN HANDICAP - 1000 metres

**THE BRONX** (Z. Spain) – shifted out on jumping away. A post-race veterinary examination revealed no visible abnormalities.

**MONTRE** (D. Tourneur) – rider reported was inclined to lay out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**SILENT SNIPER** (J. Kah) – rider reported the filly was inclined to shift about throughout the event and did not feel comfortable in its action. A post-race veterinary examination revealed no visible abnormalities.

**SPARTAN WARRIOR** (C. Lindop) - jumped away awkwardly and shortly after was inconvenienced by THE BRONX, which shifted out. Raced keenly in the early and middle stages of the event.

# RACE 5: RESOURCECO HANDICAP - 1550 metres

**JUSTA HINT** (J. Cartwright) – inclined to lay in under pressure in the straight.

**COMPLETE CLASS** (C. Lindop) – raced keenly in the early and middle stages of the event. Became held up in the vicinity of the 500 metres until approaching the 300 metres when it was obliged to alter course to the inside of OPTIMIZE to obtain clear ground. A post-race veterinary examination revealed minor lacerations to the near fore pastern.

**DAY OF REST** (M. Neilson) - wide without cover throughout the event.

**JUST LIVE ON** (J. Kah) – rider reported she had become concerned with the gelding's action in the straight. A post-race veterinary examination revealed no visible abnormalities.

**JEST FOR THE ROAD** (J. Bowditch) – raced keenly in the early stages whilst being restrained. A post-race veterinary examination revealed no visible abnormalities.

**ENCHANTING BEAUTY** (J. Holder) - jumped away awkwardly and was slow into stride.

# RACE 6: MCMAHON SERVICES HANDICAP - 1400 metres

**SPIRITOF ENDEAVOUR (USA)** (D. Caboche) – inconvenienced on jumping away when contacted by FLASK.

**COUNTER SPIN** (C. Lindop) – raced keenly in the early and middle stages of the event and raced wide without cover throughout.

**WELCOME NED** (A. Doye) - jumped away awkwardly and shifted out contacting AMPLE ON OFFA. Rider reported the gelding had not travelled at any stage during the event and performed below his expectations. A post-race veterinary examination revealed no visible abnormalities.

#### RACE 6: MCMAHON SERVICES HANDICAP - 1400 metres (Cont'd)

**BRADMAN** (M. Neilson) – tightened onto FLASK on jumping away. Had difficulty in obtaining clear ground at the entrance to the straight, shifted in and then raced in restricted room until the vicinity of the 100 metres between the heels of MULLINGER LANE and AMPLE ON OFFA. Inside the 200 metres brushed with AMPLE ON OFFA for a short distance.

**MULLINGER LANE** (Z. Spain) – shifted out on jumping away onto BRADMAN.

**AMPLE ON OFFA** (P. Gatt) – contacted on jumping away. A post-race veterinary examination revealed no visible abnormalities.

FLASK (J. holder) – taken out on jumping away onto SPIRITOF ENDEAVOUR.

#### RACE 7: ALAN SHEPPARD CONSTRUCTIONS HANDICAP - 1250 metres

**DYLANSON** (J. Cartwright) – shifted in and brushed the running rail near the 1000 metres. A post-race veterinary examination revealed no visible abnormalities.

**DAYTONA GREY** (R. Hurdle) – hampered on jumping away when tightened between LITTLE AKIE and BALIGARI.

**ROYAL ISLAND** (A. Darmanin) - a post-race veterinary examination revealed no visible abnormalities.

**BALIGARI** (J. Bowditch) – shifted in on jumping away. A post-race veterinary examination revealed no visible abnormalities.

**LITTLE AKIE** (Z. Spain) – shifted out on jumping away. Inside the 800 metres raced in restricted room and had to be steadied when tightened onto JUSTIFY THAT by BALIGARI, which rolled in.

CASINO WIZARD (D. Tourneur) - jumped away awkwardly.

SHAF (M. Neilson) - slow to begin.

**VOODOO LAD** (J. Holder) – raced keenly in the early and middle stages of the event. Shifted out abruptly away from the running rail near the 1000 metres for no apparent reason.

# RACE 8: SEPPELTSFIELD ESTATE HANDICAP - 1250 metres

**BIG BOY BLEV** (J. Toeroek) – inconvenienced on jumping away.

SPINNING DIAMOND (S. Cahill) - jumped away awkwardly and shifted out onto BIG BOY BLEV.

MISTER ROCKSTAR (D. Tourneur) - shifted in, in the vicinity of the 900 metres when insufficiently clear of TAPESTRY VISION, which was forced to steady and alter course to avoid the heels of MISTER ROCKSTAR. D. Tourneur found guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on 4 June, and to conclude at midnight on 11 June 2016: a period of three (3) meetings. Stewards questioned D. Tourneur into the instructions provided by Trainer Mr D. Jolly for this event. D. Tourneur explained that he had been advised that it was likely he would take up a position in the first third and if possible to attempt to obtain cover. He added jumping away well he was of the opinion that he would be caught four to five wide and for this reason had elected to allow his mount to stride forward and take up a position in the lead. Mr D. Jolly confirmed the instructions provided were that he expected the gelding to settle in the first third owing to the fact that MISTER ROCKSTAR was fresh, the addition of blinkers for today's start and the step up in distance. He stated that he was surprised the gelding had led. He added that in his opinion he had not changed the tactics but rather had expected the horse to race that way due to the reasons he provided. Stewards noted the explanation and advised Mr Jolly that he should be mindful of AR135A which related to horses being ridden in a different manner from how they were ridden at their most recent start. A postrace veterinary examination revealed the gelding to be lame in both hind legs. First aid administered. Veterinary Certificate of Fitness required prior to trial or race.

#### RACE 8: SEPPELTSFIELD ESTATE HANDICAP - 1250 metres (Cont'd)

**INFINITY QUEEN** (T. Pannell) - jumped away awkwardly. Became awkward on the heels of SNAKE FARLEY for a number of strides at the entrance to the straight and was obliged to alter course.

**TAPESTRY VISION** (J. Cartwright) – had to be steadied and alter course in the vicinity of the 900 metres when MISTER ROCKSTAR shifted in. A post-race veterinary examination revealed no visible abnormalities.

# RACE 5: RESOURCECO HANDICAP - 1550 metres

Stewards questioned Mr T. Jefferies, representing Trainer Mr D. Weir, in relation to him presenting VOODOO LAD into the parade ring for this race when JUSTA HINT had accepted for the event. After considering his explanation, he pleaded guilty to a charge under AR175(k) in that his negligence may have led to a breach of the rules and was fined \$500. In arriving at this penalty Stewards took into account that there was no intent on the part of Mr Jefferies and that he had been involved in the racing industry for approximately 40 years and had not committed an offence of this nature previously.

#### STRATHALBYN - SUNDAY, 22 MAY 2016

#### RACE 1: PHILMAC / SABOIS MAIDEN PLATE - 1605 metres

KING OF SIAM (NZ) (J. Frew) – Jemma Frew pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was suspended from riding in races for a period to commence at midnight on Saturday, 28 May, and to conclude at midnight on Saturday, 4 June: a period of three (3) meetings. Stewards acting under AR196(3) ordered that this penalty be served concurrently with the penalty imposed at Gawler on Wednesday, 25 May 2016.
