Report on Race Meeting held at the Port Augusta Racecourse

RACE 1 : TED OXLADE MEMORAIL / SABOIS MAIDEN PLATE - 1100 metres

WHITE JADE (M. Poon) - jumped away awkwardly. Rider reported inclined to lay in under pressure in the straight.

JESSIE'S OWN (A. Doyle) – on jumping away lost its position when taken out by AMERITAR and tightened onto OWL ON THE PROWL. A post-race veterinary examination revealed no visible abnormalities.

AMERITAR (Z. Spain) – jumped away awkwardly, shifted out and bumped JESSIE'S OWN. Rider reported was inclined to hang out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 2 : TERRY GARDINER'S MEATS & SALTBUSH LIVESTOCK / SABOIS MAIDEN PLATE - 1396 metres

BUTTERBEER – a late scratching at 11.35 am as it was unable to be loaded onto the float.

KING OF SIAM (NZ) (J. Frew) - a post-race veterinary examination revealed no visible abnormalities.

MAPPINGA MELODY (D. Caboche) - rider explained the filly travelled well in the early and middle stages of the event, however, when placed under pressure from in the vicinity of the 600 metres failed to respond to his riding and did not feel comfortable in its action and for this reason elected not to ride the filly out in his normal manner. A post-race veterinary examination revealed no visible abnormalities.

RACE 3 : BRYAN (POPEYE) HARBRIDGE MEMORIAL BENCHMARK 54 HANDICAP - 1600 metres

BENJIDDAH (Jemma Frew) - a post-race veterinary examination revealed no visible abnormalities.

PRIDE OF AMERICA (Z. Spain) - a post-race veterinary examination revealed the mare to be lame in the off foreleg. Trainer advised a Veterinary Certificate of Fitness required prior to trial or race.

KOOMA BLAZE (T. Pannell) – rolled out in the vicinity of the 1200 metres onto VIEWPOINT ESTATE. Held up for clear running from in the vicinity of the 600 metres until in the vicinity of the 400 metres when racing between PRIDE OF AMERICA and MAPPINGA PRINCE.

PILOT'S LANE (J. Potter) – marginally slow to begin.

RACE 3 : BRYAN (POPEYE) HARBRIDGE MEMORIAL BENCHMARK 54 HANDICAP
- 1600 metres (Cont'd)

VIEWPOINT ESTATE (L. Crow) – in the vicinity of the 1200 metres was obliged to be steadied as FACE LEICA STAR shifted in and KOOMA BLAZE rolled out.

FACE LEICA STAR (M. Poon) – in the vicinity of the 1200 metres shifted in onto VIEWPOINT ESTATE, which was obliged to be steadied as KOOMA BLAZE rolled out. Rider severely reprimanded.

RACE 4 : HOLCIM (AUSTRALIA) BENCHMARK 60 HANDICAP - 1867 metres

TIGER JET (T. O'Donnell) - raced keenly in the early and middle stages of the event.

SILENT SINNER (D. Tootell) - a post-race veterinary examination revealed no visible abnormalities.

RACE 5 : SUNDOWNER HOTEL MOTEL BENCHMARK 64 HANDICAP – 1396 metres

IRISH MAMBO (A. Doyle) – rider accidentally dropped his whip in the vicinity of the 250 metres. Rider pleaded guilty to a charge under AR137(a) carelessness in dropping his whip and was fined \$50.

RACE 6 : DARRYL FULLERTON MEMORAIL BENCHMARK 72 HANDICAP - 1100 metres

GENTLE MELODY (A. Doyle) - slow to begin.

SNIP OF MAGIC (T. O'Donnell) – reared on jumping away. Approaching the finish inclined to shy at the winning post. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$250.

GOOSE GREEN (M. Poon) - a post-race veterinary examination revealed no visible abnormalities.

RACE 7 : MCDONALDS WHYALLA CUP - 1600 metres

BELGIETTO (D. Caboche) - jumped away awkwardly, shifted in contacted DEVON. Shortly thereafter clipped the heels of DEVON losing several lengths.

DEVON (J. Potter) – contacted at the start by BELGIETTO. Raced keenly in the early and middle stages of the event.

SAVANERO (NZ) (A. Doyle) - a post-race veterinary examination revealed no visible abnormalities.

SHOGUN'S REIGN (L. Crow) - a post-race veterinary examination revealed no visible abnormalities.

SOUTHERN SEA (M. Poon) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8 : SPOT ON FISHING BENCHMARK 56 HANDICAP - 1200 metres

The start of this event was delayed approximately two minutes.

DELANANN (T. Pannell) - jumped away awkwardly, shifted out and bumped BELLA TAHLEE.

FINNISS MOMENT (Jemma Frew) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

BELLA TAHLEE (A. Doyle) – bumped at the start by DELANANN.

TALE BLAZER (L. Crow) - in the vicinity of the 200 metres was held up for a short distance when attempting a tight run between MAPPINGA QUEEN, which rolled out and DELANANN.

RACE 8 : SPOT ON FISHING BENCHMARK 56 HANDICAP - 1200 metres (Cont'd)

TILLY GIRL (K. Brooks) – underwent a pre-race veterinary examination on arrival at the barriers and ruled unfit to race. Acting on this advice Stewards withdrew the mare at 4.29 pm. Trainer advised the mare's feet require Farrier attention. Trainer advised a Veterinary Certificate of Fitness required prior to accepting for a future trial.

SPINNING CROWN (D. Tootell) – marginally slow to begin.
