**RACE 1 : B & L COX ELECTRICAL / SABOIS DISTANCE MAIDEN PLATE - 2200 metres**

**ASELLUS** (C. Lindop) – over-raced in the early stages of the event.

**RECHARGING TO WIN** (R. Hurdle) – in the vicinity of the 400 metres had to ease to avoid the heels of the weakening **LIGHTSCAPE**.

**ANOTHER ENEMY** (T. Zanker) – passing the finish post on the first occasions had to be restrained to avoid the heels of **DAPPER ROSSA**, which was carried in by **LEMON ZEST**.

**CLOCKIMUS PRIME** (J. Potter) – over-raced in the early stages of the event.

**LEMON ZEST** (D. Caboche) – shifted in passing the winning post on the first occasion when insufficiently clear of **DAPPER ROSSA**, which was carried in onto **ANOTEHR ENEMY**. Rider reminded of his obligations to be clear when shifting ground in future. A post-race veterinary examination revealed no visible abnormalities.

**LIGHTSCAPE** (J. Holder) – rider reported his mount began to weaken passing the 600 metres and in his opinion the filly failed to handle the 2200 metres distance. A post-race veterinary examination revealed no visible abnormalities.

**RACE 2 : CARLTON DRAUGHT / SABOIS THREE-YEARS-OLD & OVER MAIDEN PLATE**  
**- 900 metres**

**SUPER RULES** (E. Finnegan) – hung in when placed under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**BIG ROMANCE** (J. Cartwright) – knuckled on jumping away. Lost its near side front plate.

**AN APPLE A DAY** (T. Zanker) - began awkwardly.

**RACE 3 : REQUEST RECRUITMENT / SABOIS FILLES & MARES MAIDEN PLATE**  
**- 1400 metres**

**MINITINI** (T. Pannell) - in the vicinity of the 1000 metres had to be restrained to avoid the heels of **KEMERI**.

**EXALTED SISTER** (E. Finnegan) – a post-race veterinary examination revealed no visible abnormalities.

**RACE 3 : REQUEST RECRUITMENT / SABOIS FILLES & MARES MAIDEN PLATE**  
**- 1400 metres (Cont'd)**

**KEMERI** (C. Lindop) – in the vicinity of the 1000 metres shifted in when insufficiently clear of MINITINI. Rider reminded of her obligations to be clear when shifting ground in future.

**RACE 4 : SAMBEC SHEDS / SABOIS COLTS, GELDINGS & ENTIRES MAIDEN PLATE**  
**- 1400 metres**

The start of this event was delayed approximately five minutes.

**BOLD ZAC** (E. Finnegan) – a late scratching at 1.54 pm on veterinary advice after being fractious in the barriers. Trainer advised the gelding would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race. E. Finnegan was examined by the First Care Medical Personnel and was ruled unfit to fulfill her remaining engagements.

**TIME TO ORDER** (J. Cartwright) – blundered in the vicinity of the 1000 metres.

**RACE 5 : ACKMAC IRRIGATION & TRENCHING BENCHMARK 56 HANDICAP - 1600 metres**

The start of this event was delayed approximately two minutes.

**SILENT MAN** (D. Tourneur) – held up for clear running in the vicinity of the 400 metres until inside the 200 metres.

**DANOULI** (J. Holder) – over-raced in the early and middle stages of the event.

**LYDIARD** (R. Hurdle) – held up for clear running in the vicinity of the 200 metres.

**ONE PERCENTA** (J. Potter) – slow into stride.

**ZOE'S GIFT** (J. Cartwright) – in the vicinity of the 1200 metres had to be restrained to avoid the heels of DANOULI, which shifted out when over-racing.

**PITCH DARK** – a late scratching at 2.09 pm by order of Stewards as there was no available rider.

**LOUVRE LADY** (J. Maund) - a post-race veterinary examination revealed no visible abnormalities.

**COUGH AND SPLUTTER** (M. Poon) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 6 : LONG'S SAND 7 METAL BENCHMARK 60 HANDICAP - 900 metres**

**OGUNDE** (M. Poon) – began awkwardly shifted in carrying LEAHONE onto OAMARU OWL.

**OAMARU OWL** (J. Potter) – was severely hampered on jumping away when tightened for room between LEAHONE and GALRIGUEZ. Hung out when placed under pressure over the concluding stages.

**OUTSIDE** (K. Brooks) – began awkwardly shifted in carrying GALRIGUES in onto OAMARU OWL.

**GALRIGUEZ** (J. Holder) - a post-race veterinary examination revealed a mildly elevated heart rate.

**RACE 7 : MCALISTER PAINTERS BENCHMARK 80 HANDICAP - 1400 metres**

**EDGEWOOD** (J. Holder) – change of tactics to be ridden more positive.

**TIPPERARY LIL** (S. Cahill) – in the vicinity of the 300 metres was disappointed for a narrow run between KILL BILL and EIGELSTEIN, which laid out. A post-race veterinary examination revealed no visible abnormalities.

**RACE 7 : MCALISTER PAINTERS BENCHMARK 80 HANDICAP - 1400 metres (Cont'd)**

**AUTUMN SUNSET** (J. Cartwright) – raced wide without cover throughout the event.

**WISE JOURNEY** (Z. Spain) – held up for clear running in the vicinity of the 300 metres until inside the 200 metres.

**EIGELSTEIN (GB)** (C. Lindop) – over-raced in the early stages of the event. Laid out when placed under pressure in the straight.

**RACE 8 : CUTTING EDGE ENGINEERING BENCHMARK 64 HANDICAP - 1200 metres**

**DAUNTING DANCER** (Z. Spain) – began awkwardly, shifted in and contacted LADY HEDERAJ. Laid in under pressure over the concluding stages. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

**BAITON** (K. Brooks) – in the vicinity of the 1200 metres shifted in and tightened the room of MURTI, which had to be steadied. Rider reprimanded. Inconvenienced in the vicinity of the 50 metres.

**MURTI** (J. Cartwright) – had to be steadied when crowded for room in the vicinity of the 1200 metres. Over-raced in the middle stages of the event. Raced in restricted room from the 300 metres to inside the 100 metres. Inconvenienced in the vicinity of the 50 metres.

**LADY HEDERAJ** (C. Lindop) – contacted on jumping away and carried in onto DADDY'S LITTLELADY.

**JUST A DREAM** (M. Poon) – began awkwardly, shifted out and contacted RIGHT HERE.

**RIGHT HERE** (J. Holder) – contacted on jumping away and carried out onto DADDY'S LITTLE LADY.

**ZUCCHERINA** – a late scratching at 2.52 pm as there was no available rider.

**DADDY'S LITTLE LADY** (J. Maund) – hampered on jumping away.

**TRAFALGAR BELLE** (A. Doyle) - slow to begin.
