RACE 1 : NRC COMMITTEE / SABOIS MAIDEN PLATE - 1000 metres

The start of this event was delayed approximately two minutes.

TOW RAGE (NZ) (Z. Spain) - in the vicinity of the 200 metres was hampered.

RINEHART (D. Tourneur) – began awkwardly, shifted in and bumped PASS THE GLASS. In the vicinity of the 250 metres was momentarily tightened for running.

O'LONHROAD (Jemma Frew) – over-raced in the early and middle stages of the event. Laid in when placed under pressure in the straight. In the vicinity of the 200 metres shifted in and bumped TOW RAGE (NZ). A post-race veterinary examination revealed no visible abnormalities.. Trainer issued a warning.

PASS THE GLASS (E. Finnegan) – bumped on jumping away.

REACT (H. Mckechnie) – shifted in marginally in the vicinity of the 250 metres and tightened RINEHART.

RACE 2 : NRC LIFE MEMBERS / SABOIS MAIDEN PLATE – 1430 metres

AUSSIE BOB (J. Maund) – in the vicinity of the 100 metres had to be restrained to avoid the heels of CENTENARY SHOT, which shifted in when insufficiently clear.

CENTENARY SHOT (R. Hurdle) – slow to begin. Laid in when placed under pressure in the straight. in the vicinity of the 100 metres shifted in when insufficiently clear of AUSSIE BOB. Rider reminded of his obligations to be clear when shifting ground in future.

TOM'S WAY (J. Frew) - slow to begin. Rider reported his mount began to weaken in the vicinity of the 800 metres and rounding the home turn raced on the wrong leg and was disappointing in its finish effort. A post-race veterinary examination revealed no visible abnormalities.

CHANGE COURSE (Jemma Frew) - began awkwardly. Raced wide without cover throughout the event.

SHE'S GOT RHYTHM (D. Tourneur) – rider reported after placing his mount under pressure from the 600 metres the filly failed to respond to his vigorous riding and was disappointing in its finishing effort. A post-race veterinary examination revealed no visible abnormalities.

RACE 3 : GRAROCK PLUMBING BENCHMARK 64 HANDICAP - 2000 metres

BREDLIGN (NZ) (M. Poon) - a post-race veterinary examination revealed swelling in the near fore flexor tendon. Veterinary Certificate of Fitness required prior to trial or race.

OPTICAL ILLUSION (H. McKechnie) - in the vicinity of the 1600 metres shifted in when insufficiently clear of STEP DANCE. Rider reminded of her obligations to be clear when shifting ground in future.

BLACK EYE GUY (J. Potter) - in the vicinity of the 1700 metres had to be restrained to avoid the heels of STEP DANCE, which shifted in when insufficiently clear.

SILENT INTEREST (B. Griffiths) - a post-race veterinary examination revealed no visible abnormalities.

STEP DANCE (J. Mamat) - in the vicinity of the 1700 metres shifted in when insufficiently clear of BLACK EYE GUY. Rider reprimanded. in the vicinity of the 1600 metres had to be restrained to avoid the heels of OPTICAL ILLUSION, which shifted in when insufficiently clear. In the vicinity of the 1400 metres had to be restrained after improving onto the heels of OPTICAL ILLUSION.

RACE 4 : HAYNES ENGINEERING BENCHMARK 72 HANDICAP - 1100 metres

MISS JOOLIA (H. McKechnie) - in the vicinity of the 300 metres became awkward on the heels of the weakening SANDHILL BLAZE.

SANDHILL BLAZE (Jemma Frew) – reared on jumping away. Rider explained that her instructions in the event were to lead and after rearing at the start she elected to push forward in an attempt to comply with the instructions. Stewards advised Jemma Frew that she should not have been too single minded in complying with the instructions and after rearing on jumping she should have considered other available options throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 5 : ENVIRO TEC SE BENCHMARK 72 HANDICAP - 1430 metres

WOOLSTHORPE STORE (R. Hurdle) - slow to begin.

HASTA LA SHAMER (H. McKechnie) – hampered on jumping away. Over-raced throughout the event. Rider reported that after being hampered at the start was further back than anticipated. She added in the vicinity of the 400 metres was held up momentarily on the heels of ONE FOR LATER, which was weakening. Rider also reported in the straight her mount laid out. A post-race veterinary examination revealed no visible abnormalities.

NORMANDY LAD (M. Poon) – began awkwardly, shifted in and contacted HASTA LA SHAMER.

RACE 6 : NRC PATRONS BENCHMARKS 56 HANDICAP - 1200 metres

SHE'S ALL POWER (M. Poon) – hampered shortly after the start.

SANDHILL RULER (J. Frew) – reared on jumping away and as a result was slow to begin. Raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

VISUAL IMAGE (Z. Spain) – rider reported his mount over-raced in the early and middle stages of the event and hung out. A post-race veterinary examination revealed no visible abnormalities.

ALWAYS MAGIC - underwent a pre-race veterinary examination after not racing for 12 months and passed fit to race.

HASTA LA GARBY (Jemma Frew) – over-raced in the early stages of the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was suspended from riding in races for a period to commence at midnight on Sunday, 19 June, and to conclude at midnight on Wednesday 29 June 2016: a period of four (4) meetings.

SILK AND SATIN (B. Griffiths) - raced wide without cover throughout the event.

RACE 7: LOCAL TRAINERS BENCHMARK 56 HANDICAP - 1430 metres

DOWN THE AISLE (M. Poon) - a post-race veterinary examination revealed no visible abnormalities.

TROUBLED GLASS (H. McKechnie) - slow to begin.

RORY'S UNION (J. Maund) – raced wide without cover throughout the event.
