**RACE 1 : MACUMBA STATION / SABOIS MAIDEN PLATE - 1100 metres**

**I LIKE ME** (A. Doyle) - a post-race veterinary examination revealed no visible abnormalities.

**WHITE JADE** (M. Poon) – inclined to hang out throughout the event.

**EDGE OF CHAOS** (J. Potter) - bumped by AN APPLE A DAY on jumping away.

**AN APPLE A DAY** (D. Caboche) - underwent a pre-race veterinary examination and passed fit to start. Shifted out on jumping away and made contact with EDGE OF CHAOS. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

**RACE 2 : NONNING PASTORAL CO / SABOIS MAIDEN PLATE - 1498 metres**

**SELDOM HOME** (J. Potter) – raced keenly in the early stages of the event.

**TICKLE ME ERNIE** (K. Brooks) - a post-race veterinary examination revealed no visible abnormalities.

**KING OF SIAM (NZ)** (J. Frew) – began awkwardly.

**TIME TO ORDER** (L. Stojakovic) – began awkwardly.

**RACE 3 : WILKATANA STATION BENCHMARK 54 HANDICAP - 1200 metres**

**FINNISS MOMENTS** (Z. Spain) - A post-race veterinary examination revealed no visible abnormalities.

**SCARLET LETTER** (A Doyle) - a post-race veterinary examination revealed no visible abnormalities.

**TALE BLAZER** (L. Stojakovic) – began awkwardly and shifted out onto DECOMPRESSION.

**DECOMPRESSION** (M. Poon) – was tightened for room and lost its position on jumping away when tightened between TALE BLAZER and COURT RANGER.

**RACE 4 : WIRREALPA STATION BENCHMARK 72 HANDICAP - 1100 metres**

**BOLD SENATOR** (J. Cartwright) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 5 : BILLA KALINA PASTORAL CO BENCHMARK 72 HANDICAP – 1396 metres**

**TRIUMPHANT ONE** (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 6 : C K OLDFIELD MEMORIAL BENCHMARK 60 HANDICAP - 1600 metres**

**BELGIETTO** (B. Griffiths) – pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

**KALAMURNA** (T. Pannell) – bumped by LITTLE AUDREY on jumping away.

**PILOT’S LANE** (J. Potter) - began awkwardly.

**LITTLE AUDREY** (K. Brooks) – began awkwardly shifted out and made contact with KALAMURNA.

**VIEWPOINT ESTATE** (L. Stojakovic) – raced ungenerously entering the course proper.

**RACE 7 : MAHANEWO PROPRIETORS SQUATTER’S CUP - 1867 metres**

**DEVON** (B. Griffiths) – pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$200.

**CLANDARBHEN** (K. Brooks) – over-raced in the early and middle stages of the event.

**HERO TO VILLIAN** (L. Stojakovic) – was observed to be making an abnormal respiratory noise. A post-race veterinary examination revealed no visible abnormalities. Nonetheless the trainer was advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to trial or race.

**RACE 8 : MCDOUALL PEAK PTY LTD BENCHMARK 54 HANDICAP - 1396 metres**

**CON’S GOLD** (M. Poon) - a post-race veterinary examination revealed no visible abnormalities.

**LITTLE JAY JAY** (D. Caboche) – began awkwardly, shifted out and made contact with DELANANN.

**RED BEGONIA** (A. Doyle) – passing the 600 metres was momentarily steadied after improving onto the heels of DELANANN. Inclined to lay in under pressure in the straight.

**DELANANN** (T. Pannell) – bumped by another runner on jumping away and had its hindquarters turned out.

**KOSMOS TERCEDES** (Z. Spain) – rider explained in his opinion the gelding may not have been suited by today’s soft going.
