THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Saturday, 9 July 2016

RACE 1 : SCHWEPPES HANDICAP - 1000 metres

MANUEL (M. Neilson) - jumped away awkwardly and shifted out onto FLASH HUSSY, which was hampered when tightened onto HILUMIERE, which was taken wider. Rider explained the colt was off the bit from in the vicinity of the 600 metres and whilst it finished the race off in a respectable manner, did not perform in a manner he expected. A post-race veterinary examination revealed no visible abnormalities.

SHOWPERO (J. Holder) – raced greenly over the concluding stages.

FEDEROSA (NZ) (J. Toeroek) – severely hampered inside the 100 metres and had to be steadied when taken out by FLASH HUSSY.

FLASH HUSSY (M. Poon) – shifted out under riding and inside the 100 metres shifted into the running of FEDEROSA (NZ), which was severely hampered when taken out. Rider pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday,13 July and to conclude at midnight on Wednesday, 20 July 2016 : a period of three (3) meetings.

HILUMIERE (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

VIENNA MISS (E. Finnegan) - jumped away awkwardly and raced greenly throughout the event.

RACE 2 : PROJECTION GRAPHICS HANDICAP - 1950 metres

EMMOOKI'S DASH (Z. Spain) – raced wide without cover in the middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

GENERAL CUSTER (NZ) (J. Kah) – rider explained in her opinion the gelding did not back up from its previous start and maybe better suited to racing fresh. She added whilst it made ground in the straight it did not finish the race off over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

SUBIASO (B. Claridge) – over-raced in the early stages of the event.

DANOULI (J. Holder) – raced keenly in the early stages of the event.

RACE 3 : HUGHES CHAUFFEURED LIMOUSINES TWO-YEARS-OLD MAIDEN PLATE - 1000 metres

ASHERO (R. Hurdle) - jumped away awkwardly.

FROM FIFTH (J. Cartwright) - jumped away awkwardly and raced greenly throughout the event.

HARDWICKE BAY (D. Thornton) – inconvenienced when contacted inside the 800 metres by SHE'S STARSTRUCK, which shifted in.

HERO'S HONOR (D. Caboche) – shifted out at the entrance to the straight and inconvenienced NEEDY ROCKET, which was obliged to alter course to the inside of that gelding.

NEEDY ROCKET (J. Holder) – lost its near hind plate during the event and inconvenienced at the entrance to the straight.

REWARDABLE (M. Vance) – inconvenienced shortly after the start by FROM FIFTH, which shifted out. Raced ungenerously for a short distance near the 600 metres and inside the 600 metres became awkward on the heels of NEEDY ROCKET for a number of strides.

ARIZONA WILDCAT (Z. Spain) - jumped away awkwardly, shifted out and inconvenienced DON'T CRY WOLF.

BARABBA GOLD (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

SHE'S STARSTRUCK (M. Poon) – inside the 800 metres shifted in and contacted HARDWICKE BAY, which was inconvenienced. Rider reprimanded and advised to take greater care when shifting ground.

RACE 4 : UBET HANDICAP - 1300 metres

The start of this event was delayed approximately two minutes.

COPADREAM (J. Cartwright) – underwent a pre-race veterinary examination after contacting its barrier stall after being loaded and was passed fit to race. Proved difficult to load thereafter. A post-race veterinary examination revealed no visible abnormalities. Trainer was advised the gelding would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

MEGASHOT (D. Thornton) – inconvenienced in the vicinity of the 800 metres.

PRINCE GOBLET (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

WASABI BOB (C. Lindop) – approaching the 800 metres got its head up, raced ungenerously for a short distance and became awkward on the heels of ROCKY VALLEY, shifted out and inconvenienced MEGASHOT.

RACE 5 : ROBBIE'S CHOP SHOP HANDICAP - 1000 metres

COCOA DOLL (E. Finnegan) - raced keenly in the early stages of the event. A post-race veterinary examination revealed the filly showing signs of mild tying up in both hindquarters.

ASCENDANCE (D. Thornton) - slow to begin.

NEAR QUEUE (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

FEDERAL COURT (Z. Spain) – began very awkwardly and slow to begin losing three to four lengths.

RED SCIMITAR (J. Holder) - jumped away very awkwardly. Became awkward in its stride shortly after the start and thereafter had difficulty in obtaining clear ground shortly after the entrance to the straight when racing inside ASCENDANCE and behind NEAR QUEUE. A post-race veterinary examination revealed no visible abnormalities.

RACE 6 : HOLDFAST INSURANCE HANDICAP - 1400 metres

CONSERVATORIUM (Z. Spain) – rider reported the gelding hung out during the event. A post-race veterinary examination revealed no visible abnormalities.

CELLARMASTER (NZ) (J. Cartwright) – raced wide without cover for a short distance in the vicinity of the 1200 metres. Inconvenienced in the vicinity of the 200 metres when BRINKLEY BLISS shifted out to improve. A post-race veterinary examination revealed the gelding to be lame in the near foreleg and coughing post-race. Veterinary Certificate of Fitness required prior to trial or race.

CHESTNUT CHARLIE (R. Hurdle) - underwent a pre-race veterinary examination prior to arrival at the barriers and was found to be lame in the near foreleg. CHESTNUT CHARLIE was a late scratching at 2.29 pm by order of Stewards.

BRINKLEY BLISS (J. Kah) – held up for a short distance near the 400 metres until shortly after the entrance to the straight. Approaching the 200 metres shifted out to improve and inconvenienced CELLARMASTER (NZ), which was taken wider. Rider reprimanded.

ARCTIC SONG (M. Neilson) – held up for a short distance near the 400 metres.

RACE 7 : MEDALLION HOMES HANDICAP - 1300 metres

The start of this event was delayed approximately one minute.

DEBEERSONUS (J. Kah) – laid out in the straight.

MIO DIO – proved fractious when being loaded and contacted the front of its barrier stall. Underwent a pre-race veterinary examination which revealed the gelding to have a broken tooth and blood in its mouth. MIO DIO was a late scratching by order of Stewards at 3.10 pm.

STRATEGIC DEMAND (C. Lindop) - laid in, in the straight.

RACE 8 : QUAYCLEAN HANDICAP - 1000 metres

HERENOA (M. Poon) - a post-race veterinary examination revealed a slow recovery.

IDATWO - underwent a pre-race veterinary examination after arrival on course and was found to be lame in the off foreleg. IDATWO was a late scratching at 1.20 pm by order of Stewards.

RACE 9 : MAC DRINK DRIVING? GROW UP HANDICAP - 1300 metres

CORRECT CALL (J. Holder) – in the vicinity of the 700 metres became awkward on the heels of KESAN and when being restrained shifted out abruptly onto VICEROY, which was severely hampered and became unbalanced when taken wider. A post-race veterinary examination revealed no visible abnormalities.

VICEROY (D. Thornton) – severely hampered and became unbalanced in the vicinity of the 700 metres when taken wider by CORRECT CALL.

KIFAAH (M. Neilson) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

OAMARU OWL (J. Potter) - jumped away awkwardly and then inconvenienced shortly after the start by OCTOMINT, which shifted in shortly after the start. Thereafter became awkward on the heels of OCTOMINT for a number of strides and altered course to the outside of that horse to obtain clear running.

MURTI (C. Lindop) – raced keenly in the middle stages of the event.

DAREBEN HALARO (E. Finnegan) – rider reported the gelding was uncomfortable when racing between horses in the vicinity of the home turn.

RACE 9 : MAC DRINK DRIVING? GROW UP HANDICAP - 1300 metres (Cont'd)

ROSELLI STING (R. Hurdle) – rider reported the gelding hung in, in the straight. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

OCTOMINT (D. Caboche) – shifted in at the start and inconvenienced OAMARU OWL. Lost its near fore plate during the event.

RIDER SAMPLING (19):

All nineteen (19) riders were breathalysed prior to taking their first ride. All returned negative.
