RACE 1 : CARLTON DRAUGHT MURRAY BRIDGE GOLD CUP 12 OCTOBER / SABOIS MAIDEN
PLATE - 2206 metres

THE BRIGHTONIAN (J. Maund) - slow to begin.

RACE 2 : CARLTON DRAUGHT / SABOIS TWO-YEARS-OLD MAIDEN PLATE - 1006 metres

HARDWICKE BAY (M. Neilson) – brushed on jumping away when REWARDABLE jumped away awkwardly and shifted out.

REWARDABLE (P. Gatt) - jumped away awkwardly and shifted out brushing HARDWICKE BAY.

YOUBETCHA (C. Lindop) - slow to begin.

HARLEM CHILD (M. Poon) - slow to begin.

NODOUBTABOUTIT (D. Tourneur) – held up for clear running from in the vicinity of the 700 metres until the entrance to the straight when racing on the heels of RIPPING EFFORT.

RACE 3 : CLASSICBET MAIDEN PLATE - 1006 metres

The start of this event was delayed approximately three minutes.

ANY SATURDAY NOW (C. Lindop) – raced ungenerously in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RED SCIMITAR (J. Frew) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

ULTIMATE PLEASURE (J. Holder) – reared and fell in the mounting enclosure and fell dislodging J. Holder. Underwent a pre-race veterinary examination and passed fit to race. J. Holder examined by the First Care Medical Personnel and passed fit to fulfill his remaining engagements. On arrival at the barriers had to be re-saddled. Reared behind the barriers and fell. Underwent a veterinary examination and ruled unfit to race. Acting on this advice Stewards withdrew ULTIMATE PLEASURE at 12.41 pm. It was established the filly had fractured its spine and as a result was humanely euthanized. Stewards ordered a blood sample be taken from the filly.

LA PRENEUSE (D. Caboche) – underwent a pre-race veterinary examination as the mare had not raced since February 2015 and passed fit to race.

NAUGHTY LIKE NAT (Z. Spain) - held up for clear running from the entrance to the straight until the vicinity of the 100 metres and as a result was unable to obtain clear ground for the remainder of the event.

RACE 4 : MKSL BENCHMARK 60 HANDICAP - 2206 metres

MR ANDRE (B. Griffiths) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$400.

RIGHT AND READY (J. Holder) - slow to begin. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

RACE 5 : TERMINIX PEST & WEED CONTROL / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1406 metres

RUFUS (C. Lindop) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

SAGANO (J. Frew) – inconvenienced on jumping away and as a result was slow into stride when OAK PARK VICTORIA jumped away awkwardly and shifted in.

JOIN THE CLUB (Z. Spain) – in the vicinity of the 1200 metres raced keenly for a short distance when improving on heels. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

OAK PARK VICTORIA (D. Tourneur) - jumped away awkwardly and shifted in inconveniencing SAGANO.

RACE 6 : SAMBEX SHEDS CLASS 2 HANDICAP - 1606 metres

HASTA LA RED (NZ) (C. Lindop) - slow to begin.

THE FASTNET (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

FRIENDWITHBENEFITS (M. Poon) – inclined to lay out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

DEVARICH (D. Caboche) - slow to begin.

RACE 7 : MILL PARK STUD BENCHMARK 60 HANDICAP - 1006 metres

SHIVARCHI (M. Poon) - in the vicinity of the 200 metres shifted out under pressure. Rider reprimanded.

BATTISTONI (J. Potter) - a post-race veterinary examination revealed a small laceration to the left hind pastern, a small laceration to the off fore heel and delayed recovery with an elevated heart rate.

TEMPTING FAITH (J. Mamat) - in the vicinity of the 200 metres shifted in under pressure. Rider reprimanded. A post-race veterinary examination revealed no visible abnormalities.

BLONDE MISSILE (J. Holder) - shifted out when insufficiently clear in the vicinity of the 300 metres. Rider severely reprimanded.

CRYSTAL MOMENT (O. Ridge) - in the vicinity of the 300 metres had to be steadied and lost its position when BLONDE MISSILE shifted out.

KICKSTARTER (C. Lindop) - in the vicinity of the 700 metres shifted in under pressure when racing tight inside SHIVARCHI.

MERRY CHRISTMAS (D. Tourneur) - in the vicinity of the 700 metres had to be checked and lost its position when KICKSTARTER shifted in and away from SHIVARCHI. In the vicinity of the 200 metres had to be steadied and lost its position.

MIDNIGHT MOON (Z. Spain) – lost its off fore plate during the event.

RACE 8 : WEBB CONTRACTORS BENCHMARK 60 HANDICAP - 1206 metres

FORCE OF THREE (J. Kah) – from in the vicinity of the 600 metres until approaching the 300 metres was held up for clear running.

TANZEN (Z. Spain) – raced keenly in the early and middle stages of the event. In the vicinity of the 200 metres shifted in marginally under pressure. Rider reminded of his obligations when shifting ground in future.

SAPPHIRE ZOOM (P. Gatt) - in the vicinity of the 200 metres was bumped by TANZEN on a number of occasions and was momentarily inconvenienced.

RIDER SAMPLING:

All twenty (20) riders were breathalysed prior to taking their first ride. All returned a negative result.
