RACE 1 : HOST AT WILLOW GROVE STUD BENCHMARK 72 HANDICAP - 1430 metres

HASTA LA SHAMER (B. Claridge) – over-raced in the early and middle stages of the event.

GAV'S GIFT (J. Potter) - slow to begin.

RACE 2 : D 7 M RURAL / SABOIS MAIDEN PLATE – 1430 metres

DOUBTFUL BILLY (J. Frew) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

HOPWOOD (NZ) (K. Bishop) - a post-race veterinary examination revealed no visible abnormalities.

GRECIAN SPY (D. Tourneur) – laid out under pressure in the straight.

WHEN IN VEGAS (Z. Spain) – inclined to lay in throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 3 : HANSEN DESIGN AND PRINT / SABOIS MAIDEN PLATE - 1000 metres

EXCEL TO GLORY (M. Poon) – Trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

LOTTADANE (J. Eaton) - jumped away awkwardly and as a result was slow into stride. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

MAPPING MELODY (K. Bishop) – laid in under pressure in the straight.

HANDICAP - 1430 metres**

RACE 5 : MICHELLE'S PET & HOME SERVICES BENCHMARK 60 HANDICAP - 1000 metres

NORTH BEACH (B. Griffiths) – rider pleaded guilty under AR145 in that he weighed in, in excess of half a kilogram and was fined \$200.

RACE 6 : STIRLING VINEYARD SERVICES BENCHMARK 56 HANDICAP - 1200 metres

VALENTINIAN (B. Briffiths) – at entrance to the straight had to momentarily steady when SHE’S ALL POWER shifted out when insufficiently clear.

BLACKSTEIN (J. Frew) - performed below expectations. A post-race veterinary examination revealed a poor recovery.

MOLASMO JET (B. Claridge) - in the vicinity of the 50 metres was bumped by GRETA AFFAIR and shifted out marginally. A post-race veterinary examination revealed a poor recovery.

GRETA AFFAIR (R. Hurdle) - in the vicinity of the 50 metres shifted out marginally bumping MOLASMO JET.

SHE’S ALL POWER (J. Mamat) – stood flat-footed and was very slow to begin. At the entrance to the straight shifted out when insufficiently clear of VALENTINIAN, which had to momentarily steady. Rider reprimanded.

Correct weight for this event was delayed to allow B. Claridge (MOLASMO JET) placed third to view the official footage. After doing so B. Claridge lodged an objection against GREATA AFFAIR (R. Hurdle) being declared the winner on the grounds of alleged interference from the vicinity of the 150 metres. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* B. Claridge’s objection.

RACE 7: BORDERTOWN PHARMACY BENCHMARK 60 HANDICAP - 2000 metres

The start of this event was delayed approximately three minutes due to maintenance on the track.

OPTICAL ILLUSION (J. Mamat) – bumped on jumping away when MONDATCHEV jumped away awkwardly and shifted out.

MONDATCHEV (J. Eaton) - jumped away awkwardly and shifted out bumping OPTICAL ILLUSION. A post-race veterinary examination revealed no visible abnormalities.
