## RACE 1 : BSH/ROXBY EARTHMOVING SABOIS MAIDEN PLATE - 1000 metres

AN APPLE A DAY (T Zanker) - inclined to lay in under pressure in the straight.

**RONDAFERRO** (Jemma Frew) – pleaded guilty to a charge under AR137(a) in that she was careless in dropping her whip approaching the finish and fined \$50.

Correct weight for this event was delayed to allow Stewards to view the vision of the start and take evidence from the Starter, Mr M. Patton, to ensure a fair start had been effected.

#### RACE 2 : WORKPAC/NATIONAL JOCKEYS TRUST BENCHMARK 54 HCP - 1000 metres

**BLOOMIN' ELUSIVE** (NZ) (A. Jordsjo) – reared over in the barriers. Examined by the Club's Veterinary Surgeon and declared unfit to race. Declared a late scratching at 1.52 pm. Stewards ordered deductions of 16c in the win and 14c in the place to be made. Trainer, Mr R. Campbell, advised that the mare was required to complete at least one Official Barrier Trial and one Official Jump Out to the Steward's satisfaction prior to accepting for a future event.

**WESTERN BOY** (T Zanker) – laid out from the 800 metres to the winning post. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mrs S. Ratch was advised that a Veterinary Certificate of Fitness would be required prior to presenting for a future race or trial.

SHOP FRAAR'N WIDE (J Frew) - inclined to lay in under pressure in the straight.

#### RACE 3 : KALARI PTY LTD BENCHMARK 64 HCP - 1200 metres

**LIBERTY HILL** (K Brooks) – inclined to lay in under pressure in the straight. Rider reprimanded under AR137(c) for making a celebratory gesture prior to the winning post.

MUCKATAH LAD (T Zanker) – inclined to lay in under pressure in the straight.

**SPINNING CROWN** (W Kerford) – stood flat footed and missed the start approximately eight (8) lengths. Trainer, Mr S. Whittle, was advised that the gelding would be required to jump out to the Steward's satisfaction in either an Official Jump Out or Barrier Trial prior to accepting for a future race.

### RACE 4 : TOXFREE BENCHMARK 54 HCP - 1400 metres

**FINNISS MOMENT** (Jemma Frew) – in the vicinity of the 1300 metres was inconvenienced when TILLY GIRL rolled in. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used the whip on more than five (5) occasions prior to the 100 metres and was suspended from riding in races for a period to commence at midnight on Sunday, 14 August 2016 and conclude at midnight on Wednesday, 24 August 2016, a period of four (4) meetings.

**MORE PLEASE** (B Griffiths) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**EPONA REBEL** (K Brooks) – began awkwardly and as a result was slow into stride.

**TILLY GIRL** (L Stojakovic) – in the vicinity of the 1300 metres rolled in and inconvenienced FINNISS MOMENT.

## RACE 5 : BHP BILLITON ROXBY DOWNS OUTBACK CUP - 1800 metres

**DEVON** (B Griffiths) – rider reprimanded under AR137(c) for making a celebratory gesture prior to the winning post.

## RACE 6 : AEM CONSOLIDATED BENCHMARK 60 HCP - 1600 metres

**ANOTHER ENEMY** (T Zanker) – in the vicinity of the 100 metres was obliged to alter course when VIEWPOINT ESTATE shifted in.

**VIEWPOINT ESTATE** (K Brooks) – in the vicinity of the 100 metres shifted in and inconvenienced ANOTHER ENEMY. Rider advised of her obligations when her mounts commence to shift ground.
