**RACE 1 : COOPERS/ SABOIS+ MAIDEN/CLASS 1 PLATE - 2104 metres**

**DAPPER ROSSA** (D Tourneur) – kicked mounting yard fence en route to the barriers. Underwent a pre-race veterinary examination and passed fit to race. Jumped away awkwardly and shifted in bumping ANOTHER ENEMY.

**CARSON (NZ)** (B Claridge) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

**ANOTHER ENEMY** (D Caboche) – bumped on jumping when DAPPER ROSSA jumped away awkwardly and shifted in.

**TORCHLIGHT** (J Potter) – raced ungenerously in the early stages of the event.

**RACE 2 : TREASURY WINES / SABOIS MAIDEN PLATE – 1104 metres**

**AEROFY** (D Tourneur) – from the vicinity of the 400 metres to the vicinity of the 300 metres, was held up for clear running. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**FAMILJA** (J Bowditch) – in the vicinity of the 600 meters, shifted out when insufficiently clear of ARLEIGH. Rider was severely reprimanded under AR137(a) for Careless Riding.

**EXALTED DEE** (R. Hurdle) – slow to begin. In the vicinity of the 600 metres, was momentarily inconvenienced when racing tight to the inside of ARLEIGH, which steadied and lost its position. From the vicinity of the 400 metres to the vicinity of the 300 metres, was held up for clear running.

**RACE 2 : TREASURY WINES / SABOIS MAIDEN PLATE – 1104 metres (Cont'd)**

**LA PRENEUSE** (D Caboche) – jumped away awkwardly and as a result was slow into stride.

**ARLEIGH** (K Chiong) – in the vicinity of the 600 metres, had to be steadied and lost its position when FAMILJA shifted out when insufficiently clear.

**RACE 3 : COOPERS VINTAGE ALE / SABOIS FILLIES AND MARES MAIDEN PLATE – 1204 metres**

**DROVER MAD** (B Claridge) – on arrival at the barriers the rider was concerned with the mare's action. Underwent a pre-race veterinary examination and passed fit to race.

**FROZEN HONOR** (D Tourneur) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**LIONEL LEFT ME** (D Thornton) – raced keenly in the early and middle stages of the event. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**PARLIAMENT MISS** (J Kah) – was inconvenienced on jumping away.

**SAND CAT** (M Poon) – jumped away awkwardly and shifted in, bumping PARLIAMENT MISS. Shifted out under pressure over the concluding stages.

**TICKETS TO KISS** (T Pannell) – approaching the finish had to momentarily steady when SAND CAT shifted out under pressure.

**PRETTY PUNK** (C Lindop) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**SWEET SCHILLY** (D Caboche) – jumped away awkwardly and shifted out bumping PARLIAMENT MISS.

Correct weight for this event was delayed to allow T. Pannell, the rider of the third placegetter, to view the official footage in the straight.

Following the running of this race M. Poon was examined by First Care Medical Personnel and ruled unfit to fulfil his remaining engagements.

**RACE 4 : AKEED MOFEED @ GOLDIN FARMS / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1204 metres**

**DRAGON BOSS** (T Pannell) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**RACE 5 : SCHWEPPE MAIDEN PLATE - 1504 metres**

The start of this race was delayed approximately two minutes.

**FASTER THAN YOU** (J Maund) – raced keenly in the early and middle stages of the event.

**PARENTIVE** (J Toeroek) – slow to begin.

**RUFUS** (C Lindop) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**TOTALLY WICKED** (Z Spain) – raced keenly in the early and middle stages. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**KIRONA** (T Pannell) – was examined by the Club's Veterinary Surgeon on arrival at the barriers after it contacted the mounting yard fence en-route to the start and was passed fit to race.

**RACE 5 : SCHWEPPE MAIDEN PLATE - 1504 metres (Cont'd)**

**NOT SO LADY LIKE (NZ)** (P. Gatt) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**WITCHCRAFT MISS** (J Bowditch) – a post-race veterinary examination revealed no visible abnormalities.

**RACE 6 : SANDERS FODDER BENCHMARK 56 HCP - 1204 metres**

**ZARAKHANI** (D Thornton) – raced keenly in the early and middle stages of the event.

**MAN SHE'S FAST** (S Cahill) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**PRIME FOCUS** (K Brooks) – in the vicinity of the 800 metres, raced keenly and had to be restrained off of heels momentarily. At the entrance to the home straight, when attempting to take a tight run to the inside of SCARLET ICE, had to be steadied and lost its position.

**SECRETMENS BUSINESS** (D Caboche) – slow to begin.

**SCARLET ICE** (J Toeroek) – at the entrance of the home straight, shifted in marginally away from LEAHONE.

**RACE 7 : SAVE THE DATE - GAWLER CUP SUNDAY OCTOBER 23RD BENCHMARK 60 HCP - 1104 metres**

**COOL MAVERICK** (D Caboche) - underwent a pre-race veterinary examination after being fractious in the barriers and passed fit to race.

**BOLDACIOUS GIRL** (B Griffiths) – rider reported in his opinion the mare felt awkward in its action over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

**NIL RHYTHM** (J Potter) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**SILENT SNIPER** (J Kah) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**RACE 8 : DUCATOON PARK MARES BENCHMARK 64 HCP - 1204 metres**

**MISS MURRA** (A Jordsjo) – slow to begin.

**SHE'S A STORM** (C Lindop) – slow to begin. Approaching the 200 metres, was bumped when SWEET SATURDAY shifted out. A post-race veterinary examination revealed no visible abnormalities.

**HARMONIUM BELLS** (D Tourneur) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**THE CASTLE KAT** (R Hurdle) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**SHEANNA** (B Claridge) – approaching the 200 metres had to check and lost its position when SWEET SATURDAY shifted out when insufficiently clear.

**SWEET SATURDAY** (D. Caboche) – approaching the 200 metres shifted out when insufficiently clear of SHEANNA, which had to check and lost its position. Shortly after, continued to shift out bumping SHE'S A STORM. Rider pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Saturday, 20 August, and to conclude at midnight on Saturday, 3 September 2016, a period of six (6) meetings.

**RACE 9 : KNIGHTS ROSES BENCHMARK 60 HANDICAP - 1504 metres**

**WICKED PROMISE** (M Neilson) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**DIVINE WEAVER** (C Lindop) – raced keenly in the early and middle stages of the event.

**GENERAL:**

Following the running of Race 6, B. Claridge pleaded guilty to a charge under AR175(q) for improper conduct, in that whilst unsaddling his mount in the mounting yard, he kicked MOLASMO JET in the stomach region. B. Claridge was fined the sum of \$1000, \$500 of which was suspended for a period of 12 months.
