STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 6 August 2016

RACE 1 : ARTHUR WRIGLEY HANDICAP – 1600 metres

AZURITE (IRE) (D. Thornton) – raced keenly in the early stages and approaching the 300 metres shifted out and away from THE NIGHT SKY, which rolled out and contacted CREANCE, which was severely hampered.

SANDHILL WARRIOR (M. Poon) - a post-race veterinary examination revealed a lower than expected heart rate.

CREANCE (J. Kah) – held up for clear ground from inside the 500 metres until the entrance to the straight, shifted out to improve and brushed with KIFAAH. Thereafter raced in restricted room for a short distance and shortly thereafter in the vicinity of the 300 metres improved into a tight run and was contacted by AZURITE (IRE), which shifted out and away from THE NIGHT SKY, which rolled out slightly. As a consequence CREANCE was severely hampered and contacted KIFAAH, which was inconvenienced when taken wider. Rider was advised to ensure she only attempts runs for which there is sufficient room.

LADY HEDERAJ (Z. Spain) - a post-race veterinary examination revealed no visible abnormalities.

THE NIGHT SKY (P. Gatt) – rolled out slightly in the vicinity of the 300 metres.

KIFAAH (M. Neilson) – inconvenienced at the entrance to the straight and again near the 300 metres when taken wider by CREANCE. A post-race veterinary examination revealed no visible abnormalities.

KESAN (J. Toeroek) – unable to obtain clear ground for a short distance approaching the 200 metres and again thereafter for a short distance inside the 100 metres.

RACE 2 : RICK CHESSON THREE-YEAR-OLD MAIDEN PLATE - 1050 metres

The start of this event was delayed approximately ten minutes owing initially to PRINCE OF ARABIA proving difficult to proceed to the barriers and thereafter KAPINETTE breaking free from its rider and galloping some distance before being captured. The start was further delayed when a barrier attendant was kicked by a horse behind the barriers and requiring First Care Medical assistance.

GRONKY (M. Neilson) – tightened at the start between HARLEM CHILD and NORTHERN LASS, which both shifted ground and lost its position.

PRINCE OF ARABIA (J. Allen) – proved very difficult en route to the barriers. Mr T. Jeffries, representing Trainer Mr D. Weir was advised in view of the colt's manners en route to the barriers PRINCE OF ARABIA would now be required to proceed to the barriers without delay in an Official Barrier Trial prior to accepting for a future race. A post-race veterinary examination revealed no visible abnormalities.

ARIZONA WILDCAT (Z. Spain) – shifted out approaching the 200 metres and inconvenienced RIPPING EFFORT, which had to be steadied. Rider severely reprimanded when shifting ground when insufficiently clear.

RACE 2 : RICK CHESSON THREE-YEAR-OLD MAIDEN PLATE - 1050 metres (Cont'd)

DANCING JOURNEY (C. Lindop) – awkward to begin.

KAPINETTE – a late scratching by order of Stewards on Veterinary advice at 12.55 pm when the filly dislodged E. Finnegan behind the barriers and galloped for some distance before being captured by the Clerks of the Course.

RIPPING EFFORT (E. Boyd) – obliged to be steadied in the vicinity of the 200 metres to avoid the heels of ARIZONA WILDCAT. Rider reported the filly was inclined to get away from runners during the event.

SHE RA (J. Holder) - a post-race veterinary examination revealed a lower than expected heart rate.

RACE 3 : MAXINE WHITFORD HANDICAP - 2000 metres

The start of this event was delayed approximately two minutes owing to the delay in the previous event.

DANOULI (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

SASUN (T. Pannell) – held up for clear running from in the vicinity of the 400 metres until the 200 metres. Rider explained the gelding was initially off the bridle but commenced to improve inside the 600 metres, however, thereafter he was held up for clear running for some distance inside the 400 metres and in the vicinity of the 300 metres had considered improving to the inside of ANOTHER AL but owing to that gelding rolling in, he elected to improve his position outside of ANOTHER AL but was only able to do so in the vicinity of the 200 metres.

MATERIALIZED (P. Gatt) – rider reported his saddle slipped sideways shortly after the start placing him at a disadvantage during the event.

ANOTHER AL (M. Poon) – raced wide without cover in the early stages of the event.

CENTRE DIVIDER (R. Hurdle) – pulled hard in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 4 : TERRY RENFREY HANDICAP - 2500 metres

GLORIOUS SINNDAR (FR) (J. Allen) - a post-race veterinary examination revealed no visible abnormalities.

NORO LIM (IRE) (P. Gatt) – obliged to be steadied approaching the 100 metres when PURE TANGO shifted out. A post-race veterinary examination revealed no visible abnormalities.

PURE TANGO (D. Tourneur) – rolled out approaching the 100 metres and inconvenienced NORO LIM (IRE), which had to be steadied. Rider severely reprimanded for shifting ground when insufficiently clear.

BOLD ZAMOUR (NZ) (E. Finnegan) – rider reported on pulling up she felt there may be something amiss with the gelding. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race. First aid administered.

MAWBY (K. Chiong) - a post-race veterinary examination revealed no visible abnormalities.

RACE 5 : JOCKEY CELEBRATION DAY HANDICAP - 1100 metres

The start of this event was delayed approximately two minutes.

FINE APPROACH (M. Poon) – reared after being loaded into its barrier stall, underwent a pre-race veterinary examination and passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

RACE 5 : JOCKEY CELEBRATION DAY HANDICAP - 1100 metres (Cont'd)

TYCOON SOFIE (J. Holder) – shifted in inside the 800 metres across the running of THE CASTLE KAT.

CASH IS COMING (K. Chiong) – shifted out in the vicinity of the 200 metres and crossed the running of THE CASTLE KAT, which had to be steadied for several strides to avoid the heels of CASH IS COMING. Rider pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 7 August and to conclude at midnight on Sunday, 14 August 2016: a period of three (3) meetings.

CERTAIN ELLIE (D. Tourneur) – in the vicinity of the 700 metres got its head up, over-raced for a short distance and became awkward on the heels of runners.

THE CASTLE KAT (R. Hurdle) – obliged to be checked inside the 800 metres when awkward on the heels of TYCOON SOFIE, which shifted in. Obligated to be steadied for several strides in the vicinity of the 200 metres when CASH IS COMING shifted out into its running line.

RACE 6 : PETER MACFARLANE HANDICAP - 1200 metres

USAIN DANE (K. K Chiong) – knuckled at the start and contacted ACID FLO.

HERENOA (J. Potter) – Trainer advised he would instruct the rider to be more positive in the early stages of the event.

SEGREGATION (D. Tourneur) – began awkwardly, shifted out and contacted MARBLE RYE, which shifted in at the start. Held up for a short distance approaching the 200 metres when racing between HERENOA and COOL MAVERICK.

MARCO POLO (M. Poon) - a post-race veterinary examination revealed no visible abnormalities.

MARBLE RYE (J. Toeroek) – shifted in at the start and contacted SEGREGATION.

ACID FLO (E. Boyd) – rider reported the mare appeared not to handle the underfoot conditions in today's event.

MOVIE (NZ) (M. Neilson) - a post-race veterinary examination revealed no visible abnormalities.

Correct weight for this event was delayed to allow Trainer Mr D. Jolly and J. Potter the rider of HERENOA to view the official photo for third place. They submitted to Stewards in their opinion the result should be a dead heat between HERENOA and SEGREGATION. After considering their submission, on viewing the official photo finish image and after questioning the judges, Stewards were satisfied that the correct result was declared.

RACE 7 : DAVID R COLES AM SPRING STAKES - 1200 metres

DAYTONA GREY (C. Lindop) – pulled hard in the early stages of the event.

CONSERVATORIUM (J. Bowditch) - a post-race veterinary examination revealed no visible abnormalities.

GAMBLIN' GURU (J. Holder) – awkward and slow to begin. Pulled hard in the early stages of the event.

KARACATIS (J. Toeroek) - pulled hard in the early stages of the event. A post-race veterinary examination revealed no visible abnormalities.

KARLOVASI (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

ROCKET COMMANDER (D. Tourneur) - pulled hard in the early stages of the event.

RACE 7 : DAVID R COLES AM SPRING STAKES - 1200 metres (Cont'd)

BEIRUT (J. Rule) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300.

RACE 8 : CRAIG FITZGERALD HANDICAP - 1200 metres

RAHEEBA (J. Toeroek) – rider reported in his opinion the gelding did not back up from its previous start. A post-race veterinary examination revealed no visible abnormalities.

SCHIZLE (K. Chiong) - jumped away awkwardly and contacted DARK IMAGE.

URBAN BOURBON (R. Hurdle) – began awkwardly.

SPRINGFIELD LEW (J. Potter) – rider pleaded guilty to a charge under AR137A4(b) in that he used his whip in a manner that raised his arm above shoulder height over the concluding stages and was fined \$200.

ALERTNESS (J. Holder) – rider reported the mare performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

TORCIDA (D. Tourneur) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

MIDNIGHT MOON (Z. Spain) – rider reported the gelding hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

ADJOURNED INQUIRIES	Race 5 – Into the reasons THE CASTLE KAT had to be checked near the 800 metres.
