Report on Race Meeting held at Morphetville Parks Racecourse
by the South Australian Jockey Club on Saturday, 1 October 2016

TRACK: Soft 7 (*Upgraded to Soft 6 at 11.00 am*)

WEATHER: Fine

RAIL: Out 8 metres 1000 metres to 400 metres, 6 metres to WP, 5 metres remainder.

RACE 1 : AKEED MOFEED @ GOLDIN FARMS TWO-YEAR-OLD PLATE - 1000 metres

LOVE POET (M. Poon) – slow to begin and thereafter failed to muster early speed. Approaching the 600 metres appeared to lose its footing behind and became very unbalanced and was eased out of the event by its rider. Thereafter, while being restrained, LOVE POET stepped through the inside running rail near the 200 metres and commenced to gallop towards the winning post structure on the inside of the course but was restrained by its rider and eventually pulled up near the crossing. M. Poon explained that approaching the 600 metres the horse lost its footing behind for no apparent reason and became very unbalanced. He added he formed the view that the horse may have injured itself and broken down and as a consequence he eased it out of the event. He could offer no explanation for the horse's behaviour when stepping through the running rail near the 200 metres. Mr R. Jolly, the trainer of the filly, was advised that in view of its racing manners the filly would now have to trial to the Steward's satisfaction before next being allowed to start in a race. A post-race veterinary examination revealed the filly to be lame in the near hind leg and had a haematoma to its off foreleg. First aid administered. Trainer, Mr R. Jolly, was advised a Veterinary Certificate of Fitness was required prior to presenting the filly for a trial.

POPPY DARLING (E. Boyd) – was examined by the Club's Veterinary Surgeon after arrival on course and found to have pulled its near hind shoe after being fractious in its raceday stall. Re-shod and examined by the Club's Veterinary Surgeon prior to proceeding to the mounting yard and passed fit to race. Over-raced in the early stages of the event, raced greenly and was inclined to lay in and weakened in the straight. A post-race veterinary examination revealed the filly had been galloped on, on the off hind leg, had an injury to its superficial digital flexor tendon and was lame in that leg. First aid administered. Trainer, Mr J. O'Connor, was advised a Veterinary Certificate of Fitness was required prior to presenting the filly for a future trial or race. Mr J. O'Connor advised Stewards the filly had been transported to the Morphetville Equine Clinic for treatment.

RACE 2 : ADELAIDE GALVANISING INDUSTRIES HANDICAP - 1000 metres

MR MARKOU (M. Poon) – Mr C. McEvoy, foreman acting on behalf of Mr T. McEvoy, was advised that a warning had been placed on MR MARKOU owing to the gelding being fractious in its barrier stall. Shifted out at the start and contacted FAIRY NYMPH.

FAIRY NYMPH (Z. Spain) – contacted at the start by MR MARKOU. Laid out over the concluding stages of the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 3 : ADELAIDE IMAGE PRINTING HANDICAP - 2400 metres

FLYING CASINO (J. Holder) – a post-race veterinary examination revealed no visible abnormalities.

HONEY STEEL'S GOLD (M. Neilson) – rider reported in his opinion the gelding may have come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

BARGE AND CHARGE (E. Finnegan) – rider reported the gelding got its tongue back during the event. A post-race veterinary examination revealed no visible abnormalities.

MICKIEM (B. Claridge) – acting on confirmed advice from Trainer, Mr R. Daniel, that the gelding had cast itself in its box and injured its off front and off hind legs Stewards declared this horse to be a late scratching at 8.50 am.

MATERIALISED (P. Gatt) – after arrival on course the mare was examined by the Club's Veterinary Surgeon who reported the horse to be lame in the off foreleg. MATERIALISED was declared a late scratching by order of Stewards at 1.14 pm.

BIG BOY BLEV (T. Pannell) – over-raced and raced wide without cover in the early stages of the event.

RACE 4 : GERRY SAINT MEMORIAL MAIDEN PLATE - 1300 metres

BARSHONTI (J. Toeroek) – rider reported his mount raced greenly during the event.

EXPLOSIVE GIFT (T. Pannell) – brushed and taken wider at the entrance to the straight.

TSAVORITE (P. Gatt) – a post-race veterinary examination revealed no visible abnormalities.

WAGING WAR (C. Lindop) – jumped away very awkwardly, was slow to begin and at the entrance to the straight became awkwardly placed on the heels of BEAUTIFUL VOICE, shifted out and brushed with EXPLOSIVE GIFT.

BEAUTIFUL VOICE (B. Claridge) – lost its near fore plate during the event.

CASINO CLUB (M. Poon) – contacted near the 100 metres.

FLAMES OF LIFE (J. Kah) – raced ungenerously for a short distance inside the 1000 metres and became very awkwardly placed on the heels of runners. Thereafter laid in, in the straight, shifted in abruptly in the vicinity of the 100 metres and contacted CASINO CLUB. A post-race veterinary examination revealed no visible abnormalities.

RACE 5 : LYN GRANTHAM HANDICAP - 1550 metres

AUTUMN SUNSET (D. Thornton) – a post-race veterinary examination revealed no visible abnormalities.

BOYS GETAROUND HIM (J. Toeroek) – approaching the 1000 metres shifted out slightly contacting TABLEAUX, which was taken wider.

BEAU'S MY BOY (Z. Spain) – rider reported the horse hung in from in the vicinity of the 600 metres.

METRO COWBOY (J. Kah) – rider reported that she intended on settling forward of midfield but owing to the gelding being slow to begin she was obliged to settle further back. She added that the gelding failed to finish the race off in the manner she expected and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

TABLEAUX (P. Gatt) – taken wider near the 1000 metres.

RACE 6 : KERRI TURNBULL HANDICAP – 1000 metres

DR DAPPER (C. Lindop) – tightened shortly after the start and lost its position.

I AM GYPSY (R. Hurdle) – shifted out at the start, contacting CLASSY JACK.

BAY ROAD (J. Toeroek) – jumped away awkwardly and was slow to begin.

CLASSY JACK (D. Caboche) – contacted at the start by I AM GYPSY and shifted out and away from that horse onto DR DAPPER, which was tightened onto CASINO WIZARD resulting in DR DAPPER losing its position.

RACE 7 : UBET HANDICAP - 1250 metres

DOUBLE POCKETS (E. Boyd) – shifted in, inside the 200 metres taking ALITAKA in. Rider severely reprimanded under AR137(a) for careless riding.

COUNTER PULSE (C. Lindop) – shifted out at the start and contacted HALAYR ROTHESTAR. Raced ungenerously for some distance inside the 1000 as the pace slackened.

WAPPING (K. Bishop) – shifted out inside the 200 metres taking TRUENO out. A post-race veterinary examination revealed no visible abnormalities. Rider severely reprimanded under AR137(a) for careless riding.

DUCKWORTH (S. Cahill) – rider reported that his mount dipped between the 700 metres and 600 metres. He added when placed under pressure the gelding failed to finish the event off and as he had become concerned with the horse's action did not ride his horse in his normal manner for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

ALITAKA (J. Kah) – taken in inside the 200 metres and was hampered. A post-race veterinary examination revealed a minor laceration to the near hind leg.

TRUENO (T. Pannell) – taken out inside the 200 metres and was hampered.

RACE 7 : UBET HANDICAP - 1250 metres (cont'd)

SEE ME ROLLIN' (J. Potter) – jumped away awkwardly, shifted in and contacted HALAYR ROTHESTAR. Raced ungenerously for a short distance near the 1000 metres and approaching the 800 metres again raced ungenerously and became awkward on the heels of TRUENO, clipped the heels of that horse and stumbled.

KINGSGROVE (M. Poon) – tightened inside the 200 metres between TRUENO, which was taken out by WAPPING, and ALITAKA, which was taken in by DOUBLE POCKETS, had to be checked and lost its position.

HALAYR ROTHESTAR (J. Holder) – tightened at the start between SEE ME ROLLIN' and COUNTER PULSE which both shifted ground.

RACE 8 : MAC DRINK DRIVING? GROW UP HANDICAP - 1250 metres

MOSSBEAT (Z. Spain) – rider reported the mare made breathing noises on pulling up. A post-race veterinary examination revealed the mare to be exhibiting a lower than expected heart rate.

HAZY LANE (E. Boyd) – over-raced in the early stages of the event.

COMPLETE CLASS (C. Lindop) – over-raced in the early stages of the event.

ALERTNESS (J. Holder) – rider reported that the mare was reluctant to stretch out during the event. A post-race veterinary examination revealed no visible abnormalities.

HUSHEEN (J. Kah) – rider reported that she had become concerned with the mare's action during the event. A post-race veterinary examination revealed no visible abnormalities.
