STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 8 October 2016

TRACK: Soft 5 (*Upgraded to a Good 4 at 1.15 pm retrospective to Race 1*)

WEATHER: Fine

RAIL: Out 4 metres 1200 metres to 400 metres, out 3 metres remainder.

RACE 1 : UBET HANDICAP – 2016 metres

JIM'S JOURNEY (Z. Spain) – raced greenly in the straight.

NAME THE DAY (J. Bayliss) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 2 : MELBOURNE CUP LIVE RACING @ MORPHETTVILLE HANDICAP -
1200 metres

LAST BULLET (J. Holder) – contacted in the vicinity of the 900 metres and taken in onto MAIL IT IN. Held up from in the vicinity of the 500 metres until near the 200 metres. Inclined to lay in under pressure over the concluding stages.

GREY STREET (M. Poon) – in the vicinity of the 900 metres shifted in and contacted LAST BULLET. Rider reprimanded.

MAIL IT IN (T. Pannell) – unbalanced when contacted by LAST BULLET in the vicinity of the 900 metres. Was unable to obtain clear running in the straight and was untested to the line. A post-race veterinary examination revealed the gelding had lost its near fore plate.

RACE 3 : SCHWEPES HANDICAP (HEAT 3 SPRING SERIES FOR MARES) -
1513 metres

SNAKE CHARMER (E. Finnegan) – shifted out slightly in the vicinity of the 300 metres onto MY OBSESSION. Rider reprimanded.

L'AMARYBELLE (B. Claridge) – shifted in, in the vicinity of the 300 metres onto MY OBSESSION. Rider severely reprimanded.

MY OBSESSION (H. Coffey) – in the vicinity of the 300 metres was forced to take hold and lost its position when tightened between SNAKE CHARMER, which shifted out slightly, and L'AMARYBELLE, which shifted in.

RACE 3 : SCHWEPPE'S HANDICAP (HEAT 3 SPRING SERIES FOR MARES) - 1513 metres (cont'd)

HAZY LANE (M. Poon) – when questioned regarding the instructions provided for this event M. Poon explained that he had been instructed to take up a position on pace with the option to lead if he could do so comfortably due to the apparent lack of speed in the event. Trainer, Mr R. Jolly, confirmed the instructions and advised that they were similar to those provided to E. Boyd at the mare's previous start, however on that occasion HAZY LANE had been slow to begin.

BAIKAL (Z. Spain) – reared on jumping away and was slow into stride.

RACE 4 : HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1600 metres

KAZOOM (NZ) (S. Cahill) – lost its position on jumping away when tightened onto MANDANA by DAPPER AFTER DARK. Over-raced in the middle stages of the event. Had difficulty obtaining clear ground in the straight and was obliged to alter course on a couple of occasions when ON A DREAM and DREADLOCK shifted ground slightly.

DAPPER AFTER DARK (J. Toeroek) – inconvenienced and taken out onto KAZOOM (NZ) on jumping away.

PROUD EAGLE (P. Gatt) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

IMMORTAL FIRE (B. Sweeney) – rider was unable to claim down to her minimum riding weight. After considering her explanation Stewards permitted apprentice B. Sweeney to ride the gelding half a kilogram over her minimum riding weight at the geldings allotted weight of 54 kg. Shifted out on jumping away onto DAPPER AFTER DARK, which was inconvenienced when taken out.

Correct Weight was delayed for this event to allow S. Cahill (KAZOOM (NZ)) placed third to view the official vision in the straight. After doing so S. Cahill lodged an objection against DREADLOCK (D. Thornton), the second placegetter, and ON A DREAM (C. Lindop), the winner, alleging interference from the 300 metres until the winning post. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *dismissed* both objections.

RACE 5 : AKEED MOFEED @ GOLDIN FARMS HANDICAP - 1200 metres

NEAPOLITAN (NZ) (E. Finnegan) – shifted out on jumping away contacting CRAFTED. Disappointed at the entrance to the straight when attempting a tight run to the inside of MY SNIP.

GUN GURU (T. Pannell) – rider reported that the gelding had not stretched out throughout the event despite his efforts and was disappointing. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainers, Mr L. Macdonald and Mr A. Gluyas, were advised a Veterinary Certificate of Fitness would be required prior to accepting for a future trial or race.

PERFECTLY SAFE (M. Neilson) – a post-race veterinary examination revealed no visible abnormalities.

SO YOU TOO (C. Lindop) – laid in under pressure in the straight.

RACE 5 : AKEED MOFEED @ GOLDIN FARMS HANDICAP - 1200 metres (cont'd)

CRAFTED (J. Holder) – inconvenienced on jumping away when contacted by NEAPOLITAN (NZ). Raced keenly in the middle stages of the event.

SNEAKERS (NZ) (J. Bowditch) – rider reported that the filly made excessive respiratory noise on pulling up. A post-race veterinary examination revealed no visible abnormalities.

RACE 6 : JAMES BOAG'S PREMIUM HANDICAP - 1050 metres

KING'S PARDON (Z. Spain) – had to be steadied near the 500 metres when SEGREGATION rolled out.

MARCADO (H. Coffey) – rider explained that the gelding had never travelled throughout the event and had performed poorly. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Mr S. Richards, was advised a Veterinary Certificate of Fitness would be required prior to accepting for a future trial or race.

MR LIBERTY (J. Cartwright) – slow to begin.

ROLL THE IGNITION (M. Neilson) – rider reported that the mare hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

CASH IS COMING (J. Holder) – shifted out on jumping away onto BEAU RIVAGE.

SEGREGATION (J. Toeroek) – lost its position on jumping away when tightened onto ROCK STATUS by BEAU RIVAGE. Rolled out in the vicinity of the 500 metres onto KING'S PARDON.

BEAU RIVAGE (T. Pannell) – taken out on jumping away onto SEGREGATION.

SHARK MIRAGE (D. Tootell) – reared on jumping away and was slow into stride.

RACE 7 : HILL SMITH STAKES - 1800 metres

SILVERA (D. Thornton) – laid in under pressure in the straight.

MR ALOOF (P. Gatt) – hampered on jumping away when tightened onto FULLY STOKED.

FULLY STOKED (B. Claridge) – contacted on jumping away. Shifted in under pressure in the vicinity of the 300 metres onto KALALO. Rider reminded of his obligations.

KALALO (J. Cartwright) – jumped away awkwardly and shifted out contacting MR ALOOF. Inconvenienced near the 300 metres when FULLY STOKED shifted in.

THE PERFECT CROP (NZ) (J. Maund) – became awkwardly placed on the heels of SILVERA for a number of strides in the vicinity of the 1100 metres.

MARIN COUNTY (J. Kah) – raced wide without cover throughout the event.

RACE 8 : MAC DRINK DRIVING? GROW UP HANDICAP - 1200 metres

The start of this event was delayed approximately five minutes.

RACE 8 : MAC DRINK DRIVING? GROW UP HANDICAP - 1200 metres (cont'd)

FEDERAL COURT (J. Bowditch) – taken out onto ROSELLI STING by NORTH BEACH in the vicinity of the 300 metres.

DE JORVIK (P. Gatt) – became fractious in its barrier after being loaded and struck its head. Underwent a pre-race veterinary examination and was passed fit to start. A post-race veterinary examination revealed no visible abnormalities.

ROSELLI STING (J. Kah) – inconvenienced in the vicinity of the 300 metres by FEDERAL COURT, which was taken out. Laid in under pressure in the straight.

NORTH BEACH (K. Bishop) – raced wide without cover throughout the event. Rolled out in the vicinity of the 300 metres onto FEDERAL COURT.

FREEDOM ROAD (R. Hurdle) – laid in under pressure in the straight.

SHE'S A STORM (C. Lindop) – difficult to load. Stood flat footed and missed the start many lengths. Trainers, Mr L. Macdonald and Mr A. Gluyas, were advised that the mare would be required to load without delay and jump on terms with the field in an Official Barrier trial prior to accepting for a future race.

COCOLICIOUS (J. Toeroek) – Trainer, Mr S. Theodore, advised that he would instruct his rider to attempt to settle the mare forward of mid-field.
