**Report on Race Meeting held at Morphettville Parks Racecourse**

**TRACK:** Good 4 (*Upgraded to a Good 3 at 12.45 pm retrospective to Race 1*)

**WEATHER:** Fine

**RAIL:** Out 4 metres 1000 metres to Winning Post, true remainder.

**RACE 1 : MELBOURNE PARKVIEW HOTEL HANDICAP - 1250 metres**

**MR MARKOU** (M. Poon) – rolled out rounding the home turn and was inclined to lay out under pressure in the straight.

**NAJMAAT** (M. Neilson) – jumped away awkwardly. Rider reported that the filly had raced flat. A post-race veterinary examination revealed a slightly elevated heart rate.

**RACE 2 : UBET HANDICAP - 1300 metres**

**LORD ASPEN** (M. Poon) – hung out rounding the home turn and was inclined to lay out under pressure in the straight.

**JUSTIFY THAT** (K. Bishop) – jumped away awkwardly.

**WHAT'S IN A NAME** (J. Cartwright) – Stewards questioned rider J. Cartwright in relation to his riding in this event, particularly in the stages of the straight. J. Cartwright explained that he had ridden the gelding previously and in work and in a trial leading up to this race and was of the opinion that the horse performs better when balanced and not asked for an effort too early. Stewards noted his explanation but advised him to ride in manner that did not invite question. Stewards took into account that from in the vicinity of the 200 metres when J. Cartwright had placed the gelding under pressure it had only improved past one runner to the finish, that being PEPPER THE PIN, which had commenced to weaken.

**PEPPER THE PIN** (C. Lindop) – rider reported that in her opinion the gelding may have tired up. A post-race veterinary examination revealed no visible abnormalities.

**RACE 3 : SCHWEPPE'S HANDICAP - 1950 metres**

**BOYS GETAROUND HIM** (D. Caboche) – a post-race veterinary examination revealed no visible abnormalities.

**KIFAAH** (M. Neilson) – raced keenly in the middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**ONE FOR MAX** (J. Holder) – on arrival on course was found to have lost its near fore plate. Attended to by the farrier. Underwent a pre-race veterinary examination and passed fit to start.

#### **RACE 4 : CASINO ROYALE @ MORPHETTVILLE 2/12 MAIDEN PLATE - 1400 metres**

**SUPER CHARM** (D. Thornton) – inconvenienced when bumped rounding the home turn.

**BILLET DOUX** (J. Cartwright) – rolled out rounding the home turn contacting WAGING WAR.

**FAST 'N' ROLLING** (M. Neilson) – rider reported that in his opinion the colt had not appreciated the firm track. A post-race veterinary examination revealed no visible abnormalities.

**TEQUILA FLYER** (J. Kah) – rolled out rounding the home turn and bumped SUPER CHARM.

**WAGING WAR** (C. Lindop) – jumped away awkwardly and slow into stride. Inconvenienced when rounding the home turn. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was fined \$100. In arriving at this penalty Stewards took into consideration that the rider had received pressure from her inside on the home turn and had used her whip on two occasions in an attempt to straighten and hold her position.

**LANSON LASS** (P. Gatt) – a post-race veterinary examination revealed excess upper respiratory noise. Trainer, Mr M. Huxtable, was advised the results of an endoscopic examination and a Veterinary Certificate of Fitness were required to be forward to the TRSA Veterinary Surgeon prior to accepting for a future trial or race.

#### **RACE 5 : QUAYCLEAN HANDICAP (HEAT 6 OF SPRING SERIES) - 1400 metres**

This race was delayed approximately two minutes.

**FINE APPROACH** (D. Caboche) – a post-race veterinary examination revealed no visible abnormalities.

**BELUGA BLUE** (C. Lindop) – raced keenly in the early and middle stages of the event.

**HAZY LANE** (M. Poon) – laid in under pressure in the straight.

**LA CONSOLIDATA** (D. Tourneur) – a post-race veterinary examination revealed no visible abnormalities.

**TRIMENSA** (K. Bishop) – late scratching at 3.30 pm by order of Stewards when the mare refused to load. Trainer, Mr R Atkinson, was advised that the mare would be required to load without delay in an official trial prior to accepting for a future race.

**TUNISIA TRAVELLER** (J. Kah) – rider accidentally dropped her whip in the vicinity of the 50 metres and was fined \$50 under AR137(a) for carelessness.

**THESPINIS** (E. Boyd) – became held up at the entrance to the straight until approaching the 200 metres and then had difficulty obtaining clear ground over the concluding 100 metres.

#### **RACE 6 : DAVID LOY HANDICAP – 1000 metres**

**BRIMARVI EQUIADA** (J. Cartwright) – inconvenienced on jumping away when contacted by MERRY CHRISTMAS. Shifted in slightly at the entrance to the straight onto EVIL DREAMS. Rider reported that in his opinion the gelding may have held its breath during the event. A post-race veterinary examination revealed no visible abnormalities.

**EVIL DREAMS** (M. Poon) – shifted out abruptly on jumping away onto MERRY CHRISTMAS. Hampered at the entrance to the straight when it rolled out slightly at the same time as BRIMARVI EQUIADA shifted in. Rider reported that the gelding had not travelled throughout the event and was reluctant racing inside other runners. A post-race veterinary examination revealed no visible abnormalities.

**JUST KAPPY** (J. Potter) – was inclined to roll about in the straight as it commenced to weaken and approaching the 200 metres rolled out into the running line of NORDIC ECLIPSE. Rider reprimanded and advised in future to make a great effort to keep his mounts straight when they commence to shift. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 6 : DAVID LOY HANDICAP – 1000 metres (cont'd)**

**KILLAWARRA** (J. Holder) – shifted in slightly in the vicinity of the 200 metres onto NORDIC ECLIPSE.

**NORDIC ECLIPSE** (R. Hurdle) – approaching the 200 metres was forced to take hold when JUST KAPPY rolled out as it commenced to weaken and KILLAWARRA shifted in slightly.

**MERRY CHRISTMAS** (C. Lindop) – lost its position on jumping away when tightened onto BRIMARVI EQUIADA by EVIL DREAMS. Held up from approaching the 400 metres until the entrance to the straight.

### **RACE 7 : AKEED MOFEED @ GOLDIN FARMS HANDICAP - 1550 metres**

**SPARTAN EAGLE** (K. Bishop) – inconvenienced in the vicinity of the 700 metres when ON A DREAM shifted out.

**L'AMARYBELLE** (D. Tourneur) – held up from approaching the 400 metres until the entrance to the straight.

**JUST LIVE ON** (S. Cahill) – hind quarters turned in the vicinity of the 800 metres when contacted by ON A DREAM resulting in the gelding becoming unbalanced and shifting back in.

**ON A DREAM** (C. Lindop) – raced keenly in the early and middle stages of the event and inside the 900 metres rolled out and contacted the hind quarters of JUST LIVE ON turning that gelding in resulting in ON A DREAM being inconvenienced. In the vicinity of the 700 metres shifted out onto SPARTAN EAGLE.

**ALITAKA** (J. Kah) – held up from approaching the 400 metres and was untested to the line.

**DEVILISHLY** (M. Neilson) – held up from approaching the 400 metres until near the 300 metres.

**BALLET TIME** (Z. Spain) – rider reported that he had become concerned with the mare's action in the straight.

### **RACE 8 : MAC DRINK DRIVING? GROW UP HANDICAP - 1300 metres**

**IMPORTANT** (D. Caboche) – lost its position on jumping away when tightened onto BROWN BEN by UMALUKA. Lost its position in the vicinity of the 200 metres when tightened onto ROSELLI STING by UMALUKA.

**CALL ME CURTIS** (Z. Spain) – inclined to rear on jumping away.

**TABLEAUX** (P. Gatt) – held up for a short distance at the entrance to the straight.

**ROSELLI STING** (J. Kah) – hampered and became unbalanced approaching the 200 metres when contacted by IMPORTANT taking it in onto SHARBO (NZ)

**WISE AND HAPPY** (J. Potter) – held up for a short distance at the entrance to the straight.

**THE CLASH (NZ)** (M. Poon) – inclined to rear on jumping away. A post-race veterinary examination revealed no visible abnormalities.

**UMALUKA** (R. Hurdle) – shifted out on jumping away onto IMPORTANT. Raced wide without cover throughout the event. Shifted in onto IMPORTANT approaching the 200 metres resulting in its hind quarters being turned, resulting in it shifting in further. Rider severely reprimanded.

**SHARBO (NZ)** (D. Tourneur) – hind quarters turned approaching the 200 metres when contacted by ROSELLI STING resulting in SHARBO shifting out.

**ACUTAS** (J. Maund) – co-trainer, Mr C. Binnie, advised that he would instruct the rider to attempt to gain cover in this event. A post-race veterinary examination revealed no visible abnormalities.
