Report on Race Meeting held at Morphettville Racecourse by the South Australian Jockey Club on Tuesday, 1 November 2016

RACE 1: UBET THREE-YEAR-OLD COLTS & GELDINGS MAIDEN PLATE - 1050 metres

The start of this event was delayed approximately four minutes.

EVERASREADY (J. Bowditch) – difficulty in obtaining clear ground from the entrance to the straight until approaching the 200 metres.

LANE AGAIN (E. Boyd) – inconvenienced on jumping away when tightened onto KARMIDALA and then taken back out by that gelding. Raced keenly for a short distance approaching the 600 metres. A post-race veterinary examination revealed no visible abnormalities.

RHYTHMICAL (J. Toeroek) – broke through the barrier stall after being loaded. Quickly restrained and underwent a pre-race veterinary examination at the start and passed fit to race. A post-race veterinary examination revealed no visible abnormalities.

WEATHER CHANNEL (T. Pannell) - jumped away awkwardly, shifted in contacting LANE AGAIN and shortly after, lost its position when taken back out by that gelding across the heels of MILE HIGH.

YOU ES MARSHAL (P. Gatt) – reared in the mounting yard dislodging its rider. P. Gatt was examined by the First Care Medical Personnel and passed fit to fulfil the engagement.

RACE 2: SCHWEPPES MAIDEN PLATE - 1050 metres

A LITTLE CHUNKY (J. Toeroek) - jumped away awkwardly, shifted in and was slow into stride. In the vicinity of the 200 metres had to be eased and altered course when MELODY QUEEN rolled in.

CLASSY CARMEN (K. Bishop) – fractious in its barrier after being loaded. Trainer was advised a warning had been placed on the filly in relation to its barrier manners. A post-race veterinary examination revealed no visible abnormalities.

CONTAINMENT (R. Hurdle) – shifted out on jumping away onto PENINSULA LINKS.

EYE WAS (P. Gatt) – lost its position on jumping away when tightened between CONTAINMENT, which shifted out and A LITTLE CHUNKY, which shifted in.

MELODY QUEEN (T. Pannell) - jumped away awkwardly unbalancing its rider.

RACE 2: SCHWEPPES MAIDEN PLATE - 1050 metres (Cont'd)

PENINSULA LINKS (S. Cahill) – hampered and lost its position on jumping away when tightened between A LITTLE CHUNKY and CONTAINMENT. Raced keenly in the early and middle stages of the event. Held up from in the vicinity of the 500 metres until approaching the 100 metres.

SCARLETT FOX (J. Cartwright) – brushed with ASPALIS on a number of occasions inside the 200 metres.

SHE'S STARSTRUCK (J. Holder) – held up from the entrance to the straight and was untested to the line.

ASPALIS (E. Boyd) – brushed with SCARLETT FOX on a number of occasions inside the 200 metres.

RACE 3: MELBOURNE PARKVIEW HOTEL MAIDEN PLATE - 1200 metres

FAMILJA (J. Cartwright) – inclined to lay out under pressure in the straight.

STELLA'S BRO (E. Boyd) – became fractious on exiting the mounting yard and broke through two perimeter fences. Underwent a pre-race veterinary examination and ruled unfit to race. A late scratching at 12.54 pm. Trainer was advised a warning had been placed on the gelding in relation to its pre-race behaviour.

RACE 4: ANGELAKIS BROTHERS MAIDEN PLATE - 1600 metres

BALLAST (M. Poon) - jumped away awkwardly and shifted in on jumping away.

SURE GONE (D. Caboche) – shifted out in the vicinity of the 200 metres onto TUCSON ARIZONA, which was forced to check. Rider pleaded guilty to a charge of Careless Riding under AR137(a) and was suspended from riding in races for a period to commence at midnight on Saturday, 5 November and to conclude at midnight on Wednesday, 16 November 2016: a period of five (5) meetings.

EXPLOSIVE GIFT (J. Holder) – inconvenienced on jumping away when tightened by BALLAST. A post-race veterinary examination revealed the gelding to be lame in the off hind leg. Veterinary Certificate of Fitness required prior to trial or race.

FOREIGN FIGHTER (C. Lindop) - jumped away awkwardly and shifted out making heavy contact with GOODBYE GOOD LUCK.

IMPERIAL JOURNEY (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

STREETS OF DUBAI (M. Neilson) – inclined to lay in under pressure in the straight.

TUCSON ARIZONA (S. Cahill) - slow to begin. Held up from the entrance to the straight until in the vicinity 300 metres. In the vicinity of the 200 metres had to be checked to avoid the heels of SURE GONE.

FIGUREHEAD (R. Hurdle) – raced wide without cover throughout the event.

GOODBYE GOOD LUCK (J. Maund) – lost its position on jumping away when contacted by FOREIGN FIGHTER.

RACE 5: WOLF BLASS HANDICAP - 2600 metres

SEEK TO DESTROY (J. Holder) – raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SWEDISH BITTERS (Z. Spain) - a post-race veterinary examination revealed no visible abnormalities.

RACE 5: WOLF BLASS HANDICAP - 2600 metres (Cont'd)

DITCHED (D. Tootell) - raced keenly in the early and middle stages of the event. Rider reported in his opinion the mare felt awkward in its action on pulling up. Inclined to lay in under pressure in the straight. A post-race veterinary examination revealed the mare had strained its near fore flexor tendon. First aid administered. Trainer advised a Certificate of Fitness required prior to future trial or race. Lost its off hind plate during the event.

DUQUESSA (E. Boyd) – raced keenly in the early and middle stages of the event. Had difficulty in obtaining clear ground from in the vicinity of the 500 metres until near the 200 metres.

RACE 6: BURNSIDE VILLAGE HANDICAP - 1050 metres

JUST MAK (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

RUG RAT (J. Holder) – had difficulty in obtaining clear ground for a short distance approaching the 200 metres.

SALTARELLO (M. Poon) - a post-race veterinary examination revealed no visible abnormalities.

ANOTHER TWISTER (Z. Spain) – rider reported in his opinion the mare did not feel comfortable in its action on pulling up. A post-race veterinary examination revealed no visible abnormalities.

LETTER FROM PARIS (R. Hurdle) - Trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards.

RACE 7: QUAYCLEAN HANDICAP - 1100 metres

MISS JOOLIA (D. Caboche) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

TYCOON QUEEN (K. Bishop) – had difficulty in obtaining clear ground from approaching the 300 metres until inside the 200 metres.

PUNTER'S LASS (M. Poon) - a post-race veterinary examination revealed minor lacerations to the inside of both hocks.

SHEEZ ON TOP (E. Boyd) – inclined to lay in under pressure in the straight.

LADY ANDRESS (NZ) (M. Neilson) - jumped away awkwardly and was slow into stride.

RACE 8: HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1800 metres

SPRING ACTION (M. Neilson) – raced keenly in the early and middle stages of the event.

OTHERWISE OKAY (M. Poon) – approaching the 1600 metres had to be steadied momentarily and in doing so overreacted and got its head up losing ground.

DUCHOVNY (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

JESTWIN (J. Cartwright) – shifted in onto OTHERWISE OKAY in the vicinity of the 1600 metres forcing that gelding to be steadied. Rider reprimanded.

WATCH THE WOLF (C. Lindop) - a post-race veterinary examination revealed no visible abnormalities.

LE GRAND CRU (J. Holder) – had difficulty in obtaining clear ground from the vicinity of the 500 metres until near the 300 metres.

VENI VIDI VICI (B. Claridge) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: HUGHES CHAUFFEURED LIMOUSINES HANDICAP - 1800 metres (Cont'd)

SHEANNA (R. Hurdle) – Stewards questioned jockey R. Hurdle in relation to his riding of the mare over the concluding 100 metres. After considering his explanations R. Hurdle was advised of his obligation under AR137(b) in riding his mount out to the end of the race.

RACE 9: MAC DRINK DRIVING? GROW UP HANDICAP - 1200 metres

HALAYR ROTHESTAR (S. Price) – raced wide without cover throughout the event.

HOLY FIRE (NZ) (S. Cahill) – rolled out shortly after the start onto SIR ANTHONY. Approaching the 200 metres was contacted by ENCHANTING BEAUTY and became awkward when it shifted in and away onto HONEY PRINCESS.

ENCHANTING BEAUTY (C. Lindop) – held up at the entrance to the straight and approaching the 200 metres shifted in and contacted HOLY FIRE (NZ). Rider reminded of her obligations when shifting ground in future.

HUSHEEN (J. Cartwright) – rider reported that he was concerned with the mare's action in the straight. Horse left the course prior to being examined by the Clubs Veterinary Surgeon. Veterinary Certificate of Fitness required prior to trial or race. The stable advised that the mare may be retired.

NEAR QUEUE (T. Pannell) – reared over in the mounting yard dislodging its rider. T. Pannell was examined by the First Care Medical Personnel and passed fit to ride. Underwent a pre-race veterinary examination and ruled unfit to race. A late scratching at 5.24 pm.

 $\textbf{SIR ANTHONY} \ (\textbf{J. Bowditch}) - \textbf{inconvenienced shortly after the start when HOLY FIRE} \ (\textbf{NZ}) \ \textbf{rolled out}.$
