**TRACK:** Soft 5 (*Upgraded to Good 4 at 11.50 am*)

**WEATHER:** Overcast

**RAIL:** Out 7 metres 1000 metres to the Winning Post, out 4 metres remainder.

**RACE 1 : STEADFAST BRECKNOCK INSURANCE BROKERS HANDICAP - 1400 metres**

**ENKI** (J. Kah) – jumped away awkwardly and was slow to begin.

**JUST A BIGGER DASH** (E. Boyd) – rider reported that she felt the gelding was short in its action in the straight. A post-race veterinary examination revealed no visible abnormalities.

**OCTOBER TUTU** (P. Gatt) – rider reported that he had become concerned with the gelding's action over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

**RECONNECT** (B. Stockdale) – contacted in the vicinity of the 1200 metres.

**MALMOOSA** (M. Neilson) – inclined to lay in under pressure in the straight.

**SOMETHING MORE** (J. Holder) – shifted out in the vicinity of the 1200 metres and bumped RECONNECT. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used in his whip on more than five occasions prior to the 100 metres and was reprimanded.

**RACE 2 : LITTLE HEROES FOUNDATION HANDICAP - 2400 metres**

**TIDY PROPHET** (J. Kah) – rider reported that the mare travelled well in the early stages and then had improved from the 800 metres; however, when placed under pressure in the straight failed to respond to her riding and had finished the event off poorly. She added that in her opinion TIDY PROPHET had raced flat. A post-race veterinary examination revealed no visible abnormalities.

**FLYING CASINO** (J. Holder) – a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr J. Hickmott, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**ROBOCOP** (B. Stockdale) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

**RACE 3 : MY BUTCHER HANDICAP - 1550 metres**

**HADDA COUPLE** (M. Poon) – inclined to hang out throughout the event and laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**MAIL IT IN** (C. Lindop) – jumped away awkwardly. Held up from approaching the 400 metres until inside the 300 metres.

### **RACE 3 : MY BUTCHER HANDICAP - 1550 metres (cont'd)**

**ASTRO DAMUS** (J. Toeroek) – rider reported that in his opinion the gelding may have choked down during the event.

### **RACE 4 : FLEURIEU MILK COMPANY HCP - 1400 metres**

**AMPLE ON OFFA** (E. Boyd) – Approaching the 1000 metres was racing keenly whilst being restrained and then had to be steadied, losing ground when OUR PROSPECT shifted in. Held up from the entrance to the straight until approaching the 200 metres.

**BELUGA BLUE** (C. Lindop) – raced wide without cover throughout the event.

**OUR PROSPECT** (J. Holder) – shifted in, in the vicinity of the 1000 metres onto AMPLE ON OFFA. Rider severely reprimanded.

**SHA LA LA** (B. Stockdale) – slow to begin.

### **RACE 5 : BOILEAU HANDICAP - 1400 metres**

**BENEFACTOR** (H. Coffey) – a post-race veterinary examination revealed a lower than expected heart rate.

**BOYS GETAROUND HIM** (E. Boyd) – held up from the entrance to the straight until the vicinity of the 200 metres.

**HAVE PLENTY** (J. Bowditch) – raced keenly in the early and middle stages of the event.

**MEDVEDEV** (J. Potter) – acting on confirmed advice that the gelding had an elevated temperature, Stewards declared MEDVEDEV to be a late scratching at 10.35 am.

**SPRING ACTION** (M. Neilson) – raced keenly in the early and middle stages of the event.

**LE GRAND CRU** (J. Holder) – a post-race veterinary examination revealed no visible abnormalities.

**INSUPERABLE (NZ)** (E. Finnegan) – rider reminded of her obligations in riding her mounts out to the finish of the race in accordance with AR137(b).

### **RACE 6 : CAMPAIGNCLOUD & EDWARDS ADVERTISING HANDICAP – 1400 metres**

**THE OTHER GUY** (M. Neilson) – raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed a lower than expected heart rate.

**PROUD EAGLE** (J. Kah) – had difficulty obtaining clear ground from the entrance to the straight until the vicinity of the 100 metres.

**KOOP CREEK** (M. Poon) – slow to begin. Rolled in and contacted the running rail in the vicinity of the 1200 metres and again near the 600 metres. Rider reported that he was concerned with the gelding's action in the straight. A post-race veterinary examination revealed no visible abnormalities.

### **RACE 7 : MAC DRINK DRIVING? GROW UP HANDICAP - 1250 metres**

**METIER** (D. Thornton) – shifted out and away from BEAU RIVAGE in the vicinity of the 100 metres.

**PRESIDIUM** (J. Bowditch) – raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**SVETSKI** (E. Boyd) – rider reported that her saddle shifted back on jumping away placing her at a disadvantage throughout the event.

**RACE 7 : MAC DRINK DRIVING? GROW UP HANDICAP - 1250 metres (cont'd)**

**BEAU RIVAGE** (J. Kah) – contacted on jumping away.

**SOME DO** (Z. Spain) – disappointed for run to the outside of METIER, which shifted out in the vicinity of the 100 metres, and was obliged to alter course.

**PENNY FOR A POUND** (M. Poon) – jumped away awkwardly and shifted in bumping BEAU RIVAGE.

**SEE ME ROLLIN'** (J. Potter) – raced keenly in the early and middle stages of the event.
