RACE 1 : AAP / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1006 metres

The start of this event was delayed approximately four minutes.

COOL FONZY (C. Lindop) – began awkwardly, shifted in making contact with HATTAN MAN.

EXCEED WITH MAGIC (J. Huxtable) – began awkwardly, shifted out and made contact with MACKIE. When questioned rider stated his mount began awkwardly and was unable to take up a position on pace as per his instructions. In the vicinity of the 700 metres became awkward when racing inside runners. Rider stated that his mount continued to race greenly throughout the event.

HATTAN MAN (J. Bowditch) – was hampered on jumping away.

MACKIE (J. Toeroek) – was hampered on jumping away. Rider reported his mount raced greenly throughout the event.

STREET LIFE (P. Gatt) – laid in when placed under pressure over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

MILLENNIA (Jemma Frew) – dislodged its rider behind the barriers and galloped for a short distance. Underwent a pre-race veterinary examination and passed fit to race. Rider examined by the First Care Medical Personnel and passed fit to fulfil her remaining engagements. Trainer Ms D. Kligenboeck advised a warning had been placed on the filly. Rider reported the filly raced greenly throughout the event.

RACE 2 : VINIDEX / SABOIS MAIDEN PLATE - 1608 metre

ANY SATURDAY NOW (P. Gatt) – over-raced in the early and middle stages of the event. Rider reported the gelding hung out badly throughout. A post-race veterinary examination revealed no visible abnormalities.

RACE 2 : VINIDEX / SABOIS MAIDEN PLATE - 1608 metre (cont'd)

BRUNETTE DOWNS (B. Claridge) – when questioned regarding the performance of the gelding rider stated that after his mount began well, he rode his mount out to take up a position on the pace. He added in the early stages he expected JUST WALLY to cross him to allow BRUNETTE DOWNS a trailing position behind the lead, however, when JUST WALLY failed to cross over and sit outside, his mount over-raced in the early and middle stages. He further added BRUNETTE DOWNS raced intractably around the home turn and was disappointed in its finishing efforts. A post-race veterinary examination revealed no visible abnormalities.

GOING NOWHERE (Z. Spain) – slow into stride.

UNCLE MAC (J. Potter) – raced wide without cover throughout the event.

BETTYDEE (H. McKechnie) – rider reported she had concerns with the action of the mare in the home straight and did not place the mare under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr D. Dodson, later reported that the mare had pulled up mildly sore in front and stated that he would monitor the mare over the subsequent days regarding its racing future.

RACE 3 : PHILMAC / SABOIS MAIDEN PLATE - 1208 metres

ON THE LINE (P. Gatt) - a post-race veterinary examination revealed no visible abnormalities.

A LITTLE CHUNKY (Jemma Frew) – had to be checked shortly after the start to avoid the heels of ON THE LINE, which was taken out by WILLOCHRA. In the vicinity of the 1000 metres became awkwardly placed to the inside of WAKE UP BRIAN. In the vicinity of the 350 metres had to ease to avoid the heels of WILLOCHRA, which shifted out when insufficiently clear. Raced greenly when placed under pressure in the straight.

SNOW SURRENDER (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

WILLOCHRA (B. Claridge) – shifted out on jumping away taking ON THE LINE out onto A LITTLE CHUNKY. In the vicinity of the 350 metres was disappointed for a run between JACK'S CHOICE and ON THE LINE. Rider reminded of his obligations to be clear when shifting ground in future. Rider reported that even though he was disappointed for a run in the early part of the home straight, the filly did improve into clear running but finished off in a disappointing manner. A post-race veterinary examination revealed no visible abnormalities.

RACE 4 : COONARA / AIRR BM 60 HCP - 2212 metres

ALDOLPHIN (K. Bishop) – a post-race veterinary examination revealed no visible abnormalities.

DUQUESSA (J. Eaton) – passing the winning post on the first occasion was severely hampered and had to check to avoid the heels of DAL ROMMEL, which hung out.

EXALTED DEE (E. Boyd) – in the vicinity of the 300 metres had to be eased to avoid the heels of CENTRE DIVIDER, which was taken out by PLUSHENKO.

NO DOUBTFIRE (J. Mamat) – began awkwardly.

BETTY BUTTERSCOTCH (Z. Spain) – in the vicinity of the 400 metres had to be restrained to avoid the heels of DUQUESSA after being taken out by BENEFIT.

PLUSHENKO (A. Jordsjo) – in the vicinity of the 300 metres shifted out taking CENTRE DIVIDER out onto EXALTED DEE. Rider reprimanded under AR137(a) for careless riding. In the vicinity of the 50 metres was hampered after having to be restrained to avoid the heels of CENTRE DIVIDER, which shifted in when insufficiently clear.

RACE 4 : COONARA / AIRR BM 60 HCP - 2212 metres (cont'd)

CENTRE DIVIDER (B. Griffiths) – in the vicinity of the 300 metres was taken out by PLUSHENKO. In the vicinity of the 50 metres shifted in when insufficiently clear of PLUSHENKO. Rider severely reprimanded under AR137(a) for careless riding.

DAL ROMMEL (NZ) (A. Doyle) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

BENEFIT (E. Finnegan) – laid out rounding the home turn.

RACE 5 : DAISH IRRIGATION & FODDER BENCHMARK 64 HCP - 904 metres

READY SUNSHINE (B. Griffiths) – in the vicinity of the 200 metres was disappointed for a narrow run to the inside of THE CASTLE KAT. In the vicinity of the 100 metres was required to alter course to the outside of PUNTER'S LASS to obtain clear running.

SNIP OF MAGIC (C. Lindop) – began awkwardly. In the vicinity of the 600 metres had to check to avoid the heels of DIDONATO, which shifted out abruptly whilst over-racing and as a result raced ungenerously throughout the remainder of the event.

PUNTER'S LASS (A. Jordsjo) – laid out when placed under pressure in the home straight.

DIDONATO (Z. Spain) – in the vicinity of the 600 metres shifted out abruptly whilst over-racing.

Correct weight for this event was delayed to allow the connections of READY SUNSHINE to view the official vision.

RACE 6 : ORANGE PUMPS FOUR-YEAR-OLD & OVER CLASS ONE HANDICAP - 1408 metres

DAREBEN HALARO (P. Gatt) – in the vicinity of the 200 metres was held up for clear running.

WISH LIST (J. Bowditch) – fractious in the barriers. Underwent a pre-race veterinary examination and was passed fit to start. Trainer, Mr J. Hickmott, was advised that a warning had been placed on the mare in relation to its barrier manners.

THESPINIS (E. Boyd) – laid out rounding the home turn. A post-race veterinary examination revealed no visible abnormalities.

LETTER FROM PARIS (R. Hurdle) – hampered on jumping away. A post-race veterinary examination revealed the mare had suffered a bi-lateral bleeding attack. Trainer, Mr G. Richards, was advised that as this was the mare's first bleeding attack, LETTER FROM PARIS would now be suspended from racing for a period of three months in accordance with AR53A and would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race.

LUCKY NOW (D. Tourneur) – kicked running rail en route to the barriers. Underwent a pre-race veterinary examination and was passed fit to start. Began awkwardly and shifted in hampering LETTER FROM PARIS. A post-race veterinary examination revealed no visible abnormalities.

JUST A DREAM (Jemma Frew) – knuckled on jumping. A post-race veterinary examination revealed no visible abnormalities.

DISCERN (E. Finnegan) – over-raced in the middle stages of the event.

RACE 7 : GRUNDFOS CLASS ONE HCP - 1208 metres

THE SHOW GOES ON (Z. Spain) – in the vicinity of the 900 metres clipped the heels of JUST MAK, which shifted in, and as a result blundered badly.

RACE 7 : GRUNDFOS CLASS ONE HCP - 1208 metres – (cont'd)

JUST MAK (A. Jordsjo) – hung in, in the early stages of the event. In the vicinity of the 900 metres shifted in when insufficiently clear of THE SHOW GOES ON. Rider reprimanded under AR137(a) for careless riding.

NEAR QUEUE (J. Kah) – in the vicinity of the 900 metres raced in restricted room to the inside of THE SHOW GOES ON, which was taken in by JUST MAK.

EXALTED STRAWBERRY (R. Hurdle) – late scratching at 7.55 am on veterinary advice.

KEMERI (C. Lindop) – a post-race veterinary examination revealed mare to have atrial fibrillation. Trainer, Mr S. Dodd, was advised that the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness would be required prior to the filly performing satisfactorily in an Official Barrier Trial.

RACE 8 : WHITE INTERNATIONAL DAB PUMPS BENCHMARK 60 HCP - 1608 metres

RAISE A DREAM (A. Jordsjo) – in the vicinity of the 300 metres shifted out when insufficiently clear of DEVARICH. Rider reminded of her obligations to be clear when shifting ground. In the vicinity of the 50 metres shifted out and was hampered after becoming awkwardly placed on the heels of ALWAYS MAGIC.

ALWAYS MAGIC (D. Tourneur) – laid in under pressure in the straight.

GRAND ARROW (J. Huxtable) – a post-race veterinary examination revealed a minor laceration to the off fore cannon and a lower than expected heart rate. First aid administered.

WONDERGUN (E. Finnegan) – a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer, Mr D. Saxon, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

DEVARICH (B. Griffiths) – in the vicinity of the 300 metres had to be momentarily steadied to avoid the heels of RAISE A DREAM, which shifted out.

GENERAL:

All twenty-three (23) riders underwent a breathalyzer analysis prior to their first ride.
