### THOROUGHBRED RACING S.A. LIMITED STIPENDIARY STEWARDS' REPORT

### Report on Race Meeting held at the Port Lincoln Racecourse by the Port Lincoln Racing Club on Friday, 6 January 2017

## TRACK: Good 3

WEATHER: Fine

### RAIL: Out 2 metres 800 metres to winning post, out 1 metres remainder

### RACE 1 : FOURIER TECHNOLOGIES / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1000 metres

**GRACEFUL WOLF (**E. Boyd) - slow to begin. Raced ungenerously in the early and middle stages of the event. In the vicinity of the 400 metres had to be momentarily steadied when ARTFUL IGGY raced greenly and shifted in marginally.

HARDAZ (J. Huxtable) - slow to begin. Raced ungenerously in the early and middle stages of the event.

**ARTFUL IGGY (**J. Toeroek) - slow to begin. In the vicinity of the 400 metres raced greenly for a short distance and shifted in marginally.

### RACE 2 : LINCOLN ESTATE WINES / SABOIS MAIDEN PLATE - 1210 metres

ECHO WARRIOR (D. Caboche) – raced ungenerously in the early and middle stages of the event.

**MIDRADA** (J. Huxtable) – inclined to lay out severely from the vicinity of the 500 metres until the remainder of the event. A post-race veterinary examination revealed minor laceration to the off side of the mouth.

**LIVERPOOL STRIKER** (J. Toeroek) - jumped away awkwardly. Inclined to lay out under pressure rounding the home turn.

## RACE 3 : KEMP REAL ESTATE BENCHMARK 80 HANDICAP - 1750 metres

**ARTFUL DIVA (**J. Potter) - slow to begin.

**ZIPALANG (J.** Maund) - rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

## RACE 4: AVIS PORT LINCOLN BENCHMARK 56 HANDICAP - 1750 metres

**ASH ROAD (**J. Potter) – in the vicinity of the 200 metres shifted out to improve around the heels of THE HARD WAY, which shifted in marginally under pressure.

**HERE COMES THEBOOM** (J. Maund) – jumped away awkwardly and shifted out inconveniencing TASSIE, which was taken wider. In the vicinity of the 1400 metres raced ungenerously for a short distance and had to be steadied momentarily off heels.

**THE HARD WAY** (J. Huxtable) slow to begin. Approaching the 200 metres shifted in marginally under pressure. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

**TASSIE** (J. Kah) – inconvenienced when taken wider at the start when HERE COMES THE BOOM jumped away awkwardly and shifted out. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

# RACE 4: AVIS PORT LINCOLN BENCHMARK 56 HANDICAP - 1750 metres (Cont'd)

GOLDEN CLASS (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

**PHOENIX EAGLE (NZ)** (B. Griffiths) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

# RACE 5 : PERKS INTEGRATED BUSINESS SERVICES BENCHMARK 60 HANDICAP - 1210 metres

**MORE THAN MOST (**T. Pannell) - performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**DAZZLING LILLY (**Z. Spain) – in the vicinity of the 1100 metres shifted in when insufficiently clear. Rider pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Wednesday, 11 January, and to conclude at midnight on Sunday, 15 January 2017: a period of three (3) meetings.

**SCHOONER WON (**J. Potter) – in the vicinity of the 1100 metres had to be checked and lost its position when MINDSTORMS was taken in by DAZZLING LILLY, which shifted in when insufficiently clear.

**MINDSTORMS (**E. Boyd) – in the vicinity of the 1100 metres was taken in by DAZZLING LILLY, which shifted in when insufficiently clear.

### RACE 6 : LIBERTY RURAL & LOGICOIL PORT LINCOLN BENCHMARK 80 HANDICAP - 1210 metres

The start of this event was delayed approximately six minutes.

**HANK'S NEPHEW (**R. Hurdle) - jumped away awkwardly and shifted out brushing KUNGSLEDEN. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

**CATCH HIM** (Z. Spain) – lost its near hind plate en route to the barriers and was re-shod on arrival at the start by the Farrier at the start. Underwent a pre-race veterinary examination and passed fit to race.

**KUNGSLEDEN (**J. Potter) – brushed on jumping away when HANK'S NEPHEW jumped away awkwardly and shifted out.

## RACE 7 : BETTA HOME LIVING BENCHMARK 64 HANDICAP - 1390 metres

**KOODA DUCHESS** (R. Hurdle) – slow into stride. Shortly after the start bucked for a considerable distance and took no further part in the event. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr J. Dunn was advised that the gelding would be required to perform to the satisfaction of the Stewards in an Official Barrier Trial prior to accepting for a future race.

WIND SPIRIT (J. Huxtable) - slow to begin. Lost its off hind plate during the event.

**HEZA GUNN** (J. Potter) - underwent a pre-race veterinary examination on arrival at the barriers and ruled unfit to race as it had lacerations to the near hind leg. Acting on this advice Stewards withdrew HEZA GUNN at 6.52 pm. Trainer. Ms S. Williams advised a Veterinary Certificate of Fitness is required prior to a future trial or race.

**CASINO EXIT (**D. Caboche) – in the vicinity of the 1000 metres had to be steadied off heels when racing keenly.

CHLOBOROUGH (M. Poon) - slow to begin.

## RACE 8 : PORT LINCOLN REAL ESTATE BENCHMARK 56 HANDICAP - 1000 metres

**TINTAGEL ROCKER** (J. Toeroek) – in the vicinity of the 600 metres, for a short distance, raced keenly on heels and shifted out inconveniencing ARTFUL RAMBLER, which was taken wider.

## RACE 8 : PORT LINCOLN REAL ESTATE BENCHMARK 56 HANDICAP - 1000 metres (Cont'd)

**LUDUS MAGNUS (**T. Pannell) – in the vicinity of the 200 metres was inconvenienced for a short distance when WARRASIDE EDDY shifted out under pressure and CLASSY CARMEN shifted in under pressure.

**WARRASIDE EDDY** (D. Tootell) – in the vicinity of the 200 metres shifted out under pressure and in the vicinity of the 100 metres shifted in under pressure.

**LAUVASSA (**J. Maund) - slow to begin. In the vicinity of the 100 metres had to momentarily steady when CLASSY CARMEN shifted in and away from WARRASIDE EDDY, which shifted in under pressure.

**STRAVINSKA** (B. Griffiths) – bumped on jumping away when ARTFUL RAMBLER jumped away awkwardly and shifted out.

**ARTFUL RAMBLER (**J. Potter) – jumped away awkwardly and shifted out bumping STRAVINSKA. In the vicinity of the 600 metres was inconvenienced for a short distance when taken wider as TINTAGEL ROCKER shifted out.

CLASSY CARMEN (J. Kah) – in the vicinity of the 200 metres shifted in under pressure.
