**RACE 1 : LONG'S SAND & METAL/DUTTON MOTORS/ SABOIS MAIDEN PLATE - 1606 metres**

**STRONG PLAY** (S. Price) – rolled in, in the vicinity of the 1100 metres and momentarily tightened SIXTEEN AGAIN, which was inconvenienced. Inclined to lay out for a short distance inside the 200 metres.

**PADDINGTON WAY** (S. Fawke) – a post-race veterinary examination revealed a lower than expected heart rate.

**MISS MOSSY MCLAREN** (B. Claridge) – laid in, in the straight. Rider accidentally dropped his whip inside the 200 metres and was fined \$50 under AR137(a) for carelessness in dropping his whip.

**SIXTEEN AGAIN** (J. Maund) – momentarily tightened and inconvenienced in the vicinity of the 1100 metres.

**RACE 2 ; CARRINGTON - BRYAN GUY MEMORIAL BENCHMARK 64 HANDICAP - 2206 metres**

The start of this event was delayed approximately one minute owing to an interstate delay.

**BARGE AND CHARGE** (B. Griffiths) – shifted in abruptly away from IT'S FRED inside the 400 metres and brushed the inside running rail, became very awkward and unbalanced placing B. Griffiths at a disadvantage. After being corrected the gelding shifted out and contacted the hindquarters of IT'S FRED. A post-race veterinary examination revealed no visible abnormalities.

**IT'S FRED** (S. Price) – laid in approaching the 400 metres and despite the efforts of its rider shifted in. Shortly thereafter was contacted by BARGE AND CHARGE inside the 400 metres, taken out and brushed with CHENERS. A post-race veterinary examination revealed no visible abnormalities.

**RACE 2 ; CARRINGTON - BRYAN GUY MEMORIAL BENCHMARK 64 HANDICAP - 2206 metres**  
**(cont'd)**

**CHENERS** (C. Puls) – had slight contact from IT'S FRED inside the 400 metres.

**DISCERN** (M. Poon) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. In determining a penalty Stewards had regard for M. Poon's good record and the fact that he had used the whip sparingly over the final 100 metres of the event.

**RACE 3 : RAINFOREST RETREAT B&B / SABOIS MAIDEN PLATE - 1006 metres**

**SAGANO** (J. Toeroek) – over-raced in the early and middle stages of the event. Raced greenly and was inclined to lay out throughout in the straight.

**TREGORIK** (M. Neilson) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$100.

**ELECTRIC SKY** (J. Huxtable) – shifted in over the concluding stages and inconvenienced LADY OF WAR.

**TOMORROW'S HERO** (B. Claridge) – when attempting to improve in the vicinity of the 100 metres dipped for no apparent reason and thereafter had difficulty obtaining clear running for a number of strides.

**EXALTED JENNI** (B. Griffiths) – Stewards permitted B. Griffiths to ride the filly at its allocated weight as he was unable to claim any portion of his allowance.

**LADY OF WAR** (S. Fawke) – inconvenienced over the concluding stages when ELECTRIC SKY shifted in. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$100. In determining a penalty Stewards had regard for S. Fawke's good record and his limited use of the whip over the final 100 metres of the event. Rider also reminded of his obligations under AR137A(4)(b) in respect of raising his arm above shoulder height when using the whip.

**RACE 4 : MURDOCH INSURANCE BROKERS FOUR-YEAR-OLD & OVER BENCHMARK 60**  
**HANDICAP - 1206 metres**

**STERNO** (J. Huxtable) – contacted a perimeter fence in the mounting yard en route to the start. Underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start. Contacted at the start.

**RED DAZZLE** (J. Kah) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded. In determining a penalty Stewards had regard for J. Kah's good record and her very limited use of the whip over the concluding stages of the event.

**SHA LA LA** (Jemma Frew) – began awkwardly, shifted in and contacted STERNO. Dipped for no apparent reason in the vicinity of the 500 metres. Rider reported the mare was inclined to run off rounding the home turn. A post-race veterinary examination revealed no visible abnormalities. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was suspended from riding in races for a period to commence at midnight on Wednesday, 1 February 2017 and to conclude at midnight on Wednesday, 22 February 2017, a period of 10 meetings. Having regard for Jemma Frew's record in relation to whip breaches, Stewards also ordered that she be referred to the Riders' Advisory Panel and a sports psychologist to assist her in developing strategies when using the whip.

#### **RACE 5 : HILLS HIRE BENCHMARK 64 HANDICAP - 1006 metres**

**GLOBAL ICON** (D. Caboche) – jumped away awkwardly and shifted out. Inconvenienced near the 800 metres. A post-race veterinary examination revealed a slow recovery rate.

**HEARTZ ABLAZE** (J. Bowditch) – contacted a perimeter fence in the mounting yard prior to proceeding to the barriers. Underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start. Taken wider approaching the 200 metres.

**RAIN FAST** (S. Fawke) – slow to begin losing four to five lengths.

**SUPER RULES** (J. Toeroek) – shifted in at the start and contacted LANDY ADDRESS (NZ).

**EINSTEIN MAGIC** (S. Cahill) – contacted at the start.

**LADY ADDRESS (NZ)** (J. Kah) – contacted at the start. Shifted in and contacted EINSTEIN MAGIC.

**SOCIAL MEDIA** (D. Tourneur) – rolled out near the 800 metres inconveniencing SUPER RULES, which was taken out onto GLOBAL ICON, inconveniencing that horse.

**MEADOWS CADDY** (B. Claridge) – Trainer, Mr R. Wilkinson, was reprimanded under AR59A for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by the Stewards.

#### **RACE 6 : BRIDGE STREET BOUTIQUE AUSTRALIA DAY CUP BM 80 HANDICAP - 1406 metres**

**WOAKWINE** (D. Tourneur) – performed poorly. A post-race veterinary examination revealed no visible abnormalities.

**BABITZIN** (D. Caboche) – got its head up and over-raced for a short distance near the 1000 metres. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was fined \$300. In determining penalty Stewards had regard for D. Caboche's good record and his limited use of the whip over the final 100 metres of the event.

**GO THE JOURNEY** (M. Poon) – a post-race veterinary examination revealed no visible abnormalities.

**RAISE A DREAM** (C. Lindop) – rider reported the mare laid out during the event. A post-race veterinary examination revealed the mare to be lame in the off hind leg. Trainer, Mr G. Young, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

**SENIOR COUNCIL** (K. Cross) – approaching the 100 metres rolled out and brushed I'M A BLUEBAGGER. A post-race veterinary examination revealed a slow recovery rate.

**I'M A BLUEBAGGER** (S. Fawke) – contacted approaching the 100 metres.

#### **RACE 7 : AM & ME LANGSFORD PLASTERBOARD CONTRACTORS CLASS TWO HANDICAP - 1406 metres**

**IMPULSE DIAVOLO** (D. Tootell) – jumped away awkwardly, shifted out contacting FLYING PARIS and shortly thereafter shifted in sharply contacting TIMES LIKE THESE (NZ). Tightened approaching the 1000 metres and was obliged to be steadied.

**FLYING PARIS** (J. Kah) – contacted at the start.

**HOLY JUAN** (J. Toeroek) – approaching the 1000 metres shifted in and tightened IMPULSE DIAVOLO, which had to be steadied. Rider severely reprimanded under AR137(a) for shifting ground when insufficiently clear.

**WAR POINT** (J. Holder) – slow into stride.

**RACE 7 : AM & ME LANGSFORD PLASTERBOARD CONTRACTORS CLASS TWO HANDICAP -  
1406 metres (cont'd)**

**BIT SPENSIVE** (D. Tourneur) – shifted out at the start and contacted **TIMES LIKE THESE** (NZ). Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 and was fined \$200.

**TIMES LIKE THESE (NZ)** (J. Potter) – contacted at the start by **BIT SPENSIVE**, taken out and in turn contacted **IMPULSE DIAVOLO**.
