Report on Race Meeting held at Morphettville Parks Racecourse by the South Australian Jockey Club on Wednesday, 15 February 2017

TRACK: Good 4 (Upgraded to a Good 3 @ 1.18pm retrospective to Race 1)

WEATHER: Fine

RAIL: Out 9 metres 1000 metres to WP, 6 metres remainder.

RACE 1: HOLDFAST INSURANCE / SABOIS FILLIES & MARES MAIDEN PLATE - 1000 metres

The start of this event was delayed approximately four minutes.

QUIVERS (M. Neilson) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

BIRDS IN HAND (J. Holder) – Trainer advised a warning had been placed on the filly in relation to it being difficult to load. Lost its position shortly after the start when tightened by CREPE VOLANT.

EMBECEE LIL (D. Thornton) – difficult to load. Trainer was advised that the gelding would be required to load without delay in an Official Barrier Trial prior to accepting for a future race. Contacted on jumping away. Had to be steadied and lost its position inside the 800 metres when tightened by VINO RISPETTO. A post-race veterinary examination revealed a minor laceration to the near fore pastern. First aid administered.

KAPINETTE (J. Kah) - a post-race veterinary examination revealed a slow recovery. First aid administered.

VINO RISPETTO (J. Bowditch) - slow to begin. Inconvenienced in the vicinity of the 800 metres when tightened by WHISPERING WILLOW and shortly after shifted in and away onto EMBECEE LIL. Held up from the vicinity of the 400 metres until inside the 200 metres.

WARRASIDE FAIRY (D. Tootell) - slow to begin.

WHISPERING WILLOW (S. Fawke) – shifted in inside the 800 metres onto VINO RISPETTO. Rider advised of his obligations when shifting ground.

CREPE VOLANT (B. Griffiths) – underwent a pre-race veterinary examination as the mare was fractious in its barrier after being loaded and passed fit to race. Jumped away awkwardly and shifted in contacting EMBECEE LIL and shortly after shifted out hampering BIRDS IN HAND. Rider reported the mare laid in under pressure in the straight and he had become concerned with its action over the concluding stages. A post-race veterinary examination revealed the mare to be lame in the near foreleg. Veterinary Certificate of Fitness required prior to trial or race.

RACE 2: QUAYCLEAN / SABOIS MAIDEN PLATE - 1250 metres

DAMOCLES (S. Price) – lost positon on jumping away when tightened by THINK OUT LOUD.

EXALTED JENNI (B. Griffiths) - slow to begin.

RACE 2: QUAYCLEAN / SABOIS MAIDEN PLATE - 1250 metres (Cont'd)

I'M A PRINCESS (D. Thornton) – raced in restricted room to the inside of TAQAAREED for a short distance approaching the 600 metres and near the 500 metres had to be checked and lost its position when that filly shifted in slightly. A post-race veterinary examination revealed no visible abnormalities.

TAQAAREED (J. Bowditch) – shifted in and away from SAND CAT approaching the 500 metres.

THINK OUT LOUD (D. Tourneur) - jumped away awkwardly and shifted in abruptly onto DAMOCLES.

EXALTED TRAVELLER (E. Finnegan) – rider accidentally dropped her whip inside the 200 metres and was fined \$50 under AR137(a) for carelessness.

RACE 3: UBET ADELAIDE CUP 13TH MARCH 2017 MAIDEN PLATE - 1400 metres

CHAMPION BOY (J. Toeroek) - Trainer fined \$50 under AR59A for failing to produce Thoroughbred Identification Card. The horse was permitted to start – identified from records held by Stewards. Slow to begin.

CLEVER TOMMY (R. Hurdle) – shifted out on jumping away onto YOUBETCHA. Shortly after shifted back in onto TABLE OF WISDOM.

FISH BONES FRY (S. Fawke) – taken in shortly after the start onto KIRONA. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

TABLE OF WISDOM (D. Thornton) - taken in shortly after the start onto FISH BONES FRY.

KIRONA (T. Pannell) – taken in shortly after the start onto MISS MOSSY MCLAREN. Lost its near hind plate during the event.

MISS MOSSY MCLAREN (Z. Spain) – hampered shortly after the start when KIRONA shifted in and was taken in onto FIX THE DATE.

FIX THE DATE (J. Kah) – hampered shortly after the start when tightened by MISS MOSSY MCLAREN. Inclined to lay out under pressure in the straight. Rider explained the filly was inclined to race keenly in the middle stages of the event and she had become awkwardly placed on heels on a number of occasions between the 900 metres and the 600 metres. A post-race veterinary examination revealed no visible abnormalities.

YOUBETCHA (E. Boyd) - hampered on jumping away.

RACE 4: JAMES BOAG'S PREMIUM BENCHMARK 60 HANDICAP - 1250 metres

NUTHERBOTTLEGONSKI (J. Toeroek) – rider reported that his whip had become caught in the gelding's mane for a short distance in the vicinity of the 200 metres.

SHARK MIRAGE (D. Tootell) – rider accidentally dropped his near side rein inside the 100 metres and was obliged to stop riding in an attempt to re-gather.

COOL MAVERICK (D. Caboche) – taken in, in the vicinity of the 1100 metres onto PRESIDIUM by AMINTIRE. Held up from the vicinity of the 500 metres until near the 150 metres.

PRESIDIUM (M. Poon) – had to take hold and lost its position in the vicinity of the 1100 metres to avoid the heels of COOL MAVERICK and then raced keenly in the early and middle stages of the event.

AMINTIRE (T. Pannell) – shifted in, in the vicinity of the 1100 metres onto COOL MAVERICK, which was taken in onto PRESIDIUM, which was forced to take hold and lose its position. Rider pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 19 February, and to conclude at midnight on Sunday, 26 February 2017: a period of three (3) meetings.

RACE 5: SCHWEPPES CLASS ONE HANDICAP - 1400 metres

HOLY JUAN (J. Toeroek) - rolled out onto MEADOWS CADDY in the vicinity of the 600 metres.

JEALOUS RUMOUR (D. Thornton) – held up from the entrance to the straight until approaching the 200 metres.

ALL EIGHTS (P. Gatt) – contacted near the 600 metres and became unbalanced.

GERONIMO'S SON (D. Tootell) – raced fiercely in the early and middle stages of the event.

GOT THAT SWING (J. Holder) – taken out in the vicinity of the 600 metres contacting ALL EIGHTS.

SET TO SURPRISE (D. Caboche) - a post-race veterinary examination revealed lacerations to the near hind leg. First aid administered.

RACE 6: ADELAIDE GALVANISING CLASS 2 HANDICAP - 1000 metres

SILENT ICE (S. Cahill) - jumped away awkwardly.

SUPER RULES (J. Toeroek) - jumped away awkwardly.

STAR PLAYER (T. Pannell) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

WINGARD'S MARK (R. Hurdle) – shifted out on jumping away onto STAGHORN. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

STAGHORN (J. Holder) – taken out on jumping away onto NIL RHYTHM. Had difficulty in obtaining clear ground in the early stages of the straight.

NIL RHYTHM (J. Potter) – lost its position on jumping away when tightened by STAGHORN. A post-race veterinary examination revealed no visible abnormalities.

RACE 7: MAC: STOP DRUG DRIVING BENCHMARK 60 HANDICAP - 1950 metres

MOOSEM (D. Thornton) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

ROD'S OPINION (J. Bowditch) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: HUGHES CHAUFFEURED LIMOUSINES BENCHMARK 60 HANDICAP - 1550 metres

GRAND ARMADA (D. Tootell) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

JIMMYTOWN JEWEL (J. Toeroek) – disappointed at the entrance to the straight when tightened between ICEFLOW, which shifted out slightly at the same time as TUSCAN FEVER shifted in slightly. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. Veterinary Certificate of Fitness required prior to trial or race.

TUSCAN FEVER (S. Price) – shifted in slightly at the entrance to the straight onto JIMMYTOWN JEWEL. a post-race veterinary examination revealed no visible abnormalities.

ICEFLOW (M. Neilson) – shifted out slightly at the entrance to the straight onto JIMMYTOWN JEWEL. A post-race veterinary examination revealed a lower than expected heart rate.

SASSY JO (J. Bowditch) - jumped away awkwardly.

BIG WEEKEND (B. Griffiths) - struck a perimeter fence on leaving the mounting yard. Underwent a pre-race veterinary examination at the start and passed fit to race.

RACE 3: LOCK AG SERVICES BENCHMARK 72 HANDICAP – 1200 metres

BOLD SENATOR (V. Wong) – in the vicinity of the 1000 metres shifted in when insufficiently clear of GEORDIE'S SECOND, which was taken in onto SOUND OF VICTORY, which was obliged to be checked and as a result was taken in onto TRIUMPHANT ONE, which was severely hampered and obliged to be checked. Rider pleaded guilty to a charge of Careless Riding under AR137(a) for shifting ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 19 February and to conclude at midnight on Sunday 26 February 2017: a period of three (3) meetings.
