# Report on Race Meeting held at Balaklava Racecourse by the Balaklava Racing Club on Wednesday, 12 April 2017

#### RACE 1: SHARMANS SILOS/SABOIS MAIDEN PLATE - 1056 metres

**HOW WE ROLL** (M. Neilson) – raced greenly throughout the event and was inclined to lay out under pressure in the straight. Approaching the 800 metres had to take hold to avoid the heels of DESIGNER BABY. A post-race veterinary examination revealed no visible abnormalities.

**REGAL GROVE** (P. Gatt) – slow to begin. Rider reported that the gelding may have gotten its tongue over the bit during the event. A post-race veterinary examination revealed no visible abnormalities.

**DESIGNER BABY** (J. Huxtable) – shifted in approaching the 800 metres when insufficiently clear of HOW WE ROLL, which was forced to take hold. Continued in inconveniencing MILITARY FORCES. Rider pleaded guilty to a charge of careless riding under AR137(a) and was suspended from riding in races for a period to commence at midnight Monday, 17 April 2017 and to conclude at midnight Sunday, 23 April 2017, a period of three meetings.

FIRE 'N' VICE (A. Jordsjo) – a post-race veterinary examination revealed no visible abnormalities.

**MILITARY FORCES** (K. Bishop) – inconvenienced approaching the 800 metres when DESIGNER BABY momentarily rolled into its running line. Raced keenly on the heels of DESIGNER BABY for a number of strides approaching the 600 metres.

#### RACE 2: PORT PIRIE RSL/SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1312 metres

**ACE ATTACK** (C. Lindop) – shifted in on jumping away onto REDDYDOO. Inclined to lay in, in the straight, resulting in the colt having difficulty in obtaining clear ground until inside the 200 metres.

**BWUVA** (S. Price) – lost its off fore plate during the running of the event. A post-race veterinary examination revealed no visible abnormalities.

**FROM FIFTH** (D. Thornton) – a post-race veterinary examination revealed no visible abnormalities.

**ONEWOOD** (T. Pannell) – inclined to lay out under pressure in the straight and inside the 100 metres had to be eased across the heels of TROGIR as that gelding shifted in at the same time as ONEWOOD continued to lay out slightly.

**SINGLE NO MORE** (P. Gatt) – a post-race veterinary examination revealed no visible abnormalities.

**TROGIR** (J. Huxtable) – raced keenly in the early and middle stages of the event. Shifted in under riding over the concluding 100 metres and inside the 100 metres shifted in onto ONEWOOD, which had to be eased. Rider reprimanded.

#### RACE 2: PORT PIRIE RSL/SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1312 metres (cont'd)

**REDDYDOO** (B. Griffiths) – contacted and taken in on jumping away onto PENGE.

**PENGE** (J. Kah) – contacted on jumping away.

#### RACE 3: GILLIES PLAINS & HAMPSTEAD RSL CLASS TWO HANDICAP - 1056 metres

WICKED AFFAIR (K. Crowther) – inclined to lay out under pressure in the straight.

**IDATWO** (S. Price) – Trainers Mr T. Dansie and Mrs Storr were granted permission to race the gelding with hoofpads. Mr Dansie and Mrs Storr pleaded guilty to a charge under AR140B(3) for failing to lodge a gear notification by the required time and were fined \$200. Laid out under pressure over the concluding 100 metres.

**WARRASIDE EDDY** (D. Tootell) – jumped away awkwardly. Had blood present in its near side nostril following the running of the event. Trainer, Mr G. Searle, was advised that the gelding would be required to gallop 1000 metres in the presence of a Steward prior to accepting for a future trial or race in accordance with AR53A(7).

#### RACE 4: MORPHETT VALE RSL BENCHMARK 60 HCP - 2224 metres

**DOCKER PAV** (S. Cahill) – had to be steadied and lost ground in the vicinity of the 500 metres when POWER GLEN shifted out. Inclined to lay in, in the straight. Contacted on a number of occasions over the concluding stages by POWER GLEN, which shifted out.

**POWER GLEN** (V. Wong) – shifted out in the vicinity of the 500 metres onto DOCKER PAV. Rider reprimanded. Inclined to shift about under pressure in the straight and inside the 100 metres shifted out brushing with DOCKER PAV on a number of occasions. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

**OCCIDENT (NZ)** (J. Huxtable) – rolled out in the vicinity of the 400 metres onto SET TO SURPRISE.

**DYLAN JACK** (J. Potter) – raced keenly in the early stages of the event.

**SET TO SURPRISE** (D. Thornton) – inclined to lay in, in the straight and in the vicinity of the 400 metres had to be steadied when OCCIDENT (NZ) rolled out.

Correct weight for this event was delayed to allow S. Cahill (DOCKER PAV) placed second and Trainer Mr N. Smart to view the vision on the concluding 600 metres. After doing so S. Cahill lodged an objection against POWER GLEN (V. Wong) being declared the winner alleging interference rounding the home turn and over the concluding 200 metres. After considering the evidence, on viewing the official footage and acting on their own observations, Stewards *upheld* the protest and amended the result.

The placing's were amended to read:

First No. 1 DOCKER PAV
Second No. 4 POWER GLEN
Third No. 2 LONDOSTAR
Fourth No. 7 DYLAN JACK

#### RACE 5: HENSON LLOYD/CITY GOLD BENCHMARK 64 HANDICAP - 1212 metres

The start of this event was delayed approximately two minutes to avoid a clash with an interstate event.

WEATHER CHANNEL (J. Kah) – inconvenienced on jumping away.

**ZANDERCAN** (V. Wong) – jumped away awkwardly and shifted out contacting WEATHER CHANNEL. Laid out over the concluding 600 metres.

#### RACE 6: ADELAIDE GALVANISING INDUSTRIES BENCHMARK 56 HANDICAP - 1412 metres

**ECLAIR ATTACK** (J. Huxtable) – in the vicinity of the 900 metres shifted in onto SURF CRUISER, which had to be steadied. Rider reprimanded.

**BOLD ZAC** (B. Griffiths) – laid out under pressure over the concluding stages inconveniencing JUST VICTORIA.

**FREE THE WIND** (V. Wong) – rolled out onto MAKO MAGIC approaching the 200 metres. Rider advised in future to make a greater effort to keep his mounts straight when they commence to shift ground.

**COOL TARGET** (E. Finnegan) – hampered on jumping away. Held up from the entrance to the straight and in the vicinity of the 200 metres was forced to race in restricted room between the heels of TOUCH, which was inclined to lay in, and MAKO MAGIC, which had been taken out by FREE THE WIND. COOL TARGET was untested to the line.

**SURF CRUISER** (B. Claridge) – raced fiercely in the early and middle stages of the event and in the vicinity of the 900 metres had to be steadied when ÉCLAIR ATTACK shifted in.

**TOUCH** (J. Potter) – inside the 1000 metres raced in restricted room between the heels of BOLD ZAC and FREE THE WIND, making contact with both these runners on a number of occasions, resulting in TOUCH losing its position. Inclined to lay in under pressure in the straight.

ANOTHER AL (P. Gatt) - laid out under pressure in the straight.

**JUST VICTORIA** (R. Hurdle) – taken out slightly off its running line by BOLD ZAC over the concluding 50 metres.

**MAKO MAGIC** (J. Maund) – held up approaching the 200 metres when awkwardly placed between COOL TARGET and the heels of FREE THE WIND, which shifted out.

**DIVINE WEAVER** (A. Jordsjo) – jumped away awkwardly and shifted in onto COOL TARGET. Inclined to lay out under pressure in the straight.

Correct weight for this event was delayed to allow R. Hurdle (JUST VICTORIA) placed third, to view the official vision in the straight.

#### RACE 7: TPI TROPHY BENCHMARK 64 HANDICAP - 1612 metres

**SOARING HIGH** (C. Lindop) – inclined to lay in under pressure in the straight.

**ANYPORTINASTORM** (M. Neilson) – dislodged its rider en route to the barriers and galloped riderless for some distance before being recaptured. M. Neilson was examined by the First Care Medical personnel and ruled unfit to fulfil his remaining engagements. Acting on this advice ANYPORTINASTORM was a late scratching at 4.23 pm as there was no rider available in the time frame required. Trainer, Mr G. Searle, was advised that a warning had been placed on the gelding in relation to its pre-race manners.

**WISE JOURNEY** (J. Holder) – inclined to lay in under pressure in the straight.

### RACE 8: AEP HEALTH GROUP CLASS ONE HANDICAP - 1212 metres

**MYKIEBAEU** (J. Holder) – shifted out on jumping away and contacted HEIDI STAR, resulting in MYKIEBAEU becoming unbalanced. In the vicinity of the 300 metres had to be steadied momentarily when SPRINGFIELD LEW was taken in slightly and as a result raced in restricted room until the vicinity of the 100 metres.

**SPRINGFIELD LEW** (J. Potter) – in the vicinity of the 300 metres taken in slightly onto MYKIEBAEU by PRINCESS ASTRO.

## RACE 8: AEP HEALTH GROUP CLASS ONE HANDICAP - 1212 metres (Cont'd)

**INSKY (NZ)** (T. Pannell) – momentarily inconvenienced in the vicinity of the 700 metres when MYKIEBAEU rolled in slightly.

**CAPPADOCIA** (B. Claridge) – rolled in slightly, in the vicinity of the 300 metres onto PRINCESS ASTRO.

**HEIDI STAR** (A. Jordsjo) – contacted on jumping away.

**PRINCESS ASTRO** (D. Thornton) – in the vicinity of the 300 metres shifted in and away from CAPPADOCIA onto SPRINGFIELD LEW.

**BIG WEEKEND** (R. Clark) - a post-race veterinary examination revealed the gelding to be lame in both forelegs. Veterinary Certificate of Fitness required prior to trial or race.
