Report on Race Meeting held at Morphettville Parks Racecourse
by the South Australian Jockey Club on Saturday, 23 September 2017

RACE 1: SCHWEPES THREE-YEAR-OLD MAIDEN PLATE - 1000 metres

CHAROSSA (M. Neilson) – raced greenly throughout the event. In the vicinity of the 700 metres shifted out contacting SHARING SECRETS. Clipped the heels of TAN TAT FLAME in the vicinity of the 300 metres and fell dislodging M. Neilson. M. Nielson was transported to hospital for further observation. An inquiry into this incident was adjourned to a date and time to be fixed to allow M. Neilson to be in attendance. A post-race veterinary examination revealed an abrasion to the chest and off hind. First aid administered.

MONDO MAGIC (J. Holder) – shifted out under pressure over the concluding 100 metres. Rider reminded of his obligations when his mounts commence to shift ground.

SHARING SECRETS (C. Lindop) – inconvenienced when contacted by CHAROSSA in the vicinity of the 700 metres.

MISS PASEK (J. Bowditch) - slow to begin.

TAN TAT FLAME (R. Clark) – taken wider on the track over the concluding 100 metres by MONDO MAGIC. A post-race veterinary examination revealed minor lacerations to both hind legs.

Correct weight was delayed to allow R. Clark (TAN TAT FLAME) and Trainer Mr T. McEvoy to view the official vision in the straight. After doing so R. Clark lodged an objection against MONDO MAGIC (J. Holder) being declared the winner, alleging interference over the concluding 200 metres. After considering the evidence, viewing the official vision and acting on their own observations Stewards **dismissed** the objection.

RACE 2: FLEURIEU MILK COMPANY HANDICAP – 1000 metres (Run at 1:56 pm instead of 1.21 pm)

Owing to the delay into transporting M. Neilson to hospital all races were put back by one race.

RACE 2: FLEURIEU MILK COMPANY HANDICAP – 1000 metres (Run at 1:56 pm instead of 1.21 pm) (Cont'd)

CASHED (D. Caboche) – in the vicinity of the 300 metres shifted out onto BOGGOMS, which was obliged to alter course to that gelding's inside. Rider severely reprimanded.

BOGGOMS (D. Tourneur) – raced fiercely in the middle stages of the event. In the vicinity of the 300 metres altered course to the inside of CASHED.

ICONIC (R. Clark) – Trainer advised Stewards that he would instruct his rider to attempt to settle further forward than the gelding's most recent starts. Lost its off fore plate during the event.

EVIL DREAMS (V. Wong) - a post-race veterinary examination revealed no visible abnormalities.

RACE 3: SKY – ATA TRAINERS TRUST HANDICAP - 1950 metres (Run at 2.36 pm instead of 1.56 pm)

OUR BOY NICHOLAS (R. Clark) - slow to begin.

TIME ROGUE (P. Gatt) – became cast in the barriers after being loaded. Underwent a pre-race veterinary examination who reported the gelding had injured its off hind leg and was unfit to race. Acting on this advice Stewards withdrew TIME ROGUE at 2.37 pm.

PREFERRED ROUTE (J. Bayliss) - a post-race veterinary examination revealed the gelding to be lame in both hind legs. Trainer advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

OUT OF ITALY (J. Kah) - a post-race veterinary examination revealed abnormal upper respiratory noise and was lame in the off hind leg. Trainer advised the results of a laryngoscopic examination and a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race as well as a Veterinary Certificate of Fitness for lameness.

RACE 4: THE ALBERTON HOTEL HANDICAP - 2400 metres (Run at 3.16 pm instead of 2.36 pm)

KELLSTORM (IRE) (L. Riordan) – rider explained the horse had been reluctant to settle however travelled well in the middle stages of the event. He added when asked to improve into the race with the eventual winner, THE WILLYBE (NZ), in the vicinity of the 800 metres, KELLSTORM (IRE) had only responded for a short distance and by the 600 metres was under pressure and had not responded to his riding. He added that in his opinion, the horse was not suited by the track condition or the lack of pace in the event. A post-race veterinary examination revealed no visible abnormalities.

SLY ROMANCE (NZ) (J. Kah) - jumped away awkwardly and shortly thereafter was contacted by CRY IF I WANT TO.

HOYLAKE (NZ) (V. Wong) – in the vicinity of the 1600 metres had to be steadied off the heels of TEMPS VOLEUR as the pace slackened.

VERREAUX (NZ) (M. Julius) - jumped away awkwardly.

CELTIC PRINCE (NZ) (P. Gatt) – improved onto the heels of KELLSTORM (IRE) in the vicinity of the 1600 metres as the pace slackened and had to be steadied.

CRY IF I WANT TO (J. Bayliss) - jumped away awkwardly and shifted out onto SLY ROMANCE (NZ).

RACE 5: UBET HANDICAP - 1250 metres (Run at 3.56 pm instead of 3.16 pm)

The start of this event was delayed approximately four minutes.

ASCENDANCE (J. Holder) - a post-race veterinary examination revealed no visible abnormalities.

WASABI BOB (C. Lindop) – lost its near fore plate en route to the barriers and required Farrier attention. Underwent a pre-race veterinary examination and passed fit to race.

RACE 6: HOLDFAST INSURANCE HANDICAP – 1550 metres (Run at 4.36 instead of 3.56)

MAIL IT IN (R. Clark) - a post-race veterinary examination revealed no visible abnormalities.

TUNES (P. Gatt) - jumped away awkwardly.

LITTLE AKIE (S. Fawke) – rider accidentally dropped his whip in the vicinity of the 150 metres and was fined \$50 under AR137(a) for Carelessness.

ILOVEWHATSEBRINGS (T. Pannell) - slow to begin.

RACE 7: HUGHES LIMOUSINES HANDICAP – 1300 metres (Run at 5.10 instead of 4.36 pm)

DAYTONA GREY (R. Clark) – shifted in on jumping away inconveniencing DR DAPPER. Contacted rounding the home turn by MOSS 'N' DALE (NZ).

LE COMMANDANT (J. Kah) – held up from the entrance to the straight until the vicinity of the 300 metres.

GO THE JOURNEY (V. Wong) - slow to begin.

MOSS 'N' DALE (NZ) (J. Martin) – shifted out rounding the home turn brushing DAYTONA GREY.

DR DAPPER (C. Lindop) – inconvenienced on jumping away.

SMACKDOWN (NZ) (L. Riordan) - a post-race veterinary examination revealed no visible abnormalities.

RACE 8: SPRING CARNIVAL 21 OCT – 7 NOV HANDICAP – 1400 metres (Run 5.42 pm at instead of 5.10 pm)

FULLY STOKED (E. Finnegan) – taken in on jumping away onto NIGHT QUEEN. A post-race veterinary examination revealed no visible abnormalities.

BREAKER OF CHAINS (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

YOUBETCHA (C. Lindop) – shifted in on jumping away onto FULLY STOKED.

LET'S TANGO (J. Bowditch) – shifted out on jumping away onto DARK IMAGE.

STRYKER FORTUNE (J. Kah) – held up from the vicinity of the 400 metres until near the 150 metres.

FORCE OF THREE (R. Hurdle) – held up for a short distance approaching the 200 metres. Forced to race in restricted room for a number of strides approaching the 100 metres between STAR WARS (NZ), which rolled in slightly, at the same time as LET'S TANGO shifted out.

NIGHT QUEEN (J. Holder) – taken in across the running of DARK IMAGE on jumping away. Rider reported the mare felt sore in front during the event and made excess respiratory noise. A post-race veterinary examination revealed no visible abnormalities.

DARK IMAGE (V. Wong) – lost its position on jumping away when tightened between NIGHT QUEEN, which was taken in and LET'S TANGO, which shifted out.
