### RACE 1: MOGAS MORTLOCK / SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1000 metres

The start of this event was delayed approximately two minutes

BURGUNDEE MISS (R. Clark) - jumped away awkwardly and shifted in.

**STAY SASSY** (D. Caboche) - jumped away awkwardly and shifted out. Raced wide without cover throughout the event.

## RACE 2: LIBERTY RURAL PORT LINCOLN / SABOIS FOUR-YEARS-OLD & OVER MAIDEN PLATE - 1000 metres

The start of this event was delayed approximately six minutes owing to HOW JAMMY'S THAT getting reshod

**HARDAZ** (J. Potter) – in the vicinity of the 600 metres shifted in and away from AMBER DIAMONDS and became awkward in its action when taken in onto INVINCIBLE SUSHI, which was inconvenienced. Rider reported the gelding raced greenly throughout the event. A post-race veterinary examination revealed lacerations to the off hind leg.

**HOW JAMMY'S THAT** (J. Maund) – lost its off hind plate en route to the barriers. Re-shod on arrival at the barriers. Underwent a pre-race veterinary examination and passed fit to race.

AMBER DIAMONDS (D. Caboche) - hung in throughout the event.

GOLDPHON (S. Fawke) - inclined to lay in under pressure in the straight.

**INVINCIBLE SUSHI** (J. Huxtable) – in the vicinity of the 600 metres was inconvenienced when HARDAZ shifted in and away from AMBER DIAMONDS.

**KOODA STAR** (A. Doyle) – in the vicinity of the 600 metres, when following INVINCIBLE SUSHI, which was inconvenienced, became awkward on that mare's heels and had to be restrained for a number of strides.

**MISS MOSSY MCLAREN** (R. Clark) – rider could offer no explanation into the mare's performance. A post-race veterinary examination revealed an abrasion to the corner of the mouth.

# RACE 2: LIBERTY RURAL PORT LINCOLN / SABOIS FOUR-YEARS-OLD & OVER MAIDEN PLATE - 1000 metres (Cont'd)

**SYNERGY** (V. Wong) – hung out throughout the event.

## RACE 3: PORT LINCOLN GOURMET MEATS / SABOIS FILLIES & MARES BENCHMARK 64 HANDICAP - 1000 metres

The start of this event was delayed approximately two minutes.

**NIPPY LIPPY** (R. Clark) – in the vicinity of the 200 metres rider dropped her whip. Rider pleaded guilty under AR137(a) for carelessness in dropping her whip and was fined \$50. A post-race veterinary examination revealed lacerations to both hind pasterns.

PUZZLIST (D. Caboche) - slow to begin.

**PENNY FACE** (A. Doyle) – as no suitable Apprentice was available Stewards permitted A. Doyle to ride the mare claiming half a kilogram of his allowance in this event. Slow to begin. Held up for clear running from rounding the home turn until in the vicinity of the 200 metres.

### RACE 4: LEADER DISTRIBUTORS BENCHMARK 80 HANDICAP - 1000 metres

**HANK'S NEPHEW** (R. Hurdle) – rounding the home turn was obliged to be momentarily steadied as REVENGEFUL rolled in marginally. A post-race veterinary examination revealed no visible abnormalities.

**REVENGEFUL** (D. Caboche) – rounding the home turn rolled in marginally onto HANK'S NEPHEW, which was obliged to be momentarily steadied.

**COSMIC KHELEYF** (R. Clark) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**SLIDE OF HAND** (A. Doyle) – Stewards permitted A. Doyle to ride the mare claiming half a kilogram of his allowance in this event.

# RACE 5: RON STOETZER MEMORIAL COLTS, GELDINGS & ENTIRES BENCHMARK 60 HANDICAP - 1000 metres

**THE BRONX** (J. Huxtable) - a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Trainer Ms J Stoetzer was advised a Veterinary Certificate of Fitness would be required prior to presenting the gelding for a future trial or race.

**TOLSTOY** (A. Doyle) – inclined to lay in under pressure in the straight.

MIRTHDALE (T. Pannell) – a post-race veterinary examination revealed no visible abnormalities.

**GET PRONTO** (K. Bishop) – hung in throughout the event. Became awkward on the heels of MIRTHDALE for a number of strides when rounding the home turn. Thereafter continued to hang in and approaching the 100 metres was obliged to be restrained off the heels of THE BRONX and TOLSTOY. Continued to hang in to the finish line and as a result became awkward in its action when being corrected. A post-race veterinary examination revealed laceration to the corner of the off side of the mouth. Trainer Mr J. Dunn was advised a warning had been placed on the gelding in relation to its racing manners.

**KID ME** (R. Clark) – held up for clear running from the entrance to the straight until inside the 100 metres when racing between APOLLO HOPE and SANDHILL JETT.

**PERUVIAN POWER** (J. Potter) – hung in rounding the home turn and in the straight.

**APOLLO HOPE** (D. Caboche) – required to be re-saddled on arrival at the barriers.

### RACE 6: ECOCLEAN BENCHMARK 64 HANDICAP - 1390 metres

**SCENIC MINT** (J. Huxtable) – jumped away awkwardly, shifted out and bumped EXTREME SHOT. A post-race veterinary examination revealed no visible abnormalities.

**WIND SPIRIT** (J. Potter) – held up for clear running from rounding the home turn until in the vicinity of the 150 metres.

**ONWARD** (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

CASINO EXIT (D. Caboche) - slow to begin.

**EXTREME SHOT** (V. Wong) – in the vicinity of the 100 metres rider dropped his whip. Rider pleaded guilty to a charge under AR137(a) for Carelessness in dropping his whip and was fined \$50.

XANDER'S PORSHA (S. Fawke) - jumped away awkwardly, shifted in and bumped SPINE SCHILLER.

### RACE 7: TUNARAMA COACHLINES BENCHMARK 56 HANDICAP - 1210 metres

**BOUTONNIERE** (J. Potter) – inclined to lay in under pressure in the straight.

**SAINT VALENTINE** (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

**HEZA GUNN** (J. Maund) - a post-race veterinary examination revealed ulceration to both the near and off sides of the mouth.

BENGAL TIGER (K. Bishop) - reared on jumping away.

**GRAND MARTINI** (A. Doyle) – jumped away awkwardly, shifted out and bumped MINDSTORMS. Difficulty obtaining clear ground from shortly afer the entrance to the straight and from in the vicinity of the 100 metres became held up for clear running and was untested to the line.
