STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Morphettville Racecourse
by the South Australian Jockey Club on Saturday, 30 September 2017

Stewards: M. Santoro (A/Chairman), & S. Callanan (HT) (Stewards), K. Lemay-Robins (Cadet Steward), D. Southgate (F), D. Jonas, N. Henry & F. Williams (Deputy Stewards) Dr P. Horridge & Dr B. Agnew (Veterinary Surgeons)

TRACK: Soft 5 (*Upgraded to a Good 4 at 11.35 am*)

RAIL: Out 3 metres 1200 metres to Winning Post, true remainder.

WEATHER: Fine

RACE 1: GOOD LUCK ADELAIDE CROWS HANDICAP - 1600 metres

GLAM GURU (C. Lindop) – raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

LIBERATORE (A. Mallyon) – post-race veterinary examination revealed no visible abnormalities.

PISSARO (D. Tourneur) – laid out under pressure in the straight.

RACE 2: ALEX AND BEN'S 50TH HANDICAP – 1050 metres

PHELPS GLORY (D. Tourneur) – shifted out on jumping away contacting KID FLASH. Rider explained that the gelding travelled well in the early and middle stages of the event; however, had not let down as he anticipated when placed under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

KID FLASH (J. Kah) – shifted in on jumping away contacting PHELPS GLORY.

RACE 3: NICKI EGERTON MEMORIAL HANDICAP – 1200 metres

COUNTER SPIN (R. Clark) – inconvenienced on jumping away when tightened onto ROCK STATUS. Rider reported that in her opinion the gelding had not handled the firmness of the track. A post-race veterinary examination revealed the gelding to be lame in both forelegs. Co-trainers, Mr L. Macdonald and Mr A. Gluyas, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

LAST BULLET (E. Finnegan) – laid in under pressure in the straight and shifted in making contact with EVIL DREAMS on a number of occasions. A post-race veterinary examination revealed no visible abnormalities.

HUSSYBAY (J. Kah) – shifted out on jumping away onto COUNTER SPIN. Inclined to lay out over the concluding 600 metres.

RACE 4: TRANSFORMER SERVICES HANDICAP - 1050 metres

MAGNUS KNIGHT (D. Caboche) – held up for clear ground from approaching the 400 metres until near the 300 metres and then raced in restricted room for a number of strides between POUND STERLING, which shifted out slightly at the same time as CALL ME CURTIS rolled in.

POUND STERLING (C. Lindop) – raced wide without cover throughout the event.

SHOW BENDER (J. Toeroek) – a post-race veterinary examination revealed no visible abnormalities.

RACE 4: TRANSFORMER SERVICES HANDICAP - 1050 metres (cont'd)

ASHERO (A. Jordsjo) – a post-race veterinary examination revealed no visible abnormalities.

INVISIBLE GIRL (J. Bowditch) – held up for clear running from approaching the 400 metres until near the 300 metres.

RACE 5: TOKYO CITY CUP - 1800 metres

BALF'S CHOICE (J. Kah) – a post-race veterinary examination revealed no visible abnormalities.

JIM'S JOURNEY (D. Tourneur) – had difficulty obtaining clear ground from rounding the home turn until inside the 200 metres.

RACE 6: SPRING CARNIVAL 21 OCT - 7 NOV HANDICAP - 1200 metres

BEAUTIFUL FLYER (A. Jordsjo) – in the vicinity of the 150 metres commenced to race in restricted room for a number strides between FLIGHT ACADEMY and CASH IS COMING, which was taken in slightly by NIPPERKIN. A post-race veterinary examination revealed the mare to be lame in the off foreleg. Trainer, Mr L. Jarvis, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

MODEL DRAGON (C. Caserta) – jumped away awkwardly and was slow into stride. Had difficulty obtaining clear ground from the vicinity of the 400 metres until inside the 200 metres. A post-race veterinary examination revealed no visible abnormalities.

NIPPERKIN (P. Gatt) – contacted on jumping away. A post-race veterinary examination revealed no visible abnormalities.

FEDEROSA (NZ) (J. Toeroek) – shifted in on jumping away bumping NIPPERKIN. Raced keenly in the early and middle stages of the event.

RACE 7: UBET W H WYLIE HANDICAP - 1100 metres

CRYSTAL DREAMER (A. Mallyon) – a post-race veterinary examination revealed the gelding to be lame in the off foreleg. Co-trainers, Mr M Ellerton and Mr S. Zahra, were advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

LOPE DE CAPIO (J. Lorensini) – raced fiercely in the middle stages of the event.

COOL PASSION (P. Gatt) – held up from the entrance to the straight until approaching the 200 metres.

LADY ESPRIT (J. Holder) – had to be taken hold of approaching the 100 metres to avoid the heels of DESERT LASHES, which shifted out.

BENZ (J. Kah) – jumped away awkwardly and was slow into stride. A post-race veterinary examination revealed a swelling around the off fore fetlock. Trainer, Mr G. Richards, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

DESERT LASHES (T. Pannell) – laid out under pressure in the straight and approaching the 100 metres shifted out into the running line of LADY ESPRIT, which was forced to take hold. Rider pleaded guilty to a charge of under AR137(a) for careless riding and was suspended from riding in races for a period to commence midnight Monday, 2 October and to conclude midnight Sunday, 8 October – a period of three meetings.

ONE MORE DAISY (E. Finnegan) – rider accidentally dropped her whip approaching the 200 metres and was fined \$50 under AR137(a) for carelessness.

RACE 8: THE JUNCTION HANDICAP - 1600 metres

CREANCE (J. Holder) – slow to begin.

DANCES ON STARS (NZ) (R. Clark) – slow to begin.

LADY SILHOUETTE (D. Caboche) – jumped away awkwardly.

RAHEEBA (S. Fawke) – raced keenly in the early and middle stages of the event. Inclined to shift about under pressure in the straight. Stewards questioned S. Fawke in relation to his instructions for this event. He explained that he had been instructed to settle on pace with cover if possible, which was consistent with the instructions he had been provided at RAHEEBA's most recent runs; however, after the gelding was a fraction slow to begin he had elected to ease and take cover, and due to the formation of the field he was shuffled back much further than he had anticipated. Trainer, Mr C. Bieg, confirmed that the instructions were to settle on pace and added that he was surprised at how far back RAHEEBA was in the run.

SPATHA (D. Tourneur) – a post-race veterinary examination revealed the gelding to be lame in the off hind leg. Trainer, Mr W. Wayman, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

ROTHMOORE (C. Lindop) – a post-race veterinary examination revealed no visible abnormalities.

MEDVEDEV (J. Lorensini) – had difficulty obtaining clear ground over the concluding 200 metres when racing behind RAHEEBA, which was inclined to shift about under pressure.
