RACE 1: JAMESTOWN CONTAINER / JAMESTOWN CONCRETE / JAMESTOWN CARAVAN PARK BENCHMARK 64 HANDICAP - 1000 metres

OOSTERMAN (Jemma Frew) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

MYSTICANO (L. Miller) – jumped away awkwardly and as a result was slow into stride.

GOLDEN CLASS (K. Bishop) – raced keenly in the middle stages. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that she used her whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 2: COMPLETE CHIROPRATIC/ KELLY TOYOTA/ KERIN LANDMARK RURAL/ SABOIS MAIDEN PLATE - 1000 metres

 $\textbf{RUBITRON} \; (\text{L. Miller}) - \text{inconvenienced inside the 800 metres by INVINCIBLE SUSHI}, \; \text{which shifted out}.$

INVINCIBLE SUSHI (K. Stra) – in the vicinity of the 800 metres became awkwardly placed on the heels of LASANTA, which shifted in, and was obliged to shift out momentarily inconveniencing RUBITRON.

LASANTA (O. Ridge) – in the vicinity of the 800 metres shifted in and inconvenienced INVINCIBLE SUSHI. Rider reprimanded and reminded of his obligations to straighten his mounts when they commence to shift ground. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 3: MURRAY PEST CONTROL / QUALITY LIVESTOCK / FESTIVAL HIRE BENCHMARK 60 HANDICAP - 1340 metres

RED BEGONIA (K. Stra) – laid in, in the straight.

JUST PEGGY (A. Doyle) – over-raced in the early and middle stages.

HEZA GUNN (J. Maund) – knuckled on jumping away.

TRAFALGAR BELLE (D. Tootell) – slow to begin.

RACE 4 : REDDEN BROS / RYNNES HARDWARE / WEBB TYRE SERVICE / SABOIS MAIDEN - 1340 metres

CAPTAIN MIRAGE (A. Doyle) – co-trainer, Mr T. Dansie, advised Stewards prior to the running of this race that he would instruct A. Doyle to attempt to settle CAPTAIN MIRAGE on pace with cover.

GOLD MAESTRO (D. McWhinney) – On arrival on course underwent a pre-race veterinary examination as the gelding had not raced for over 12 months and was passed fit to start. Laid in throughout the event placing its rider at a disadvantage in the vicinity of the 300 metres. A post-race veterinary examination revealed No visible abnormalities.

MY FRIEND RILEY (L. Miller) - slow to begin.

VANDERLUNE (J. Maund) - raced keenly in the early stages of the event.

RACE 5: RAILWAY HOTEL / CARLTON UNITED JAMESTOWN CUP - 1800 metres

EIGELSTEIN (GB) (Jemma Frew) – over-raced in the middle stages of the event.

DEDUCT (NZ) (D. McWhinney) – contacted an outside running rail en route to the barriers. Underwent a pre-race veterinary examination and was passed fit to start. Over-raced in the early and middle stages of the event.

RACE 6: SWAN PHARMACIES / JAMESTOWN ENGINEERING /ELDERS / KELLY KELLY BENCHMARK 54 HANDICAP- 1200 metres

SYNCHRONICITY (K. Bishop) – slow to begin.

WHITE JADE (A. Doyle) – laid out rounding the home turn.

EXTREME SHOT (J Maund) – laid in under pressure in the straight.
