**RACE 1: BK & BJ SOUTHAM TV & LINE INSTALLATION / SABOIS THREE-YEAR-OLD BENCHMARK**  
**56 HANDICAP - 1000 metres**

**MIRTHDALE** (A. Jordsjo) – rider reported her mount was inclined to lay in, in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**DEXTER YOU DEVIL** (J. Huxtable) – began awkwardly.

**PUZZLIST** (R. Clark) – laid in when placed under pressure in the straight.

**SHEZA PROPHET** (R. Hurdle) – over-raced in the early and middle stages of the event.

**RACE 2: AVIS PORT LINCOLN / SABOIS MAIDEN PLATE - 1210 metres**

**HOW JAMMY'S THAT** (J. Maund) – in the vicinity of the 1100 metres was taken in onto PENNY FACE by HUSSARAMA, which shifted in when insufficiently clear. In the vicinity of the 100 metres laid in when placed under pressure tightening the running of PENNY FACE. Rider was reprimanded.

**NEVA DOUBT US** (K. Crowther) – in the vicinity of the 800 metres had to be restrained after becoming awkwardly placed on the running rail. Inconvenienced on entering the home straight.

**HUSSARAMA** (S. Fawke) – in the vicinity of the 1100 metres shifted in when insufficiently clear of HOW JAMMY'S THAT taking that runner in onto PENNY FACE, which had to be checked to avoid that runner's heels. Rider found guilty to a charge of careless riding under AR137(a) in that he shifted ground when insufficiently clear and was suspended from riding in races for a period to commence at midnight on Sunday, 8 October and to conclude at midnight on Sunday, 15 October 2017: a period of three meetings. In the vicinity of the 1000 metres continued to shift in taking HOW JAMMY'S THAT in onto MISS MOSSY MCLAREN, which had to be restrained to avoid that gelding's heels. Rider severely reprimanded. In the vicinity of the 100 metres laid out under pressure tightening the running of PENNY FACE. Rider was reprimanded. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was fined \$200.

**MISS MOSSY MCLAREN** (R. Clark) – in the vicinity of the 1000 metres had to be restrained to avoid the heels of HOW JAMMY'S THAT, which was taken in by HUSSARAMA, which shifted in when insufficiently clear.

**PENNY FACE** (A. Doyle) – in the vicinity of the 100 metres had to be checked to avoid the heels of HOW JAMMY'S THAT, which shifted in and HUSSARAMA, which shifted out.

**RACE 2: AVIS PORT LINCOLN / SABOIS MAIDEN PLATE - 1210 metres (Cont'd)**

**SHE'S RENELDASGIRL** (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 3: LOCAL LIQUID CLASS ONE HANDICAP - 1210 metres**

**DEEKS** (J. Huxtable) – laid out in the early and middle stages of the event.

**ARTFUL IGGY** (R. Clark) – hampered on jumping away. A post-race veterinary examination revealed no visible abnormalities.

**LIVERPOOL STRIKER** (R. Hurdle) – rider reported his saddle shifted forward in the early stages of the event which placed him at a disadvantage for the remainder of the event. On entering the home straight shifted out taking JUST PAST MIDNIGHT out onto BENGAL TIGER.

**JUST PAST MIDNIGHT** (D. Caboche) – began awkwardly, shifted out onto ARTFUL IGGY. On entering the home straight was taken wider by LIVERPOOL STRIKER out onto BENGAL TIGER.

**BENGAL TIGER** (V. Wong) – had to be restrained on entering the home straight to avoid the heels of JUST PAST MIDNIGHT, which was taken out by LIVERPOOL STRIKER.

**GRAND MARTINI** (A. Doyle) – laid in when placed under pressure in the home straight.

**RACE 4: LOWE & REDDING DESIGN FOUR-YEAR-OLD & OVER BENCHMARK 56 HANDICAP - 1000 metres**

**CYCLONE STRYKER** (R. Clark) – on entering the home straight shifted out to attempt a narrow run and as a result made contact with APPOLLO HOPE.

**GET PRONTO** (V. Wong) – held up for clear running on entering the straight until inside the 150 metres.

**APOLLO HOPE** (D. Caboche) – bumped on entering the home straight.

**ARTFUL RAMBLER** (J. Potter) – raced wide without cover throughout the event.

**SAINT VALENTINE** (R. Hurdle) – began awkwardly and shifted out.

**SLIDE OF HAND** (A. Doyle) – laid out when placed under pressure in the straight. In the vicinity of the 50 metres became awkwardly placed on the heels of SANDHILL JET.

**MAPPINGA QUEEN** (K. Stra) – hampered shortly after jumping away. Held up for clear running on entering the home straight and was unable to be tested to the line.

**RACE 5: LEADER DISTRIBUTORS BENCHMARK 64 HANDICAP – 1210 metres**

**COSMIC KHELEYF** (K. Crowther) – laid in under pressure in the straight.

**HEZA HUSSLER** (D. Caboche) – raced wide without cover throughout the event.

**DIVADEBEER** (R. Hurdle) - jumped away awkwardly and shifted out making contact with TOUCH OF BELLA.

**TOUCH OF BELLA** (V. Wong) – hampered on jumping away.

**MINDSTORMS** (D. Fawke) – inconvenienced shortly after jumping away.

**RACE 6: LINCOLN ESTATE WINES BENCHMARK 80 HANDICAP - 1000 metres**

**DEBEERSONUS** (D. Caboche) – rider reported his mount laid in severely throughout the event. A post-race veterinary examination revealed no visible abnormalities.

**TOLSTOY** (A. Doyle) - slow to begin. Rider reported his mount raced greenly throughout the event and became awkward in its stride when entering the straight.

**RACE 7: VETS ON EYRE BENCHMARK 64 HANDICAP - 1390 metres**

**BETTERTHANYOUTHINK** (A. Jordsjo) - a post-race veterinary examination revealed a small skin laceration to the medial heel on the near foreleg.

**MASKING** (R. Hurdle) – rider reminded of his obligations to ride his mounts out to the finish.

**ROD'S OPINION** (J. Potter) – raced in restricted room in the vicinity of the 1000 metres and shortly after had to be restrained after improving onto the heels of BETTERTHANYOUTHINK.

**XANDER'S PORSHA** (S. Fawke) – held up for clear running in the home straight and was unable to be fully tested at any stage over the concluding stages.
