RACE 1: GAWLER CUP OCT 29TH SABOIS MAIDEN PLATE – 1500 metres

ITZ A BULLET (J. Kah) – laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: AUSBIA ELECTRICAL SABOIS FOUR-YEAR-OLD AND OVER MAIDEN PLATE - 1100 metres

FROM FIFTH (K. Crowther) – hung out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

KRUPT LEDA (J. Kah) – jumped away awkwardly and shifted out inconveniencing AWESOME STAR, which was tightened onto PUNCHEON JOURNEY. A post-race veterinary examination revealed no visible abnormalities.

AWESOME STAR (S. Fawke) – inconvenienced at the start as KRUPT LEDA jumped away awkwardly and shifted out and PUNCHEON JOURNEY jumped away awkwardly and shifted in.

HAYAKU MISS – late scratching at 10.15 am as in the trainers' opinion there was no suitable replacement senior rider.

INWARD BOUND (NZ) (C. Lindop) – hung in throughout the event.

MARG'S MINT (J. Holder) – slow to begin and failed to maintain contact with the field. Trainer, Mr K. Sweeney, was advised a warning had been placed on the mare in relation to its competitiveness. A post-race veterinary examination revealed no visible abnormalities.

MISS CUOCO (J. Bowditch) – laid in under pressure in the straight.

PUNCHEON JOURNEY (J. Toeroek) – jumped away awkwardly, shifted in and inconvenienced AWESOME STAR, which was tightened onto KRUPT LEDA.

RACE 3: SANDERS FODDER / MITAVITE SABOIS THREE-YEAR-OLD MAIDEN PLATE - 1100 metres

The start of this event was delayed approximately one minute.

MEGA FAITH (J. Bowditch) – lost its position on jumping away when tightened onto CALYPSO CLASSIC as OUR GOLDEN PATRIOT was inconvenienced and taken in. Laid in under pressure in the straight. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

ANGEL'S WISH (J. Toeroek) – difficult to load. Trainer, Mr R. Jolly, was advised a warning had been placed on the filly.

CALYPSO CLASSIC (C. Lindop) – over-raced throughout the event.

LEAD FOOT LACEY (S. Fawke) – jumped away awkwardly and shifted in onto ONLINE GIRL, which was taken in onto OUR GOLDEN PATRIOT, which was inconvenienced when tightened onto MEGA FAITH, which lost its position when tightened onto CALYPSO CLASSIC. On being correct shifted out abruptly and bumped INDIAN MO.

OUR GOLDEN PATRIOT (J. Holder) – inconvenienced on jumping away when tightened onto MEGA FAITH by ONLINE GIRL.

RUSTYDUSTYSUNSHINE (J. Potter) – inclined to lay in under pressure in the straight.

INDIAN MO (V. Wong) – fractious in the mounting yard and dislodged its rider. V. Wong was examined by the First Care Medical personnel and passed fit fulfil his remaining engagements. Trainer, Mr P. Day, was advised that a warning had been placed on the gelding in relation to its pre-race behaviour. Shortly after the start bumped with LEAD FOOT LACEY, which shifted out abruptly when being corrected. Hung in severely in the straight placing V. Wong at a disadvantage not being able to ride his mount out in his normal manner. A post-race veterinary examination revealed no visible abnormalities. Trainer, Mr P. Day, was advised that a warning had been placed on the gelding in relation to its racing manners.

ONLINE GIRL (J. Maund) – on jumping away was taken in by LEAD FOOT LACEY, which shifted in onto OUR GOLDEN PATRIOT, which was inconvenienced.

HINCHIN MISS (D. Tourneur) – raced keenly in the early and middle stages of the event.

RACE 4: BAROSSA VOLKSWAGEN FOUR-YEAR-OLD & OVER BENCHMARK 56 HANDICAP - 1100 metres

STAR PLAYER (S. Price) – acting on confirmed advice from trainer, Mr R. Balfour, that the mare was lame in the off foreleg Stewards declared STAR PLAYER a late scratching at 9.17 am.

WRITTEN ABOVE ALL (J. Kah) – Following the running of this event it was establish that WRITTEN ABOVE ALL had competed in today's event wearing blinkers which are not on its declared gear. Stewards questioned trainer, Mr J. Frew, as to how this occurred. Mr Frew advised that as this was WRITTEN ABOVE ALL's first start for his stable he was of the belief that the horse wore blinkers and therefore fitted them. Mr Frew pleaded guilty to a charge under AR140B(2) and was reprimanded. In arriving at this penalty Stewards took into account that the gear discrepancy was not picked up by the Deputy Steward.

AVEE DEBEE (K. Bishop) – trainer, Mr A. Justice, was advised that a warning had been placed on the mare in relation to its pre-race manners.

STAGHORN (J. Bowditch) – had difficulty obtaining clear ground from the entrance to the straight until inside the 100 metres. A post-race veterinary examination revealed no visible abnormalities.

REALLY EDGY (S. Fawke) – underwent a pre-race veterinary examination on arrival at the barriers and passed fit to start. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: HOLDFAST INSURANCE BROKERS BENCHMARK 60 HANDICAP - 1200 metres

PLANET VOYAGE (A. Doyle) – shortly after the start shifted in onto SILICONNI, which was inconvenienced when tightened onto SWEET VARDEN, which lost its position. Rider severely reprimanded and advised to take greater care in future.

CYCLONE THOMAS (Jemma Frew) – shifted out at the entrance to the straight and contacted SILICONNI, which was taken wider on the track.

LET'S TANGO (A. Jordsjo) – inclined to lay out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

SILICONNI (D. Caboche) – inconvenienced shortly after the start when tightened onto SWEET VARDEN as PLANET VOYAGE shifted in. Taken wider on the track at the entrance to the straight as CYCLONE THOMAS shifted out. Rider reported that in his opinion the gelding raced flat. A post-race veterinary examination revealed the gelding to be lame in both forelegs. Trainer, Mr G. Searle, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

SWEET VARDEN (K. Crowther) – lost its position shortly after the start when SILICONNI was inconvenienced and taken in by PLANET VOYAGE.

MIKAELA (E. Finnegan) – late scratching at 11.35 am as no apprentice rider was available.

RACE 6: COOPERS PREMIUM LAGER SABOIS & BENCHMARK 70 HANDICAP - 2100 metres

The start of this event was delayed approximately one minute.

OUR BOY NICHOLAS (A. Doyle) – rider reported that in his opinion the gelding didn't appreciate the firm track conditions. A post-race veterinary examination revealed no visible abnormalities.

CELTIC PRINCE (NZ) (C. Lindop) –jumped away awkwardly.

FLYING TORMENTA (R. Vigar) – slow to begin. In the vicinity of the 150 metres was disappointed for a run between ROBOCOP and PRESUMPTION, and was obliged to shift out to obtain clear ground.

ROBOCOP (J. Potter) – jumped away awkwardly and shifted out.

KAZOOM (NZ) (J. Toeroek) – raced keenly during the event. Rider reported the gelding hung out throughout the event.

PRESUMPTION (S. Fawke) – rider reported that the gelding travelled well during the event; however, failed to let down when asked for an effort and was disappointing in the finish. A post-race veterinary examination revealed no visible abnormalities.

AMICONI ORIGINALE (R. Clark) – underwent a pre-race veterinary examination on arrival at the barriers and found to be lame in the near foreleg. Acting on this advice Stewards withdrew AMICONI ORIGINALE at 3.40 pm. Trainer, Mr R. Campbell, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

RACE 7: GOLDIN FARMS BENCHMARK 64 HANDICAP - 1500 metres

AVOID THE MISSUS (J. Kah) – late scratching at 3.49 pm due to the track upgrade.

HIDDEN FORTUNE (J. Toeroek) – late scratching at 3.23 pm due to the track upgrade.

L'AMARYBELLE (D. Tourneur) – a post-race veterinary examination revealed no visible abnormalities.

MORE THAN A ROSE (V. Wong) – slow to begin. Held up for a short distance rounding the home turn and shortly after entering the straight was obliged to shift out to obtain clear running. Laid in under pressure in the straight.
