RACE 1: SOUTH EAST MARQUEES / SABOIS MAIDEN PLATE - 900 metres

CANNY MOVE (D. Tourneur) - jumped away awkwardly and shifted in bumping YANKEE BEL.

REBEL ROUSER (J. Potter) – inconvenienced on jumping away and taken wider when JUST FOXING jumped away awkwardly and shifted out.

YANKEE BEL (J. Huxtable) – bumped on jumping away when CANNY MOVE jumped away awkwardly and shifted in. Performed below expectations. A post-race veterinary examination revealed the gelding to be shin sore in both front legs. Trainer, Mr J. McLean, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

JUST FOXING (D. Caboche) – jumped away awkwardly and shifted out inconveniencing REBEL ROUSER, which was taken wider. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: OPEN2VIEW SOUTH EAST / SABOIS MAIDEN PLATE - 1550 metres

CADWIL KID (A. Doyle) – bumped on jumping away and was slow into stride when SHOULD HAVE I jumped away awkwardly and shifted in.

RAKNIKAR (R. Hurdle) – laid out under pressure in the straight.

SHOULD HAVE I (S. Fawke) – S. Fawke was dislodged in the mounting enclosure prior to the event. S. Fawke was examined by the First Care Medical personnel and was passed fit to fulfil his remaining engagements. Jumped away awkwardly and shifted in bumping CADWIIL KID.

RACE 2: OPEN2VIEW SOUTH EAST / SABOIS MAIDEN PLATE - 1550 metres (cont'd)

KASMARLAINE (D. Tourneur) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

RACE 3: DISTRICT COUNCIL OF GRANT / SABOIS MAIDEN PLATE - 1300 metres

BEAU BUMBLE (D. Tourneur) – inconvenienced at the start when TOOLONG ROAD jumped away awkwardly and shifted out and BRAEVIEW BLAZE jumped away awkwardly and shifted in. Approaching the 50 metres shifted out to improve around heels to obtain clear running.

DOUGIE BOUNCE (S. Fawke) – slow to begin. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

NOBLE ROCKS (C. Puls) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

TOOLONG ROAD (D. Caboche) – jumped away awkwardly and shifted out inconveniencing BEAU BUMBLE.

BRAEVIEW BLAZE (J. Huxtable) – jumped away awkwardly and shifted in inconveniencing BEAU BUMBLE.

LOTALUCK (K. Walters) – rider explained that after beginning well and having the addition of blinkers and a nose roll on she elected to ride her mount forward as it was their intention to do so at its last start at Casterton on the 29 May.

RACE 4: BUDGET RENTAL CARS CLASS TWO HANDICAP - 1200 metres

BRYAN (J. Huxtable) – rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded.

RACE 5: BAXTER HIRE BENCHMARK 64 HANDICAP - 1550 metres

CHENERS (J. Huxtable) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

CENTENARY SHOT (A. Jordsjo) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

UNICAJA (NZ) (K. Walters) – raced keenly in the early and middle stages of the event. In the vicinity of the 400 metres shifted out and around heels to obtain clear running.

RACE 6: CARLTON DRAUGHT BENCHMARK 64 HANDICAP - 2050 metres

RACE 7: SCOTT GROUP OF COMPANIES BENCHMARK 80 HANDICAP - 1300 metres

BIANMAGIC (V. Wong) – jumped away awkwardly and shifted out bumping KNIGHTOFTHEREALM.

HASTA LA THOMAS (H. McKechnie) – raced keenly in the early and middle stages.

KNIGHTOFTHEREALM (J. Huxtable) – bumped on jumping away and was slow into stride when BIANMAGIC jumped away awkwardly and shifted out.

RACE 8: DO IT YOURSELF FENCING BENCHMARK 56 HANDICAP - 1400 metres

DE TWIGSTAR (A. Jordsjo) – rider explained that the mare felt awkward in its action over the concluding stages. A post-race veterinary examination revealed no visible abnormalities.

RESETTHEODDS (J. Huxtable) – rider explained that in his opinion the mare did not handle today's track conditions. Performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

BASSONS (J. Lorensini) – performed below expectations. A post-race veterinary examination revealed no visible abnormalities.

SPRAY TAN (A. Doyle) – slow to begin.
