Report on Race Meeting held at Gawler Racecourse

RACE 1: THETERRACEFUNCTIONCENTRE.COM.AU BENCHMARK 60 HANDICAP – 2100 metres

HENRY THE DOLPHIN (J. Potter) – a post-race veterinary examination revealed no visible abnormalities.

HIPPOGRIFF (R. Sakai) – raced keenly in the early and middle stages of the event. Lost its near fore plate during the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: SANDERS FODDER / MITAVITE CLASS ONE HANDICAP– 1400 metres

The start of this event was delayed approximately three minutes.

DATURA (J. Kah) – approaching the 1000 metres lost its position when it had to be steadied to avoid the heels of TRAVEL PLAN, which had been taken in. Rider reported that the gelding had not travelled throughout the event. A post-race veterinary examination revealed no visible abnormalities.

TIME ROGUE (P. Gatt) – approaching the 1000 metres shifted in when insufficiently clear of TRAVEL PLAN, which lost its position when forced to take hold. In taking hold TRAVEL PLAN was taken into the running line of DATURA, which was forced to steady and lose its position. Rider pleaded guilty to a charge of careless riding under AR137(a) and was suspended from riding in races for a period to commence midnight Monday, 12 March 2018 and to conclude midnight Sunday, 18 March 2018, a period of three meetings.

TRAVEL PLAN (K. Crowther) – had to take hold and lost its position approaching the 1000 metres when TIME ROGUE shifted in.

DUPORTRON (S. Cahill) – rider reported that the gelding was reluctant to stretch out throughout the event. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: SANDERS FODDER / MITAVITE CLASS ONE HANDICAP– 1400 metres (cont'd)

RED SCIMITAR (J. Toeroek) – attempted to buck for a short distance shortly after the start. Trainer, Mr R. Balfour, was advised that the gelding would be required to complete an Official Barrier Trial to the satisfaction of the Stewards prior to a future race.

ARCHWAY TO HEAVEN (D. Tourneur) – fractious in the barrier after being loaded dislodging its rider. D. Tourneur was examined by the First Care Medical personnel and pass fit to fulfil his engagement. Trainer, Mr S. Whittle, was advised that a warning had been placed on the gelding in relation to its barrier manners. Lost its near fore plate during the event.

RACE 3: GOLDIN FARMS CLASS TWO HANDICAP - 1100 metres

FAMILJA (E. Finnegan) – a post-race veterinary examination revealed no visible abnormalities.

JUST LIKE HEAVEN (J. Holder) – laid in throughout the event and in the vicinity of the 800 metres had to be eased momentarily when BAJ shifted in. A post-race veterinary examination revealed no visible abnormalities.

ASTIR (J. Toeroek) – jumped away awkwardly.

BAJ (J. Potter) – shifted in onto JUST LIKE HEAVEN in the vicinity of the 800 metres. Rider reminded of his obligations when shifting ground.

SECOND BASE (D. McWhinney) – a post-race veterinary examination revealed no visible abnormalities.

RACE 4: GAWLER ROTARY CLUB / SABOIS MAIDEN PLATE - 1500 metres

DANOXIE (J. Kah) – a post-race veterinary examination revealed no visible abnormalities.

UNFLYNNCHING (J. Holder) – a post-race veterinary examination revealed no visible abnormalities.

VALAROMA (S. Fawke) – slow to begin.

FEARLESS FIGHTER (C. Lindop) – raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed a lower than expected heart rate.

RACE 5: CAESARS PALACE CHICKEN & SEAFOOD / SABOIS MAIDEN PLATE - 1200 metres

The start of this event was delayed approximately two minutes owing to the tongue tie having to be replaced on KARMIDALA.

DREAMLAND (P. Gatt) – a post-race veterinary examination revealed no visible abnormalities.

KARMIDALA (J. Kah) – slow to begin. Obligated to alter course in the vicinity of the 200 metres when EXALTED JENNI shifted out.

MANCHURIAN (B. Paterson) – a post-race veterinary examination revealed a speedy cut to the near side hock.

MIGHTY MICK (R. Hurdle) – slow to begin. A post-race veterinary examination revealed no visible abnormalities.

OUT OF KILTER (J. Toeroek) – slow to begin.

EXALTED JENNI (K. Crowther) – shifted out under riding from the entrance to the straight and in the vicinity of the 200 metres shifted out onto KARMIDALA, which was obliged to alter course. Rider severely reprimanded. Continued to shift out inconveniencing GO TO GATE approaching the finish when taking that filly wider.

RACE 5: CAESARS PALACE CHICKEN & SEAFOOD / SABOIS MAIDEN PLATE - 1200 metres
(cont'd)

MISS EBONY ROSE (J. Potter) – raced keenly in the early and middle stages of the event.

GO TO GATE (E. Finnegan) – inconvenienced approaching the finish when taken wider by EXALTED JENNI. A post-race veterinary examination revealed no visible abnormalities.

YOSHIKO (A. Chan) – in the vicinity of the 100 metres improved onto the heels of HEROES QUEST, which had commenced to give ground, and was obliged to alter course.

Correct weight for this event was delayed to allow L. Kennewell, trainer of fourth placegetter OUT OF KILTER, to view the Official Photo Image for third. After doing so Mr Kennewell put a submission to Stewards that in his opinion the judge had made an error and that his horse should be placed third, or at least be declared as dead-heating for third with KARMIDALA. After considering a submission from Mr R. Balfour, trainer of KARMIDALA, viewing the official photo image, and hearing evidence from the Judge and Assistant Judge, Stewards acting under AR156(3) determined that the Judge had not made a mistake and declared correct weight on the numbers originally determined by the Judge.

RACE 6: HOLDFAST INSURANCE BENCHMARK 60 HANDICAP - 1500 metres

The start of this event was delayed approximately two minutes due to the delay from the viewing the official image in the previous event.

LE DEZALEY (S. Fawke) – slow to begin.

HIDATSA (B. Paterson) – a post-race veterinary examination revealed the mare to be lame in the off hind leg. Trainer, Mr R. Balfour, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

DAPPER AFTER DARK (J. Toeroek) – a post-race veterinary examination revealed no visible abnormalities.

BALLISTIC MISSILE (E. Boyd) – jumped away awkwardly. Had difficulty obtaining clear ground from the vicinity of the 600 metres until near the 300 metres.

RACE 7: COOPERS SESSION ALE CLASS TWO HANDICAP - 1200 metres

LUVULONGTIME (S. Cahill) – rolled out in the vicinity of the 700 metres onto VOD.

ARCTIC BLAZE (D. Tootell) – inconvenienced in the vicinity of the 700 metres when contacted by VOD.

MY THREE SONS (D. Tourneur) – a post-race veterinary examination revealed no visible abnormalities.

VOD (J. Toeroek) – jumped away awkwardly. Inconvenienced when taken out by LUVULONGTIME in the vicinity of the 700 metres contacting ARCTIC BLAZE. Laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

DELLACQUA (K. Crowther) – had difficulty obtaining clear ground from the vicinity of the 600 metres until the entrance of the straight.

RACE 8: GAWLER SOUTH BAKERY BENCHMARK 56 HANDICAP - 1700 metres

GRAND ARMADA (J. Holder) – had difficulty obtaining clear ground from the vicinity of the 300 metres until near the 100 metres.

GRACEFUL WOLF (A. Chan) – slow to begin.

KOSMOS TERCEDES (C. Lindop) – approaching the 200 metres rider had her whip knocked from her hand by the whip of S. Fawke.

RACE 8: GAWLER SOUTH BAKERY BENCHMARK 56 HANDICAP - 1700 metres (cont'd)

HIGH TEC (NZ) (K. Bishop) – a post-race veterinary examination revealed the gelding to have atrial fibrillation. Trainer, Ms N. Bruggemann, was advised the results of an ECG are to be forwarded to the TRSA Veterinary Surgeon and a Veterinary Certificate of Fitness were required prior to the gelding performing satisfactorily in an Official Barrier Trial.

SWEET SCHILLY (J. Toeroek) – a post-race veterinary examination revealed the mare to be lame in the near foreleg. Trainer, Mr R. Balfour, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race.

DYLAN JACK (K. Crowther) – inconvenienced in the vicinity of the 100 metres when racing in restricted room between GRAND ARMADA and WALKABOUTCREEK.
