#### RACE 1: KUTZ ON KENTISH / SABOIS MAIDEN PLATE - 1100 metres

**BEAU BUMBLE** (R. Clark) – laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**LIMELIGHT** (S. Fawke) – when questioned regarding the performance of the gelding rider stated that he was instructed to lead in today's event but after beginning well the gelding failed to muster any early gate speed. He added that his mount was under hard riding throughout today's event and in his opinion LIMELIGHT would be better suited over greater distance. A post-race veterinary examination revealed no visible abnormalities.

**OLATUNJI** (J. Maund) – underwent a pre-race veterinary examination as it had not raced in over twelve months and was passed fit to start.

CLASSY BREW (D. Tourneur) - laid in under pressure in the straight.

**SHAKKURI** (C. Puls) – a post-race veterinary examination revealed no visible abnormalities.

**TIZA** (K. Bishop) – laid in under pressure in the straight.

# RACE 2: GALPINS ACCOUNTING AUDITORS AND BUSINESS CONSULTANTS / SABOIS MAIDEN PLATE – 1100 metres

**DOUBLE BURNER** (C. Puls) – underwent a pre-race veterinary examination as it had not raced in over twelve months and was passed fit to start. A post-race veterinary examination revealed no visible abnormalities.

**HARDWICKE BAY** (R. Clark) – underwent a pre-race veterinary examination as it had not raced in over twelve months and was passed fit to start. Over-raced in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**MISTA KNOWITALL** (J. Lorensini) – underwent a pre-race veterinary examination after being kicked behind the barriers and was passed fit to start.

# RACE 2: GALPINS ACCOUNTING AUDITORS AND BUSINESS CONSULTANTS / SABOIS MAIDEN PLATE – 1100 metres (cont'd)

**BETTER BROTHER** (E. Boyd) – slow to begin. Rider reported that her mount raced greenly throughout the event. In the vicinity of the 100 metres had to be restrained after improving onto the heels of DOUBLE BURNER and as a result shifted out abruptly.

**NATLIRUTH** (D. Caboche) – a post-race veterinary examination revealed no visible abnormalities.

BEL MOSHE (D. Tourneur) – laid out rounding the home turn and under pressure in the straight.

## RACE 3: KA MCMILLAN DESIGN & DRAFTING / SABOIS MAIDEN PLATE - 1400 metres

**BIANZEDA** (D. Tourneur) – laid out rounding the home turn and in the vicinity of the 300 metres had to be restrained to avoid the heels of THE ULSTERMAN, which laid in.

**NOBLE ROCKS** (S. Cahill) – over-raced in the early stages of the event.

**THE ULSTERMAN** (J. Lorensini) – laid in rounding the home turn. In the vicinity of the 300 metres laid in hampering BIANZEDA. Rider reminded of his obligations to keep his mounts straight when they commence to shift ground. Laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**AZ LUCKY (NZ)** (J. Potter) – underwent a pre-race veterinary examination as it had not raced in over twelve months and was passed fit to start. A post-race veterinary examination revealed no visible abnormalities.

**MISS ACHEEVA** (C. Puls) – trainer, Mr S. McIntyre, was advised that the mare is required to trial competitively to the satisfaction of Stewards prior to a future race start after being beaten by 34 lengths.

**BEL ROBBIE** (D. Bates) – stood flat-footed as the start was effected and was slow to begin. Trainer, Mr D. Bowman, was advised that the filly would be required to trial to the satisfaction of Stewards prior to a future race start. A post-race veterinary examination revealed no visible abnormalities.

**SHELLEY BANK** (A. Chan) – stood flat-footed as the start was effected and was slow to begin. Trainer, Ms A. Noonan, was advised that the mare would be required to jump satisfactorily in an Official Barrier Trial or Approval to Race Jump-out prior to a future race start.

## RACE 4: GRAND HOTEL BENCHMARK 56 HANDICAP - 1300 metres

**EMIL** (S. Cahill) – in the vicinity of the 100 metres was held up for clear running and was unable to improve into a narrow run between TOUGH VIC and MISTY HALO, and ran to the line without being fully tested.

**NORTHERN COMMAND** (C. Puls) – underwent a pre-race veterinary examination as it had not raced in over twelve months and was passed fit to start. A post-race veterinary examination revealed no visible abnormalities.

## RACE 5: DI GIORGIO FAMILY WINES BENCHMARK 64 HANDICAP - 1700 metres

ATHOS (S. Cahill) – slow to begin.

**SPY DECODER (NZ)** (K. Crowther) – in the vicinity of the 300 metres had to be restrained to avoid the heels of DYADAMO, which laid out, and MENEGATTI, which shifted in.

**CARAK** (E. Finnegan) – slow to begin.

**MENEGATTI** (S. Vella) – in the vicinity of the 300 metres rolled in marginally hampering SPY DECODER (NZ).

## RACE 5: DI GIORGIO FAMILY WINES BENCHMARK 64 HANDICAP - 1700 metres (cont'd)

**HIGH ROLLA** (R. Clark) – when questioned regarding the performance of the gelding rider stated that it was her intention to be on the pace today but after beginning only fairly the gelding was unable to muster early gate speed and settled further back in the field than anticipated.

**SAN GREGORIO** (D. Caboche) – rider reported that his mount laid out rounding the home turn and in the vicinity of the 800 metres reported that his saddle shifted sideways which placed him at a disadvantage for the remainder of the event.

### RACE 6: SPORTMAN'S HOTEL MILLICENT BM 72 HANDICAP - 1400 metres

**HADDA COUPLE** (A. Chan) – in the vicinity of the 1200 metres shifted in when insufficiently clear of SCROLL. Rider severely reprimanded. Hung out throughout the event.

**CONSTANT RETURN** (R. Clark) – stood flat-footed as the start was effected and was slow to begin. Trainer, Mr M. J. O'Connor, was advised that the mare would be required to jump with the field in either an Official Barrier Trial or Approval to Race jump-out prior to a future race start. A post-race veterinary examination revealed no visible abnormalities.

**FORTIFY** (K. Crowther) – stood flat-footed as the start was effected. Trainer, Mr G. Young, was advised that a warning had been placed on the gelding.

**SCROLL** (J. Potter) – in the vicinity of the 1200 metres had to be restrained to avoid the heels of HADDA COUPLE, which shifted in when insufficiently clear.

#### RACE 7: JOHN CHAY & CO LIVESTOCK BM 80 HANDICAP - 1100 metres

**ELZETTE** (E. Finnegan) – in the vicinity of the 300 metres attempted to savage ANOTHER DIAMOND on two occasions. Trainer, Mr R. Bruhn, was advised that the mare would be required to trial to the satisfaction of Stewards prior to resuming.

**ANOTHER DIAMOND** (S. Vella) – a post-race veterinary examination revealed no visible abnormalities.

### RACE 8: 3MP STEEL ROOFING & FENCING SUPPLIES MILLICENT CUP - 2100 metres

**SURVIVED (NZ)** (D. Bates) – over-raced in the early and middle stages of the event. Rider pleaded guilty to a charge under AR137A(5)(a)(ii) in that he used his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

**DANCE OF HEROES (GB)** (K. Crowther) – in the vicinity of the 1400 metres had to be restrained after improving onto the heels of HASTA LA THOMAS. Over-raced in the early and middle stages of the event.

**MR LEBROCK** (J. Lorensini) – over-raced in the early and middle stages of the event. In the vicinity of the 1500 metres shifted in making contact with the running rail.

**CHESTNUT CHARLIE** (R. Clark) – over-raced in the early and middle stages of the event. Laid in under pressure in the straight.

**UNREALISTIC** (T. Nugent) – raced greenly when placed under pressure in the straight.

**YET ANOTHER TIME** (E. Boyd) – a post-race veterinary examination revealed no visible abnormalities.

### RACE 9: COOPERS SESSION ALE BENCHMARK 60 HANDICAP - 1100 metres

**CRIES OF JOY** (K. Crowther) – slow to begin.

## RACE 9: COOPERS SESSION ALE BENCHMARK 60 HANDICAP - 1100 metres (cont'd)

**MISS COOLANGATTA** (C. Puls) – underwent a pre-race veterinary examination as it had not raced in over twelve months and was passed fit to start. Rider reported her mounted slipped in the going in the vicinity of the 400 metres. A post-race veterinary examination revealed no visible abnormalities.

**SILENT ICE** (A. Chan) – began awkwardly.

SHE'S GOT MAGIC (T. Nugent) – laid out when placed under pressure in the straight.
