STIPENDIARY STEWARDS' REPORT

Report on Race Meeting held at Port Lincoln Racecourse  
by the Port Lincoln Racing Club on Friday, 16 November 2018

**RACE 1: LINCOLN SAND SUPPLIES - NT & DA DICKSON / SABOIS MAIDEN PLATE - 1390 metres**

**DESERT MINTY** (B. Sweeney) - laid in under pressure in the straight.

**IT'S MYSTIC** (S. Fawke) - jumped away awkwardly and shortly after dipped. Rider reported the gelding was disappointing in its efforts to the finish. A post-race veterinary examination revealed no visible abnormalities.

**WICKED KID** (K. Lau) - shifted in abruptly in the vicinity of the 200 metres.

**VACANCE** (K. Crowther) - over-raced in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

**CLAREFELILLI** (G. Lo) - laid in under pressure in the straight.

**RACE 2: EYRE PENINSULA TRIBUNE / SABOIS MAIDEN PLATE - 1000 metres**

**MR TRUMAN** (G. Goomany) - inclined to lay in under pressure in the straight.

**ACE DE JOUR** (R. Hurdle) - rider reported the mare raced dour during the event and in his opinion, the mare has come to the end of its preparation. A post-race veterinary examination revealed no visible abnormalities.

**CRY OUT LOUD** (G. Lo) - in the vicinity of the 200 metres was crowded for room when tightened onto NOUVELLOKOVA as **STORM VOYAGER**, which laid in, shifted in abruptly.

**JAAMINT** (A. Chan) - a late scratching at 3.02 pm by order of Stewards as it refused to proceed to the start. Trainer Ms J Branford was advised the filly is now required to complete an Official Barrier Trial to the satisfaction of the Stewards prior to accepting for a future race.

**STORM VOYAGER** (K. Crowther) - laid in under pressure in the straight. In the vicinity of the 200 metres shifted in abruptly onto **CRY OUT LOUD**, which was crowded and thereafter raced greenly until the finish.

**RACE 3: MAGIC FM 89.9 BENCHMARK 56 HANDICAP - 1000 metres**

**NITRO MAGIC** (G. Goomany) - after being loaded in its barrier was struck on a number of occasions on the legs by **ROSIE LOUISE**, which kicked out after becoming fractious in its barrier and being cast. Underwent a pre-race veterinary examination and ruled unfit to race. Acting on this advice Stewards withdrew **NITRO MAGIC** at 3.46 pm.

**RACE 3: MAGIC FM 89.9 BENCHMARK 56 HANDICAP - 1000 metres (Cont'd)**

**ROSIE LOUISE** (D. Caboche) - after being loaded in its barrier stall became very fractious, dislodged D. Caboche and became cast. Underwent a pre-race veterinary examination and ruled unfit to race. Acting on this advice Stewards withdrew ROSIE LOUISE at 3.46 pm. Trainer Miss J. Stoetzer was advised the mare is now required to complete an Official Barrier Trial prior to accepting for a future race. D. Caboche was examined by the First Care Medical Personnel and passed fit to fulfil his remaining engagements.

**NIPPY LIPPY** (K. Crowther) - in the vicinity of the 150 metres rolled in and momentarily inconvenienced OBLIQUE LINE.

**DUANETTE** (J. Toeroek) - rider reported the mare did not travel during the event and when placed under pressure in the vicinity of the 600 metres, failed to respond to his riding and for this reason he elected not to ride DUANETTE out in its normal manner. A post-race veterinary examination revealed no visible abnormalities.

**OBLIQUE LINE** (S. Logan) - held up at the entrance to the straight until in the vicinity of the 200 metres when awkwardly placed on the heels of NIPPY LIPPY, was obliged to be restrained and shifted in to obtain clear running. In the vicinity of the 150 metres was momentarily inconvenienced as NIPPY LIPPY rolled in.

**LASANTA** (K. Lau) - over-raced in the early and middle stages of the event.

**TORNADO BLUE** (G. Lo) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 4: BOSTON BAY WINES CLASS ONE HANDICAP - 1210 metres**

**HARDASHIAN** (B. Sweeney) - held up for a short distance in the vicinity of the 400 metres. In the vicinity of the 150 metres was disappointed when attempting a run between SCOTTISH THREAD and SHEZA PROPHET at the same time as MACKIE. Thereafter had difficulty obtaining a clear run until the finish.

**MACKIE** (J. Toeroek) - laid in throughout the event. A post-race veterinary examination revealed a bruised membrane at the right corner of the mouth.

**SHEZA PROPHET** (A. Chan) - jumped away awkwardly, shifted in and bumped WINE DANCE.

**WHITWAY** (K. Crowther) - in the vicinity of the 200 metres was momentarily inconvenienced as WINE DANCE rolled out.

**WINE DANCE** (K. Bishop) - on jumping away bumped with SHEZA PROPHET. In the vicinity of the 200 metres rolled out momentarily inconveniencing WHITWAY. A post-race veterinary examination revealed no visible abnormalities.

**BURGUNDEE MISS** (G. Lo) - on jumping away was bumped and taken in by HOST ESPRIT.

**SCOTTISH THREAD** (G. Goomany) - jumped away awkwardly.

**HOST ESPRIT** (S. Fawke) - underwent a pre-race veterinary examination as it had not raced for over two years and passed fit to race. Jumped away awkwardly, shifted in and bumped BURGUNDEE MISS, which was taken in.

**RACE 5: PORT LINCOLN CARPETS & FLOORING DIRECT BENCHMARK 60 HANDICAP - 1210 metres**

**INVINCIBLE ME** (D. Caboche) - held up for clear running from inside the 400 metres until in the vicinity of the 200 metres. Shortly thereafter shifted out onto GET PRONTO, which was obliged to be steadied and shifted in to obtain clear running at the same time as EQUIDANT rolled in.

**RACE 5: PORT LINCOLN CARPETS & FLOORING DIRECT BENCHMARK 60 HANDICAP**  
**- 1210 metres (Cont'd)**

Rider severely reprimanded under AR137(a) and advised to take greater care when shifting ground. In the vicinity of the 150 metres continued to shift out onto EQUIDANT, which was obliged to be eased when tightened onto TASSIE. Rider was reprimanded under AR137(a) for careless riding and advised to take greater care in future. Inside the 100 metres shifted out onto TASSIE, which was momentarily inconvenienced. Rider was reminded of his obligation and advised to take greater care.

**ARTFUL MONTY** (A. Chan) - in the vicinity of the 400 metres became awkwardly placed on the heels of MAGNUS MAGIC for a short distance.

**TASSIE** (B. Sweeney) - jumped away awkwardly, shifted in and bumped GET PRONTO. In the vicinity of the 800 metres rolled in marginally onto PURRFECT KISSES. Inside the 100 metres was inconvenienced as INVINCIBLE ME shifted out.

**PURRFECT KISSES** (J. Toeroek) - in the vicinity of the 800 metres raced in restricted room for a number of strides between INVINCIBLE ME and TASSIE, which rolled in marginally.

**GET PRONTO** (S. Logan) - lost its position on jumping away when TASSIE jumped away awkwardly shifted in and bumped GET PRONTO. In the vicinity of the 200 metres was obliged to be steadied when INVINCIBLE ME shifted out and EQUIDANT rolled in. A post-race veterinary examination revealed the gelding to be lame in the off foreleg. First aid administered. Trainer Mr J. Dunn was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**EQUIDANT** (K. Crowther) - in the vicinity of the 200 metres rolled in. Inside the 200 metres was obliged to be eased when tightened onto TASSIE as INVINCIBLE ME shifted out.

**HIGHLAND HENRY** (K. Lau) - raced keenly in the early and middle stages of the event.

**RACE 6: BUTTERFIELD FARM DIRECT HORSE FEEDS BENCHMARK 64 HANDICAP**  
**- 1390 metres**

The start of this event was delayed approximately one minute.

**EMOJI** (K. Bishop) - proved difficult to load. Trainer Ms J. Branford was advised a warning had been placed on the gelding. Jumped away awkwardly and dipped.

**BRAMFIELD** (K. Crowther) - inside the 1000 metres got its head up when being restrained when awkwardly placed on the heels of HETUKA ZARSHO. Inclined to lay in under pressure in the straight.

**DELAGO EDITION** (A. Chan) - weakened from in the vicinity of the 500 metres. Rider explained the gelding began well and his instructions were to obtain cover however, after beginning well and the gelding racing keenly, he was unable to obtain cover and forced to race wide without cover for the majority of the event. He added in the vicinity of the 500 metres, when asked for an effort, failed to respond to his riding and was disappointing in its efforts to the finish. A post-race veterinary examination revealed minor skin abrasions to the near hind pastern.

**SYNERGY** (S. Fawke) - slow to begin. Trainer Mr T. Haddy was advised a warning had been placed on the mare.

**RACE 7: JONES ELECTRICAL/WBS PUMPS BENCHMARK 64 HANDICAP - 1750 metres**

**SAVANERO (NZ)** (S. Price) - rider reported the gelding did not feel comfortable in its action on pulling up. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. First aid administered. Trainer Mr W. Bencic was advised a Veterinary Certificate of Fitness would be required prior to presenting the horse for a future trial or race.

**RACE 7: JONES ELECTRICAL/WBS PUMPS BENCHMARK 64 HANDICAP - 1750 metres (Con't)**

**UMALUKA** (G. Lo) - rounding the home turn was obliged to be steadied when racing in restricted room between HEZA GUNN and VINTAGE GROVE.

**ONWARD** (B. Sweeney) - in the vicinity of the 1300 metres shifted in onto KIRCHNER, which was inclined to lay out and was obliged to be steadied. Rider reprimanded and advised to take greater care in future.

**LOCKS WELL** (J. Toeroek) - a post-race veterinary examination revealed no visible abnormalities.

**PENULTIMATE STAR** (D. Caboche) - raced in restricted room from in the vicinity of the 300 metres until in the vicinity of the 200 metres when racing between HEZA GUNN and BEL STREAK.

**TILBURY** (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

**KIRCHNER** (K. Bishop) - in the vicinity of the 1300 metres rolled out marginally at the same time as ONWARD shifted in and was obliged to be steadied.

**RACE 8: RDAWEP BENCHMARK 80 HANDICAP - 1210 metres**

**HANK'S NEPHEW** (R. Hurdle) - had difficulty obtaining clear ground from approaching the 200 metres until approaching the 100 metres and thereafter was disappointed when attempting a run between KINGSON, which rolled in marginally and DEBEERSONUS. Approaching the finish raced in restricted room between KINGSON and DEBEERSONUS.

**TOLSTOY** (D. Caboche) - laid in under pressure in the straight.

**STONECAST** (K. Bishop) - inside the 1000 metres over-raced and got its head up when being restrained and shifted out onto BEAU'S MY BOY, which was obliged to be eased.

**VICTOR VICTOR** (J. Toeroek) - rider could offer no explanation in relation to the gelding's performance. A post-race veterinary examination revealed no visible abnormalities.

**BEAU'S MY BOY** (E. Boyd) - approaching the 1000 metres raced keenly and dipped. In the vicinity of the 1000 metres was obliged to be eased as STONECAST, which was over-racing shifted out.

Correct weight for this event was delayed to allow R. Hurdle (HANK'S NEPHEW) placed fifth to view the vision in the straight before deciding not to lodge an objection.
