## RACE 1: GM HARFIELD MEMORIAL / SABOIS MAIDEN PLATE - 1000 metres

The start of this event was delayed approximately five minutes owing to First Care Medical Personnel attending to a stable hand.

**COMPLETE TREASURE** (K. Bishop) - in the vicinity of the 900 metres was obliged to be steadied to avoid the heels of LEDAYL KISS, which shifted in abruptly despite the efforts of its rider.

**GRINZINGER CHARGER (NZ)** (C. Jones) - in the vicinity of the 950 metres became awkward in its stride and attempted to jump a section of clover on the track.

**LEDAYL KISS** (S. Fawke) - over-raced in the early and middle stage of the event. In the vicinity of the 900 metres got its head up and shifted in abruptly despite the efforts of its rider, hampering COMPLETE TREASURE.

### RACE 2: LANDMARK BENCHMARK 72 HANDICAP - 1430 metres

**FLOW METER** (S. Fawke) - held up for clear running from the vicinity of the 400 metres until entering the straight. Laid in under pressure in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(i) in that he used his whip in a forehand manner in consecutive strides prior to the 100 metres and fined \$100. Rider also pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

BULLET KID (K. Bishop) - over-raced throughout the event. Laid in under pressure in the straight.

## RACE 3: COMBINED LIVESTOCK CARRIERS / SABOIS MAIDEN PLATE - 1430 metres

**SHARKSKI** (J. Potter) - inside the 1000 metres had to be restrained after improving onto the heels of PARIS ON FIRE after racing ungenerously.

VLAMINGH (C. Jones) - a post-race veterinary examination revealed no visible abnormalities.

BRAKEFOOT BLING (M. Autier) - slow to begin.

## RACE 3: COMBINED LIVESTOCK CARRIERS / SABOIS MAIDEN PLATE - 1430 metres (Cont'd)

MISS WAZZA (J. Lorensini) - raced wide without cover throughout the event.

**GENERAL FACTOR** (S. Fawke) - Trainer Mr M. Hickmott was fined \$100 under AR65 for failing to produce the Thoroughbred Identification Card. The horse was permitted to start as it was able to be identified from records held by Stewards.

## RACE 4: ELDERS BENCHMARK 64 HANDICAP - 1000 metres

FLO JO SNIP (J. Huxtable) - shortly after jumping away shifted out hampering SHE'S ALL POWER.

**BELEAGUER** (C. Jones) - in the vicinity of the 950 metres became awkward in its stride and attempted to jump a section of the track.

**JIMASSI** (K. Bishop) - in the vicinity of the 700 meters shifted in when insufficiently clear of SHE'S ALL POWER. Rider reminded of her obligations to be clear when shifting ground in future.

DASKULYA (E. Boyd) - laid out from the vicinity of the 400 metres until entering the straight.

**SHE'S ALL POWER** (D. Tourneur) - underwent a pre-race veterinary examination as the mare had not raced for the past 12 months and passed fit to race. Hampered shortly after jumping away by FLO JO SNIP, which shifted out. Over-raced in the early and middle stages of the event. Obliged to be restrained in the vicinity of the 700 metres after JUMASSI shifted in when insufficiently clear. A post-race veterinary examination revealed no visible abnormalities.

## RACE 5: SAL BENCHMARK 64 HANDICAP - 2000 metres

**COSTA LANTE** (J. Huxtable) - laid out under pressure in the straight.

**CHALLICUM** (J. Potter) - in the vicinity of the 1400 metres had to be restrained after improving onto the heels of FOX BY ZERPRISE after the pace slackened.

HASTA LA SPEC (D. Tourneur) - laid out under pressure in the straight.

**FOX BY ZERPRISE** (J. Maund) - rider reported his mount weakened noticeably in the vicinity of the 900 metres and was disappointed in its finishing efforts. A post-race veterinary examination revealed no visible abnormalities.

### RACE 6: STHOMAS DEGARIS CLARKSIN BENCHMARK 60 HANDICAP - 1200 metres

**ACTION IN RIO (NZ)** (J. Lorensini) - in the vicinity of the 150 metres had to be restrained to avoid the heels of CAPTAIN CALIFORNIA, which was taken in by CANIDAE, which shifted in under pressure.

**CAPTAIN CALIFORNIA** (T. Farrugia) - in the vicinity of the 150 metres was taken in onto ACTION IN RIO (NZ) by CANIDAE, which shifted in when insufficiently clear. In the vicinity of the 50 metres was contacted by GRAVITY, which laid out under pressure.

**GRAVITY** (D. Tourneur) - in the vicinity of the 50 metres laid out contacting CAPTAIN CALIFORNIA.

**CANIDAE** (S. Fawke) - in the vicinity of the 150 metres shifted in taking CAPTAIN CALIFORNIA in onto ACTION IN RIO (NZ). Rider was reprimanded.

**BURST OF FAITH** (M. Autier) - rider pleaded guilty to a charge under AR132(6)(b) in that he used his whip in an action that raised his arm above shoulder height and was reprimanded.



## RACE 7: PPH&S BENCHMARK 56 HANDICAP - 1430 metres

**RED DAZZLE** (C. Lions) - raced wide without cover throughout the event.

CRYSTAL GLASS (C. Puls) - stood flat-footed as the start was affected and was slow to begin.

**COTILLION** (K. Lau) - laid out rounding the home turn from the vicinity of the 400 metres until the entrance to the straight.

**PIANISSIMO** (S. Logan) - held up for clear running from the vicinity of the 400 metres until in the vicinity of the 300 metres.

**VEIN CHOICE** (K. Bishop) - over-raced in the early and middle stages of the event. Rider stated after racing keenly in the early and middle stages, her mount began to weaken in the vicinity of the 500 metres and was disappointing in its finishing efforts.
